If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. ORDER OF PROBABLE CAUSE

THIS MATTER was heard by the Florida Elections Commission (“Commission”) at its regularly scheduled meeting held on August 20, 2025, at 1:00 p.m. via Zoom teleconferencing.

On July 18, 2025, Staff recommended to the Commission that there was probable cause to believe that the Florida Election Code was violated. The facts articulated in Staff’s Recommendation are adopted by reference and incorporated herein. Based on the Complaint, Report of Investigation, Staff’s Recommendation, and oral statements (if any) made at the probable cause hearing, the Commission finds that there is **probable cause** to charge Respondent with the following violations:

Count 1:

On September 8, 2022, Nelson Amador violated Section 106.09(1)(b), Florida Statutes, when he accepted an excessive cash contribution totaling \$114.77.

Count 2:

On September 22, 2022, Nelson Amador violated Section 106.09(1)(b), Florida Statutes, when he accepted an excessive cash contribution totaling \$40.00.

Count 3:

On September 22, 2022, Nelson Amador violated Section 106.09(1)(b), Florida Statutes, when he accepted an excessive cash contribution totaling \$83.00.

Count 4:

On September 25, 2022, Nelson Amador violated Section 106.07(5), Florida Statutes, when he certified that the campaign's 2022 G3 Report was true, correct, and complete when it was not.

Count 5:

On October 24, 2022, Nelson Amador violated Section 106.19(1)(d), Florida Statutes, when he made a prohibited cash withdrawal to himself totaling \$411.00.

Count 6:

On October 24, 2022, Nelson Amador violated Section 106.19(1)(d), Florida Statutes, when he made a prohibited cash withdrawal to himself totaling \$494.00.

Count 7:

On October 28, 2022, Nelson Amador violated Section 106.07(5), Florida Statutes, when he certified that the campaign's 2022 G5 Report was true, correct, and complete when it was not.

Count 8:

On October 28, 2022, Nelson Amador violated Section 106.19(1)(c), Florida Statutes, when he falsely reported information on the campaign's 2022 G5 Report.

Count 9:

On October 31, 2022, Nelson Amador violated Section 106.19(1)(d), Florida Statutes, when he made a prohibited cash withdrawal to himself totaling \$20.00.

Count 10:

On October 31, 2022, Nelson Amador violated Section 106.19(1)(d), Florida Statutes, when he made a prohibited cash withdrawal to himself totaling \$202.00.

Count 11:

On October 31, 2022, Nelson Amador violated Section 106.19(1)(d), Florida Statutes, when he made a prohibited cash withdrawal to himself totaling \$500.00.

Count 12:

On November 4, 2022, Nelson Amador violated Section 106.19(1)(b), Florida Statutes, when he failed to report a contribution for \$30.00.

Count 13:

On November 5, 2022, Nelson Amador violated Section 106.19(1)(c), Florida Statutes, when he deliberately failed to disclose activity required to be reported, which consisted of one contribution, five withdrawals, and two bank fees.

Count 14:

On November 7, 2022, Nelson Amador violated Section 106.19(1)(d), Florida Statutes, when he made a prohibited cash withdrawal to himself totaling \$20.00.

Count 15:

On December 29, 2022, Nelson Amador violated Section 106.07(5), Florida Statutes, when he certified that the campaign's 2023 Termination Report was true, correct, and complete when it was not.

Count 16:

On December 29, 2022, Nelson Amador violated Section 106.19(1)(c), Florida Statutes, when he falsely reported and deliberately failed to include information on the campaign's 2023 Termination Report.

NOTICE OF RIGHT TO A HEARING

As the Respondent, you may elect to resolve this case in several ways. First, you may elect to resolve this case by consent order where you and Commission staff agree to resolve the violation(s) and agree to the amount of the fine. The consent order is then presented to the Commission for its approval. To discuss a consent order, contact the FEC attorney identified in the Order of Probable Cause.

Second, you may request an informal hearing held before the Commission, if you do not dispute any material fact in the Staff Recommendation. You have thirty (30) days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to make written or oral arguments to the Commission concerning the legal issues related to the violation(s) and the potential fine. At the request of Respondent, the Commission will consider and determine willfulness at an informal hearing. Otherwise, live witness testimony is unnecessary.

Third, you may request a formal hearing held before an administrative law judge in the Division of Administrative Hearings ("DOAH") if you dispute any material fact in the Staff Recommendation. You have thirty (30) days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to present evidence relevant to the violation(s) listed in this order, to cross-examine opposing witnesses, to impeach any witness, and to rebut the evidence presented against you.

If you do not elect to resolve the case by consent order or request a formal hearing at the DOAH or an informal hearing before the Commission within thirty (30) days of the date this Order of Probable Cause is filed with the Commission, the case will be sent to the Commission for a formal or informal hearing, depending on whether the facts are in dispute. To the Honorable Members of the Florida Elections Commission,

My name is Njällssen Amaro Lionheart, formerly known as Nelson Amador. I respectfully submit this response in my personal capacity and without legal representation to address Case No. 23-260 with clarity, respect, and conviction.

As a first-time candidate in the 2022 election cycle, I conducted my campaign with good faith, transparency, and dedication to civic service. I managed every aspect personally, without institutional backing or a professional compliance team. Like many grassroots candidates who navigate complex regulatory systems for the first time, I encountered procedural challenges, not misconduct, not concealment, and certainly not intent to violate any law.

Let me offer this in good faith:

At no point did I knowingly or intentionally violate any provision of Florida's campaign finance laws. I did not falsify, omit, or misrepresent contributions or expenditures. All actions taken during my campaign were made with a genuine intent to comply, based on my best understanding of the statutes and procedures at the time. If any inconsistencies are now perceived, they were purely administrative and reflect the challenges common to first-time, self-managed campaigns, not any effort to mislead or deceive.

This matter concerns technical filings from over three years ago. While I take compliance seriously, I no longer possess complete access to records from that period, and I am not in a position to offer detailed retroactive documentation beyond what was filed in good faith at the time. Any effort to retroactively reconstruct or speculate over old filings would be more likely to create confusion than clarity, and I will not participate in building a false narrative around innocent actions.

I respectfully request that the Commission consider these facts and decline to escalate this matter further. If administrative closure requires the submission of a voluntary remittance, I am willing to comply without admission of liability, in the interest of bringing finality to this process and preserving mutual respect between public servants.

Nothing in this response should be interpreted as an admission of fault or violation of Chapter 106, Florida Statutes. I do not accept the premise that a citizen should be penalized for navigating the political process without privilege, counsel, or a political machine. I serve my community each day as an educator, working directly with high-risk students and those assigned to behavioral reassignment institutions. My dedication to uplifting others, particularly the most

vulnerable, reflects not only my values but also my lifelong commitment to service, personal integrity, and public trust.

This is not a case of deception or abuse of the system. It is a case of a citizen stepping forward to serve and being met with retroactive scrutiny that distorts that intent.

I stand by my record, my integrity, and my right to defend both without apology.

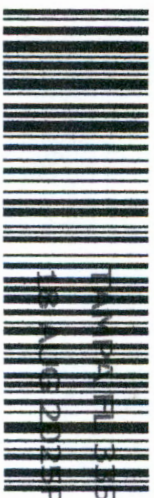

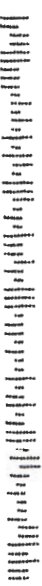

STAFF RECOMMENDATION FOLLOWING INVESTIGATION

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the referral in this case recommending that there is **probable cause** to charge Respondent with violating **Sections 106.07(5), 106.09(1)(b), 106.19(1)(b), 106.19(1)(c), and 106.19(1)(d), Florida Statutes**. Based upon a thorough review of the Report of Investigation submitted on March 28, 2024, the following facts and law support this staff recommendation:

1. On September 27, 2023, the Florida Elections Commission (“Commission”) received a referral from the Florida Division of Elections (“Complainant” or “Division”) alleging that Nelson Amador, running under the nickname of Amaro Lionheart (“Respondent”), violated Chapter 106, Florida Statutes. (Attachment A, pages 1 & 3)

2. Respondent was a candidate for State Senator, District 21, in the 2022 election. (ROI Exhibit 2, page 1; ROI Exhibit 3, pages 1-2)¹ Respondent’s Statement of Candidate form (“DS-DE 84”) was filed on March 31, 2022. (ROI Exhibit 2, page 1) Respondent was defeated in the general election held on November 8, 2022. (ROI, page 1, ¶1; Attachment B, page 2)

3. By letter dated October 31, 2023, the Executive Director notified Respondent that Commission staff would investigate the following statutory provisions:

Section 106.07(5), Florida Statutes: Respondent, a 2022 candidate for State Senator, District 21, may have certified one or more campaign treasurer’s reports were true, correct, and complete when they were not, based upon an apparent deficit balance during the 2022 G5, 2022 G6, and 2023 TR reporting periods, as alleged in the complaint.

Section 106.19(1)(b), Florida Statutes: Respondent, a 2022 candidate for State Senator, District 21, may have failed to report one or more contributions required to be reported by Chapter 106, based upon an apparent deficit balance during the 2022 G5, 2022 G6, and 2023 TR reporting periods, as alleged in the complaint.

Section 106.19(1)(c), Florida Statutes: Respondent, a 2022 candidate for State Senator, District 21, may have falsely reported

or deliberately failed to include information in one or more campaign treasurer's reports as required by Chapter 106, Florida Statutes, based upon an apparent deficit balance during the 2022 G5, 2022 G6, and 2023 TR reporting periods, as alleged in the complaint.

Section 106.19(1)(d), Florida Statutes: Respondent, a 2022 candidate for State Senator, District 21, may have made or authorized one or more expenditures prohibited by Chapter 106, Florida Statutes, based upon an apparent deficit balance during the 2022 G5, 2022 G6, and 2023 TR reporting periods, as alleged in the complaint.

Section 106.07(5), Florida Statutes: Respondent, a 2022 candidate for State Senator, District 21, may have certified the 2022 G3 campaign treasurer's report was true, correct, and complete when it was not, based on reported cash contributions in excess of the \$50 per campaign limit, as alleged in the complaint.

Section 106.09(1)(b), Florida Statutes: Respondent, a 2022 candidate for State Senator, District 21, may have accepted one or more cash contributions in excess of the \$50 per campaign limit, as alleged in the complaint.

4. On March 31, 2022, Respondent filed his Appointment of Campaign Treasurer and Designation of Campaign Depository for Candidates form ("DS-DE 9") appointing Samantha Amador as treasurer for his campaign. (ROI Exhibit 1, page 1) On June 16, 2022, Respondent appointed himself to serve as deputy treasurer. (ROI Exhibit 1, page 2)

5. By letter dated January 7, 2021, Kristi Reid Willis, Chief, Bureau of Election Records, sent Respondent a letter acknowledging that the Division had received his DS-DE 9 and that his name was placed on the 2022 active candidate list. (ROI Exhibit 4, page 1)

6. The acknowledgment letter advised Respondent that all candidates filing reports with the Division are required to use the electronic filing system ("EFS") and provided Respondent with a user identification number and initial password to grant access to the EFS. (ROI Exhibit 4, page 1) The letter further advised Respondent that all the Division's publications and reporting forms were available on its website and directed Respondent to print out Chapter 106, Fla. Stat., the *Calendar of Reporting Dates*, and other relevant documents. (ROI Exhibit 4, page 2)

Alleged Violations: §§ 106.07(5), 106.19(1)(b), 106.19(1)(c), 106.19(1)(d), Fla. Stat. – Deficit

7. Complainant alleged that Respondent violated Florida's election laws by certifying that one or more campaign treasurer's reports were true, correct, and complete when they were not because of deficit balances reflected after the 2022 G5, 2022 G6, and 2023 Termination reporting periods. Further, Complainant alleged that Respondent falsified information or deliberately failed

to include information in one or more reports because of the campaign's ending deficit of \$340.05, which stemmed from omitted contributions, omitted expenditures, or prohibited activity. (ROI Exhibit 9, pages 1-2)

8. Under Section 106.07, Fla. Stat., a campaign treasurer's report is required to contain all contributions received and all expenditures made during the reporting period as well as the date, full name, address, and occupation or purpose associated with each transaction.

9. Errors and omissions may trigger additional violations under Sections 106.19(b) and (c), Fla. Stat., if a candidate falsified reported information or deliberately failed to include information in a campaign treasurer's report, particularly if accurate information would have led to additional or more severe violations upon disclosure.

10. Further, Section 106.19(1)(d), Fla. Stat., prohibits candidates from making or authorizing certain types of expenditures. Sections 106.11(1) and (2), Fla. Stat., require all expenditures to be made via bank check or debit card. Section 106.11(4), Fla. Stat., forbids candidates from authorizing expenditures or signing checks drawn on the campaign account without sufficient funds on deposit. Section 106.12, Fla. Stat., restricts how much cash can be withdrawn for and spent on campaign expenses. Finally, Section 106.141, Fla. Stat., limits how candidates can dispose of the campaign's remaining funds.

11. As for outgoing cash under Section 106.12, Fla. Stat., candidates for state senator may withdraw up to \$500 in cash per quarter before qualifying closes and up to \$100 in cash per week after qualifying closes and until the election. However, candidates must label all withdrawals and related expenditures as "petty cash." Candidates are forbidden from withdrawing cash during the termination reporting period. Checking account withdrawals qualify as cash withdrawals. Candidates may only use cash for office supplies, transportation, and other necessities. Cash cannot be used for the purchase of time, space, or services from communications media.

12. The Division's Advisory Opinion, DE 06-10, reiterates that petty cash may only be used for office supplies, transportation expenses, and necessities. The opinion clarifies that the term "necessities" was intended to mean "an item costing no more than \$99.99 which is purchased to meet an essential, urgent need that is unavoidable due to conditions or circumstances." If this condition is not met, then a campaign account check must be used, and the candidate must offer a full reporting of the transaction under Sections 106.07 and 106.021(3), Fla. Stat. This manner ensures that petty cash is not used to purchase time, space, or services from communications media or to reimburse individuals for campaign expenses in an anonymous or indirect manner, thereby upholding principles of transparency and specificity.

2022 G5 Report

13. Respondent filed the 2022 G5 Report on the designated due date of October 28, 2022, which covered from October 8, 2022, to October 21, 2022. (ROI Exhibit 5, pages 23, 28 & 32; ROI Exhibit 10, page 1) Respondent disclosed five contributions totaling \$116.55 and no expenditures. (ROI Exhibit 5, pages 24 & 28)

14. Respondent amended the report one week later to add four expenditures totaling \$1,993.00. (ROI Exhibit 5, pages 25 & 29) The Division flagged Respondent's account for reflecting a deficit balance of \$340.05. (ROI Exhibit 9, page 1)

15. On the same day Respondent received notice of the Division's referral, Respondent amended the report to add one contribution from himself totaling \$400.00. (ROI Exhibit 5, page 31; Attachment C, page 1)

16. Bank records show three ActBlue payouts totaling \$144.82, no expenditures, and no deficit during the reporting period. (ROI Exhibit 6, pages 3-4)

17. Respondent did not provide records from ActBlue to assist Commission staff in cross-referencing the campaign's activities. ActBlue typically assesses a transaction fee of 3.95% per contribution, but the fee is 3.7% plus \$0.23 if Stripe is used. (Attachment D, page 1) The latter calculation appears to be applicable based on Respondent's numbers. Payouts generally post two business days after the donation date. (Attachment D, page 2)

18. Two transactions during the 2022 G6 reporting period, which totaled \$0.73 and \$4.58, were disclosed during the 2022 G5 period as contributions totaling \$1.00 and \$5.00. (ROI Exhibit 5, pages 24, 28 & 34; ROI Exhibit 6, page 3) Respondent omitted the associated transaction fees. (ROI Exhibit 5, page 25)

19. The ActBlue payout for \$47.92 appeared to pair with Mary Sommerfeld's contribution for \$50.00. (ROI Exhibit 5, page 17; ROI Exhibit 6, page 3) The ActBlue payouts for \$48.45 appeared to pair with Ana Amador and John Zdrodowski's contributions for \$50.55. (ROI Exhibit 5, pages 17 & 24; ROI Exhibit 6, page 3) Respondent reported two of the contributions during the prior 2022 G4 reporting period and the last contribution during the 2022 G5 reporting period. (ROI Exhibit 5, pages 17 & 24) Respondent omitted the associated transaction fees. (ROI Exhibit 5, pages 18 & 25)

20. One \$10.00 check from Julie Jenkins, one \$50.00 check from Ana Amador, and one \$400.00 loan from Respondent were not verified. (ROI Exhibit 5, page 24; ROI Exhibit 6, page 3)

21. Adjacent deposits were examined to determine whether Respondent received but misdated the contributions. Records did not identify any checks or unaccounted ActBlue payouts substantiating the transactions. (ROI Exhibit 6, pages 1, 3, 5, 9-16, 20 & 21) The closest unexplained transactions included two cash deposits during the 2022 G2 and 2022 G3 reporting periods and one ActBlue payout that should have paired with a contribution for \$50.55 during the 2022 G2 period. (ROI Exhibit 5, page 2; ROI Exhibit 6, pages 1; Attachment E, page 1) The contribution from Julie Jenkins and the cash deposits will be addressed during the excessive cash analysis on pages 8 through 9 of the Staff Recommendation.

22. As to expenditures, Respondent reported four "MON" check transactions for advertising, which totaled \$500.00 for Tampa Bay Times, \$494.00 for TBN Weekly, \$500.00 for Tampa Signs, and \$499.00 for Griffin Productions. (ROI Exhibit 5, pages 25 & 29) However, bank

records reflect checking withdrawal slips during the 2022 G6 reporting period, which totaled \$500.00, \$494.00, \$411.00, and \$202.00. All withdrawal slips indicated that the payments were made to “Nelson Amador.” (ROI Exhibit 6, pages 3, 18, 19, 22 & 23) The withdrawal for \$411.00 displayed a handwritten note stating, “Tampa Bay Newspaper.” (ROI Exhibit 6, page 19) Respondent did not provide invoices verifying these transactions.

23. In response to the complaint, Respondent stated that he made “an inadvertent error in the initial reporting” of the 2022 G5 Report. Respondent asserted that he contributed \$400.00 to the campaign to cover expenses associated with print and online media advertising, which resulted in a positive balance of \$59.95. Respondent stated, “All issues have been corrected and addressed in the EFS reporting system and the letter.” (ROI Exhibit 7, page 1) Respondent later stated that the loan and his corrective actions produced a positive balance of \$120.00. (ROI Exhibit 7, page 2)

24. Respondent informed the Commission’s investigator that he was unaware of any outstanding errors as correspondence from the Division was not timely delivered to the Post Office Box he rented for the campaign. Respondent explained that there was an error with the Post Office regarding whether he paid his mailbox fees; therefore, mail was not delivered. It was not until Respondent checked his personal email account that he realized the Division had been trying to contact him regarding the issues. (ROI Exhibit 8, pages 2 & 4)

25. Respondent stated that the 2022 campaign was his first time running for office. He did not specifically recall reading Chapter 106, Fla. Stat., or the *Candidate and Campaign Treasurer Handbook*, but Respondent acknowledged looking through these items to learn about accepting and reporting contributions, making expenditures, and handling other relevant campaign matters. When asked about ActBlue, Respondent stated that he did not believe any fees were charged. (ROI Exhibit 8, page 3)

26. As of March 12, 2025, Respondent has not corrected the 2022 G5 Report. (Attachment E, pages 1-2)

27. Pursuant to Section 106.07(5), Fla. Stat., it appears that Respondent certified the 2022 G5 Report as true, correct, and complete when it was not. Respondent reported two unverified contributions, added one unverified loan from himself, misrepresented four check expenditures, and omitted relevant ActBlue transaction fees.

28. Pursuant to Section 106.19(1)(b), Fla. Stat., it does not appear that Respondent failed to report one or more contributions during the 2022 G5 reporting period.

29. Pursuant to Section 106.19(1)(c), Fla. Stat., it appears that Respondent falsely reported information on the campaign’s 2022 G5 Report. Respondent reported that four prohibited cash withdrawals during the 2022 G6 period were permitted check expenditures during the present period. Even if Respondent accurately reported the withdrawals as cash, the withdrawals exceeded the statutory limit per week and were used for a prohibited purpose, i.e., services from communications media. Finally, Respondent falsely reported a loan to the campaign, which

appears to have been done to superficially eliminate the imbalance caused by Respondent's omissions and errors.

30. Pursuant to Section 106.19(1)(d), Fla. Stat., it does not appear that Respondent made prohibited expenditures during the 2022 G5 reporting period.

2022 G6 Report

31. Respondent filed a notice of no activity for the 2022 G6 reporting period on November 5, 2022, which was one day late. (ROI Exhibit 5, pages 38-39; ROI Exhibit 10, page 1) No automatic fine was assessed. (ROI Exhibit 10, page 1; Attachment F, page 1) The reporting period covered from October 22, 2022, to November 3, 2022. (ROI Exhibit 5, page 33)

32. Bank records show two ActBlue payouts totaling \$5.31, which were previously reported, one unreported check totaling \$30.00, five checking withdrawals to Respondent totaling \$1,627.00, and two unreported bank fees totaling \$9.00. (ROI Exhibit 6, pages 3, 5 & 18-24) No deficit occurred during the reporting period. (ROI Exhibit 6, pages 3-5)

33. In addition to the four prohibited cash withdrawals previously addressed, Respondent made a fifth unreported cash withdrawal to himself totaling \$20.00. (ROI Exhibit 6, page 24)

34. Respondent replied to the complaint and stated that no activity occurred during the 2022 G6 reporting period. (ROI Exhibit 7, page 1)

35. Respondent informed the Commission's investigator that he was unaware of the Division's notices until he checked his personal email account. Respondent acknowledged looking through Chapter 106, Fla. Stat., and the *Candidate and Campaign Treasurer Handbook* to learn about accepting and reporting contributions, making expenditures, and handling other relevant campaign matters. (ROI Exhibit 8, pages 2-4)

36. As of March 12, 2025, Respondent has not corrected the notice of no activity for the 2022 G6 reporting period. (Attachment E, pages 1-2)

37. The requirement under Section 106.07(5), Fla. Stat., to certify as to the correctness of a report does not apply to notifications of no activity submitted to the filing officer pursuant to Section 106.07(7), Fla. Stat.

38. Pursuant to Section 106.19(1)(b), Fla. Stat., Respondent failed to report one check contribution totaling \$30.00, which impacted the campaign's deficit balance and was the last deposit made outside of ActBlue after September. (ROI Exhibit 6, pages 1, 3, 5, 7 & 8)

39. Pursuant to Section 106.19(1)(c), Fla. Stat., Respondent falsely reported no activity for the 2022 G6 reporting period when Respondent accepted one unreported contribution, made five prohibited cash withdrawals, was assessed two bank fees, and failed to correct the false notice.

40. Pursuant to Section 106.19(1)(d), Fla. Stat., Respondent made five prohibited expenditures totaling \$1,627.00.

2023 Termination Report

41. Respondent filed the 2023 Termination Report one month early on December 29, 2022, which covered from November 4, 2022, to December 29, 2022. (ROI Exhibit 5, pages 40, 45 & 46; ROI Exhibit 10, page 1) Respondent disclosed one refund to himself totaling \$59.95 but later amended the amount to reflect \$120.00. (ROI Exhibit 5, pages 41 & 45) Respondent disclosed no expenditures. (ROI Exhibit 5, page 42)

42. Bank records show one checking withdrawal to himself totaling \$20.00 and two unreported bank fees totaling \$9.00. (ROI Exhibit 6, pages 5 & 25) The campaign account incurred a deficit balance of -\$1.00 upon the assessment of the final monthly bank fee. (ROI Exhibit 6, page 5) The account retained the same deficit balance until the account was credited and closed on January 31, 2023. (ROI Exhibit 6, pages 5-7)

43. In response to the complaint, Respondent stated that he contributed \$400.00 to the campaign to cover expenses associated with print and online media advertising, which resulted in a positive balance of \$59.95. (ROI Exhibit 7, page 1) Respondent later stated that his corrective actions produced a positive balance of \$120.00. (ROI Exhibit 7, page 2) Respondent amended the termination report to reflect the refunds and the closing of the account on December 20, 2022. (ROI Exhibit 7, pages 1-2)

44. As of March 12, 2025, Respondent has not corrected the 2023 Termination Report. (Attachment E, pages 1-2)

45. Pursuant to Section 106.07(5), Fla. Stat., it appears that Respondent certified the 2023 Termination Report as true, correct, and complete when it was not. Respondent misrepresented one prohibited cash withdrawal to himself and omitted two bank fees.

46. Pursuant to Section 106.19(1)(b), Fla. Stat., it does not appear that Respondent failed to report a contribution.

47. Pursuant to Section 106.19(1)(c), Fla. Stat., Respondent falsely reported one prohibited cash withdrawal as a permitted check refund. Respondent also reported a different amount, which superficially offset the new imbalance caused by Respondent's unverified loan to the campaign.

48. Pursuant to Section 106.19(1)(d), Fla. Stat., Respondent made one prohibited withdrawal totaling \$20.00 during the termination reporting period in violation of Sections 106.12 and 106.141, Fla. Stat. Respondent also failed to monitor his account to ensure the depository had sufficient funds on deposit to account for all expenditures and fees.

Alleged Violation: § 106.09(1)(b), Fla. Stat. – Excessive Cash

49. Complainant alleged that Respondent violated Florida's election laws by accepting one or more cash contributions in excess of the \$50.00 per campaign limit. Specifically, Respondent accepted an excessive cash contribution from Julie Jenkins.

50. Respondent reported a total of four contributions from Ms. Jenkins during the campaign's lifespan. (ROI Exhibit 5, pages 2, 9 & 24; Attachment E, page 1)

51. Respondent stated that the contributions from Ms. Jenkins were by check and were deposited into the campaign's account. (ROI Exhibit 7, page 1; ROI Exhibit 8, page 3) Respondent stated that he handled all cash deposits. (ROI Exhibit 8, page 3)

First Contribution: 2022 P6 Report

52. Respondent disclosed one \$20.00 check from Julie Jenkins on August 1, 2022. (Attachment E, page 1)

53. Bank records show only one transaction during the 2022 P6 reporting period, which consisted of an ActBlue payout totaling \$23.84. (Attachment G, page 1) The transaction appeared to relate to Frank Makowski's \$25.00 contribution. (Attachment E, page 1)

54. Bank records show one check received from Ms. Jenkins during the campaign. (ROI Exhibit 6, pages 9-25) The check totaled \$20.00, was dated July 27, 2022, but was deposited on September 22, 2022. (ROI Exhibit 6, pages 1 & 13)

55. It appears that Respondent reported the check close to the time of receipt, i.e., five days after the date on the check. Therefore, no cash is at issue during the 2022 P6 reporting period.

Second Contribution: 2022 G2 Report

56. Respondent disclosed four cash contributions on September 8, 2022, totaling \$103.00. One of the transactions included a \$20.00 cash contribution from Ms. Jenkins. (ROI Exhibit 5, page 2)

57. Bank records show one cash deposit on September 8, 2022, totaling \$217.77. (ROI Exhibit 6, pages 1, 9 & 10)

58. Respondent accepted \$20.00 cash from Ms. Jenkins. However, the remaining cash totaling \$114.77 was not reported or explained via cross-referencing. (ROI Exhibit 5, pages 2 & 9; Attachment E, page 1)

59. Pursuant to Section 106.09(1)(b), Fla. Stat., it appears that Respondent accepted an excessive cash contribution totaling \$114.77, which was not reported and may have related to Ms. Jenkins or a previous cash contributor.

Third Contribution: 2022 G3 Report

60. Respondent disclosed one \$40.00 cash contribution from Ms. Jenkins on September 22, 2022. (ROI Exhibit 5, page 9) Immediately upon receiving the Division's referral, Respondent changed the contribution from cash to check. (ROI Exhibit 5, pages 9 & 14; Attachment C, page 1)

61. Bank records did not verify Ms. Jenkins' check. Instead, \$123.00 in cash and Ms. Jenkins' July check were deposited on September 22, 2022. (ROI Exhibit 6, page 1, 11 & 13)

62. It appears that Ms. Jenkins' \$40.00 contribution took the form of cash, was part of the \$123.00 cash deposit, and was modified to eliminate the appearance of a violation. Based on Respondent's reporting alone, Ms. Jenkins' contribution exceeded the statutory threshold by \$10.00.

63. The remaining cash totaling \$83.00 was not reported or explained via cross-referencing. (ROI Exhibit 5, pages 2, 9 & 17; Attachment E, page 1)

64. Pursuant to Section 106.09(1)(b), Fla. Stat., it appears that Respondent accepted an excessive cash contribution from Ms. Jenkins totaling \$40.00 and an excessive cash contribution totaling \$83.00, which was not reported and may have related to Ms. Jenkins or a previous cash contributor.

Fourth Contribution: 2022 G5 Report

65. Respondent disclosed one \$10.00 check from Ms. Jenkins on October 12, 2022, as noted in paragraphs 20 and 21. (ROI Exhibit 5, page 24)

66. No cash deposits, unaccounted check deposits, or unaccounted ActBlue payouts were made on or around October 12, 2022. (ROI Exhibit 6, page 3)

67. Based on Respondent's reporting patterns, Respondent likely accepted a \$10.00 contribution from Ms. Jenkins although it is uncertain when and in what form the contribution was received. It is uncertain whether Respondent accepted a check that he neglected to deposit, accepted a check that he deposited into a separate account, accepted cash without depositing it into the campaign's account, or accepted cash that he deposited at an earlier time. Ultimately, Respondent falsely reported the nature of the \$10.00 contribution from Ms. Jenkins pursuant to section 106.19(1)(c), Fla. Stat., which may have established grounds for other violations had it been accurately reported.

Alleged Violation: § 106.07(5), Fla. Stat. – 2022 G3

68. Complainant alleged that Respondent violated Florida's election laws by certifying that the campaign's 2022 G3 Report was true, correct, and complete when it was not.

69. Respondent initially filed a notice of no activity for the 2022 G3 reporting period. (ROI Exhibit 5, pages 13 & 15; ROI Exhibit 10, page 1)

70. Respondent filed the 2022 G3 Report on September 25, 2022, which covered from September 10, 2022, to September 23, 2022. (ROI Exhibit 5, pages 8, 13 & 15) Respondent disclosed four check contributions totaling \$450.55, one cash contribution from Julie Jenkins totaling \$40.00, and no expenditures. (ROI Exhibit 5, pages 9, 10 & 13)

71. As previously discussed, Respondent changed Ms. Jenkins' contribution from cash to check on the same day he received notice of the Division's referral. (ROI Exhibit 5, pages 9 & 14; Attachment C, page 1)

72. Respondent's bank records show Ms. Jenkins' July check totaling \$20.00, two verified ActBlue payouts totaling \$288.74, which covered sequences 2 through 4, one unreported check totaling \$13.35, and one cash deposit totaling \$123.00. (ROI Exhibit 5, page 9; ROI Exhibit 6, pages 1 & 11-14) Respondent omitted \$83.00 from the cash deposit as well as ActBlue transaction fees. (ROI Exhibit 5, pages 2, 9, 10 & 17; Attachment E, pages 1-2)

73. Pursuant to Section 106.07(5), Fla. Stat., it appears that Respondent certified the campaign's 2022 G3 Report as true, correct, and complete when it was not.

74. "Probable Cause" is defined as reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. *Schmitt v. State*, 590 So. 2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. *Department of Highway Safety and Motor Vehicles v. Favino*, 667 So. 2d 305, 309 (Fla. 1st DCA 1995).

75. The facts set forth above show that Respondent was a 2022 candidate for State Senator, District 21. Respondent certified that the campaign's 2022 G3, 2022 G5, and 2023 Termination Reports were true, correct, and complete when they were not. Respondent accepted three excessive cash contributions, two of which were anonymous. Respondent falsely reported or deliberately failed to include information on the campaign's 2022 G5, 2022 G6, and 2023 Termination Reports. Respondent omitted one check contribution that was required to be reported. Finally, Respondent made six prohibited cash expenditures.

Based upon these facts and circumstances, I recommend that the Commission find probable cause to charge Respondent with violating the following:

Count 1:

On September 8, 2022, Nelson Amador violated Section 106.09(1)(b), Florida Statutes, when he accepted an excessive cash contribution totaling \$114.77.

Count 2:

On September 22, 2022, Nelson Amador violated Section 106.09(1)(b), Florida Statutes, when he accepted an excessive cash contribution totaling \$40.00.

Count 3:

On September 22, 2022, Nelson Amador violated Section 106.09(1)(b), Florida Statutes, when he accepted an excessive cash contribution totaling \$83.00.

Count 4:

On September 25, 2022, Nelson Amador violated Section 106.07(5), Florida Statutes, when he certified that the campaign's 2022 G3 Report was true, correct, and complete when it was not.

Count 5:

On October 24, 2022, Nelson Amador violated Section 106.19(1)(d), Florida Statutes, when he made a prohibited cash withdrawal to himself totaling \$411.00.

Count 6:

On October 24, 2022, Nelson Amador violated Section 106.19(1)(d), Florida Statutes, when he made a prohibited cash withdrawal to himself totaling \$494.00.

Count 7:

On October 28, 2022, Nelson Amador violated Section 106.07(5), Florida Statutes, when he certified that the campaign's 2022 G5 Report was true, correct, and complete when it was not.

Count 8:

On October 28, 2022, Nelson Amador violated Section 106.19(1)(c), Florida Statutes, when he falsely reported information on the campaign's 2022 G5 Report.

Count 9:

On October 31, 2022, Nelson Amador violated Section 106.19(1)(d), Florida Statutes, when he made a prohibited cash withdrawal to himself totaling \$20.00.

Count 10:

On October 31, 2022, Nelson Amador violated Section 106.19(1)(d), Florida Statutes, when he made a prohibited cash withdrawal to himself totaling \$202.00.

Count 11:

On October 31, 2022, Nelson Amador violated Section 106.19(1)(d), Florida Statutes, when he made a prohibited cash withdrawal to himself totaling \$500.00.

Count 12:

On November 4, 2022, Nelson Amador violated Section 106.19(1)(b), Florida Statutes, when he failed to report a contribution for \$30.00.

Count 13:

On November 5, 2022, Nelson Amador violated Section 106.19(1)(c), Florida Statutes, when he deliberately failed to disclose activity required to be reported, which consisted of one contribution, five withdrawals, and two bank fees.

Count 14:

On November 7, 2022, Nelson Amador violated Section 106.19(1)(d), Florida Statutes, when he made a prohibited cash withdrawal to himself totaling \$20.00.


Count 15:

On December 29, 2022, Nelson Amador violated Section 106.07(5), Florida Statutes, when he certified that the campaign's 2023 Termination Report was true, correct, and complete when it was not.


Count 16:

On December 29, 2022, Nelson Amador violated Section 106.19(1)(c), Florida Statutes, when he falsely reported and deliberately failed to include information on the campaign's 2023 Termination Report.

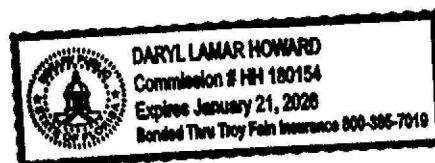

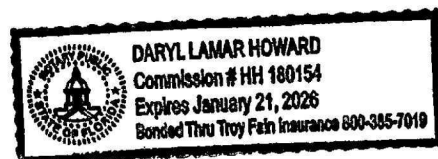

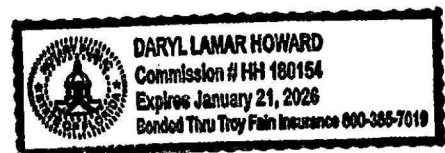

I. Preliminary Information:

1. Respondent was a 2022 candidate for State Senator, District 21; he was defeated in the general election held on November 8, 2022. Respondent was a first-time candidate.

2. An Appointment of Campaign Treasurer and Designation of Campaign Depository (DS-DE 9) was filed on March 31, 2022. Samantha Amador was appointed as campaign treasurer. To review the DS-DE 9, refer to Exhibit 1.¹

3. Respondent filed a Statement of Candidate with the Division on March 31, 2022, in which Respondent certified he had been provided access to read and understand the requirements of Chapter 106, F.S. To review the Statement of Candidate, refer to Exhibit 2.

4. An acknowledgement letter was mailed to the address provided on the DS-DE 9 on January 7, 2021.² The letter advised Respondent that all candidates filing reports with the Division are required to file by means of the Division's electronic filing system (EFS). Respondent was provided with a user identification number and initial password allowing access to the EFS.

5. The acknowledgement letter also advised Respondent that all of the Division's publications and reporting forms are available on their website, including Chapter 106, Florida Statutes, the *Candidate and Campaign Treasurer Handbook* and the *Calendar of Reporting Dates*. The letter further advised that it was Respondent's responsibility to read, understand, and follow the requirements of Florida's election laws. To review the acknowledgement letter, refer to Exhibit 4.

² Respondent had initially filed to run for Governor of Florida on 1/6/21. This acknowledgement letter was sent to Respondent after that filing. On 3/10/22, Respondent redesignated the office sought to State Senator, District 16. On 3/31/22, Respondent again redesignated the office sought to State Senator, District 21, due to redistricting. To review the redesignation letters, refer to Exhibit 3.

II. Alleged Violation of Sections 106.07(5) and 106.09(1)(b), Florida Statutes:

6. I investigated whether Respondent violated these sections of the election laws by certifying that the 2022 G3 campaign treasurer report was true, correct, and complete when it was not, and accepting a cash contribution in excess of \$50.00 per campaign limit, based upon a contribution reported during the 2022 G3 reporting period.

7. On September 9, 2022, Respondent filed the 2022 G2 report disclosing receipt of a \$20.00 cash contribution from Julie Jenkins on September 8, 2022. On September 25, 2022, Respondent filed a 2022 G3 report disclosing receipt of a \$40.00 cash contribution from Julie Jenkins on September 22, 2022. The \$40.00 cash contribution included in the 2022 G3 report brought reported aggregate cash contributions from Ms. Jenkins to \$60.00. On October 16, 2023, Respondent filed an amended 2022 G3 report changing the \$40.00 contribution from cash to check. To review the 2022 G2 and 2022 G3 reports, refer to Exhibit 5, pages 1-15.

8. I subpoenaed bank records from the designated campaign depository and reviewed them for records of the two contributions at issue. A \$217.77 cash deposit was made on September 8, 2022, and a \$123.00 cash deposit was made on September 22, 2022. Those two cash deposits could have accounted for the \$20.00 and \$40.00 cash contributions reportedly received on those dates.³ However, a \$20.00 check from Julie Jenkins was also deposited on September 22, 2022, which matches the date of the reported \$40.00 contribution at issue on the 2022 G3 report. Respondent changed that contribution from cash to check in an amended G3 report but left the amount \$40.00. To review the bank records, refer to Exhibit 6, pages 1 and 9-14.

9. Respondent did respond to the referral. He stated, “The incorrect tab regarding Reports **G2, G5, and G3** wrong contribution type was selected in the drop-down tab. The contribution type was checks from Mrs. Jenkins, which were deposited to the candidate’s campaign account. The **G3 report** was updated and corrected as of 10/16/2023, as this oversight was never corrected in the original report.” To review Respondent’s response, refer to Exhibit 7.

10. I called Respondent for the purpose of providing an opportunity to discuss the allegations made in the referral. In speaking about Ms. Jenkins’ reported cash contributions, Respondent reiterated statements made in his response, explaining the error was due to problematic data entry. Respondent also made the statement that Ms. Jenkins had only ever made check contributions. Respondent stated that he handled all cash deposits. To review the phone log, refer to Exhibit 8.

III. Alleged Violation of Section 106.19(1)(d), Florida Statutes:

11. I investigated whether Respondent violated this section of the election laws by making or authorizing one or more expenditure(s) prohibited by Chapter 106, Florida Statutes.

12. The Division’s Sum of Contributions vs. Expenditures report showed an apparent deficit balance in the following reporting period(s): 2022 G5, 2022 G6, and 2023 TR. To review the report, refer to Exhibit 9.

13. I reviewed bank records from the designated campaign depository covering the following reporting period(s): 2022 G4, 2022 G5, 2022 G6, and 2023 TR. There was one instance during that timeframe in which the campaign account balance was negative. On November 30, 2022, two bank fee expenditures in the amounts of \$2.00 and \$7.00 took the account to a negative -\$1.00 balance. On January 31, 2023, a \$1.00 “bank closing credit” rendered a \$0.00 balance; the campaign depository was subsequently closed on January 31, 2023. To review the bank records, refer to Exhibit 6. To review bank statement(s) reflecting the negative balance(s), refer to Exhibit 6, pages 5-8.

³ Deposits of online contributions via Actblue made on 9/8/22, 9/9/22, 9/14/22, and 9/22/22 could also have accounted for the two contributions at issue, but they would be considered check contributions.

IV. Alleged Violation of Sections 106.07(5), 106.19(1)(b), and 106.19(1)(c), Florida Statutes:

14. I investigated whether Respondent violated these sections of the election laws by certifying that one or more campaign treasurer report(s) were true, correct, and complete when they were not, failing to report one or more contribution(s), and falsely reporting or deliberately failing to include information in one or campaign treasurer report(s) due to an apparent deficit balance in the following reporting period(s): 2022 G5, 2022 G6, and 2023 TR.

15. I reviewed bank records from the designated campaign depository and compared them with campaign treasurer report(s) covering the following reporting periods: 2022 G4, 2022 G5, 2022 G6, and 2023 TR.⁴ The results of my review are reflected in the table below. To review the campaign treasurer report(s), refer to Exhibit 5, pages 16-46. To review the bank records, refer to Exhibit 6. To review Respondent's filing history, refer to Exhibit 10.

<p>17. I called Respondent for the purpose of providing an opportunity to discuss the allegations made in the referral. Respondent elaborated that he was unaware of outstanding errors, as correspondence from the Division was not timely delivered to the P.O. Box he had rented for the duration of the campaign. He explained that there was an internal error within the USPS regarding rental fees for his P.O. Box; due to this error, mail was not delivered to the P.O. Box, including correspondence from the Division. It was not until Respondent received a notice from the Division on his personal email account that he attempted to rectify the errors. Respondent explained he was a first-time candidate. He does not specifically recall reading Chapter 106, Florida Statutes or the <i>Candidate and Campaign Treasurer Handbook</i>. However, Respondent acknowledged reading through these items to learn about accepting and reporting contributions, making expenditures, and other campaign finance matters. The incorrect tab regarding Reports **G2, G5, and G3** wrong contribution type was selected in the drop-down tab. The contribution type was checks from Mrs. Jenkins, which were deposited to the candidate's campaign account. The **G3 report** was updated and corrected as of 10/16/2023, as this oversight was never corrected in the original report.

All issues have been corrected and addressed in the EFS reporting system and the letter. Thank you, Mrs. Hart and those of you in the Florida Election Committee, for your incredible work in keeping our elections running smoothly and fairly.

RESPONDENT INTERVIEW MEMO – Call details at # [305-761-3419]

- Who completed and filed the majority of your campaign treasurer reports: you or someone else?
 - Respondent changed treasurers and ultimately appointed his niece (Samantha Amaro) as treasurer; Respondent appointed himself deputy treasurer. Based on Respondent's comments, it appears that the treasurers *and* Respondent filed campaign treasurer reports.
- You filed qualifying documents for several different offices; a separate DS-DE 9 was filed for each office, but I have not located a Statement of Candidate for the State Senator, District 21
 - Respondent does not recall filing one for State Senator, District 21 and the Division never notified him about any outstanding qualifying docs.
- Did you receive any campaign-related assistance from an outside source, such as a campaign manager, attorney, or anyone else?
 - No.
- When did you first become aware of outstanding problems with the 2022 G5, 2022 G6, and 2023 TR?
 - Respondent didn't realize there were any errors...
 - "Right before the TR was due, I called the Division and asked them if there were issues and they told me there were not."
 - Respondent mentioned that after having lost the election, he went on some trips and did not check email regularly; to his knowledge, he did not know there were any outstanding issues.
 - Respondent further explained that there had been an error with USPS and maintaining his PO Box; this interfered with the timely receipt of DOE correspondence.
 - Note: Respondent intends to forward proof of the issues w/ USPS. He states they erroneously reported that he had *not* paid for the PO Box, even though this is inaccurate.
- Did anybody else have access to your campaign depository during the 2022/2023 election?
 - No. Also, Respondent also mentioned that he lost his campaign checks when he was in Tallahassee. He reported the lost checks and does not believe they were ever compromised.

- Can you explain how you amended the excessive cash contributions made by Julie Jenkins?
 - Respondent stated Ms. Jenkins' contributions were actually checks, not cash.
 - Respondent stated that categorizing the contributions was a data-entry error
 - He further explained there were errors made w/ drop-down menu in selecting payment "type," although he did not become aware of these errors until later
- Did you accept online contributions?
 - Yes. However, as he remembers it, Respondent does not believe he was charged any fees.
 - Respondent mentioned that he will have to review his statements from the online contribution platform, to better determine whether or not he was charged any fees.
- To your knowledge, were any fees related to an online contribution platform reflected in your campaign reports?
 - Respondent doesn't recall any fees, but he may be mistaken. He needs to research this further.
- How did you handle cash contributions?
 - Respondent stated that he handled all cash deposits and does not recall any banking errors.
- Have you ever run for public office?
 - No.
- Have you ever been appointed to act as a campaign treasurer for a candidate?
 - No
- Have you ever held the office of chairperson, treasurer, or other similar position for a political committee or electioneering communications organization?
 - No
- Have you ever prepared or signed a campaign treasurer's report?
 - No
- Do you possess a copy of Chapter 106, Florida Statutes? If so, when did you first obtain it? Have you read it?
 - Respondent does not recall receiving Chapter 106. I explained that a link was included in the Division's acknowledgment letter with PIN and ID. Respondent explained that, as it was back in 2022 and he is currently re-filing to run again, he genuinely does not recall.
 - Respondent did agree that he had looked-up various sections of Chapter 106 to complete and file campaign reports.
- Do you possess a copy of the *Candidate and Campaign Treasurer Handbook*? If so, when did you first obtain it? Have you read it?
 - See response above.
- Do you have anything else to add for the Commission's consideration regarding the charges specified in the letter of legal sufficiency in this case?
 - Respondent is preparing to run for office in 2024; following his 2022 experience, he is hiring a campaign consultant and/or campaign treasurer.
 - Respondent and I discussed problems regarding his PO Box, as the USPS erroneously reported the PO Box as "unpaid," causing Respondent's campaign-related mail was bounced-back to the Division.

- After losing the 2022 election, Respondent took a trip and did not check his campaign-related email account. Only after he checked his email on a whim, did he realize the Division had been trying to contact him about reporting errors.
- Respondent also contacted Division and worked with Mr. Howard to amend reports and learn what went wrong.

You will have an opportunity to respond to both the ROI and the SR. The Commission will then hold one or more hearings to determine whether the alleged violations occurred and, if so, the amount of the fine to be imposed upon you. Notice will be mailed to you and the Complainant at least 14 days before any hearing at which your case is to be considered.
