## **ORDER OF PROBABLE CAUSE**

On or about May 7, 2021, Roy Hardemon violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2020 TR Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

#### Count 3:

On or about June 2, 2020, Roy Hardemon violated Section 106.09(1)(b), Florida Statutes, when he accepted a cash contribution in excess of \$50.

#### Count 4:

On or about June 24, 2020, Roy Hardemon violated Section 106.07(5), Florida Statutes, when he certified that the campaign's 2020 P1 Report was true, correct, and complete when it was not.

#### Count 5:

On or about July 6, 2020, Roy Hardemon violated Section 106.07(5), Florida Statutes, when he certified that the campaign's 2020 P2 Report was true, correct, and complete when it was not.

#### Count 6:

On or about November 17, 2020, Roy Hardemon violated Section 106.07(5), Florida Statutes, when he certified that the campaign's 2020 TR Report was true, correct, and complete when it was not.

#### Count 7:

On or about July 6, 2020, Roy Hardemon violated Section 106.19(1)(c), Florida Statutes, when he deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2020 P2 Report.

#### Count 12:

On or about November 17, 2020, Roy Hardemon violated Section 106.19(1)(c), Florida Statutes, when he deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2020 TR Report.

#### **Count 13:**

#### NOTICE OF RIGHT TO A HEARING

As the Respondent, you may elect to resolve this case in several ways. 

#### STAFF RECOMMENDATION FOLLOWING INVESTIGATION

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the referral in this case recommending that there is **probable cause** to charge Respondent with violating **Sections 106.07(2)(b)1., 106.07(5), 106.09(1)(b), 106.19(1)(b), 106.19(1)(c), and 106.19(1)(d), Florida Statutes**. Based upon a thorough review of the Report of Investigation submitted on June 19, 2023, the following facts and law support this staff recommendation:

- 1. On June 24, 2021, the Florida Elections Commission ("Commission") received a referral from the Department of State, Division of Elections ("Division" or "Complainant"), alleging that Roy Hardemon ("Respondent") violated Chapter 106, Florida Statutes.
- 2. Respondent was a 2020 candidate for State Representative, District 108. Respondent's Statement of Candidate form ("DS-DE 84") was filed on January 7, 2019. (ROI Exhibit 2)<sup>1</sup> Respondent was not a first-time candidate. (ROI, p. 1, ¶1)
- 3. By letter dated December 16, 2021, the Executive Director notified Respondent that Commission staff would investigate the following statutory provisions:

Section 106.07(2)(b)1., Florida Statutes: Respondent, a 2020 candidate for State Representative, District 108, acting as his own treasurer, failed to timely make necessary amendments to the 2019 M11 and 2020 TR reports, as alleged in the complaint.

Section 106.07(5), Florida Statutes: Respondent, a 2020 candidate for State Representative, District 108, may have certified the 2020 P1 campaign treasurer's report was true, correct, and complete when it was not, based on a reported cash contribution in excess of the \$50 per campaign limit, as alleged in the complaint.

Section 106.09(1)(b), Florida Statutes: Respondent, a 2020 candidate for State Representative, District 108, may have accepted a cash contribution in excess of the \$50 per campaign limit, based upon a contribution reported during the 2020 P1 reporting period, as alleged in the complaint.

Section 106.07(5), Florida Statutes: Respondent, a 2020 candidate for State Representative, District 108, may have certified one or more campaign treasurer's reports were true, correct, and complete when they were not, based upon an apparent deficit after the 2020 P1, 2020 P2, and 2020 TR reports were filed, as alleged in the complaint.

Section 106.19(1)(b), Florida Statutes: Respondent, a 2020 candidate for State Representative, District 108, may have failed to report one or more contributions required to be reported by Chapter 106, Florida Statutes, based upon an apparent deficit after the 2020 P1, 2020 P2, and 2020 TR reports were filed, as alleged in the complaint.

Section 106.19(1)(c), Florida Statutes: Respondent, a 2020 candidate for State Representative, District 108, may have falsely reported or deliberately failed to include information in one or more campaign treasurer's reports required by Chapter 106, Florida Statutes, based upon an apparent deficit after the 2020 P1, 2020 P2, and 2020 TR reports were filed, as alleged in the complaint.

Section 106.19(1)(d), Florida Statutes: Respondent, a 2020 candidate for State Representative, District 108, may have made or authorized one or more expenditures prohibited by Chapter 106, Florida Statutes, based upon an apparent deficit after the 2020 P1, 2020 P2, and 2020 TR reports were filed, as alleged in the complaint.

- 4. On January 7, 2019, Respondent filed his Appointment of Campaign Treasurer and Designation of Campaign Depository for Candidates form ("DS-DE 9") appointing himself as treasurer for his campaign. (ROI Exhibit 1, page 1)
- 5. By letter dated January 8, 2019, Kristi Reid Willis, Chief, Bureau of Election Records, sent Respondent a letter acknowledging that his name was placed on the 2020 active candidate list. (ROI Exhibit 3, page 1)
- 6. The acknowledgment letter advised Respondent that all candidates filing reports with the Division are required to use the electronic filing system ("EFS") and provided Respondent with a user identification number and initial password to grant access to the EFS. (ROI Exhibit 3, page 1) The letter further advised Respondent that all of the Division's publications and reporting forms were available on its website and directed Respondent to print out Chapter 106, Florida Statutes, and the *Calendar of Reporting Dates*, as well as other relevant documents. (ROI Exhibit 3, page 2)

# FAILURE TO AMEND REPORTS

## Alleged Violation: Section 106.07(2)(b)1., Florida Statutes

- 7. Complainant alleged that the campaign's 2019 M11 and 2020 TR reports were incomplete when filed. *See* Compl.
- 8. The Division sent three letters notifying Respondent that the campaign's reports were incomplete, and that Respondent was required to amend the reports within 7 days of receipt of the notification. An Error Report and a Compliance Report showing why the reports were incomplete was attached to each notification. (ROI Exhibits 4 & 5) The final notification was confirmed delivered. (ROI Exhibit 5, page 7)
- 9. Respondent stated that the reports were not amended due to medical issues and a death in the family. (ROI Exhibit 10, page 2)
- 10. Respondent failed to timely file the required amendments to the campaign's 2019 M11 and 2020 TR reports within 7 days of receiving notification from the Division that the reports were incomplete and required amendment.

## **EXCESSIVE CASH CONTRIBUTION**

## Alleged Violation: Section 106.09(1)(b), Florida Statutes

- 11. Complainant alleged that Respondent violated Florida's election laws by accepting a cash contribution in excess of \$50. More specifically, Complainant alleged that Respondent accepted an excessive cash contribution from himself. See Compl., p. 3.
- 12. Respondent's 2020 P1 Report shows one cash contribution in the amount of \$500 received from Roy Hardemon on June 2, 2020. (ROI Exhibit 6, page 15)
- 13. A subpoena was issued to Respondent's designated campaign depository to ascertain whether Respondent's campaign received an excessive cash contribution. Respondent's bank records show a cash deposit in the amount of \$500 received on June 2, 2020. (ROI Exhibit 7, pages 9, & 20-23)
- 14. Respondent did not provide a response that specifically addressed the alleged Section 106.09(1)(b), Florida Statutes, violation. (ROI Exhibit 10)
  - 15. Respondent accepted a cash contribution in excess of \$50.

## Alleged Violation: Section 106.07(5), Florida Statutes

16. Complainant alleged that Respondent violated Florida's election laws by certifying that the campaign's 2020 P1 Report was true, correct, and complete when it was not, based on a reported cash contribution in excess of the \$50 per campaign limit.

17. Based on the above analysis, it appears that the excessive cash contribution was reported correctly as it was supported by Respondent's bank records.

# APPARENT DEFICIT BALANCE

#### Alleged Violation: Section 106.19(1)(d), Florida Statutes

- 18. Complainant alleged that Respondent violated Florida's election laws by making or authorizing expenditures prohibited by Chapter 106, Florida Statutes. More specifically, Complainant alleged that Respondent authorized expenditures without sufficient funds on deposit during the 2020 P1, 2020 P2, and 2020 TR reporting periods. *See* Compl., pp. 5-7.
- 19. Section 106.19(1)(d), Florida Statutes, prohibits candidates from making or authorizing expenditures in violation of Section 106.11(4), Florida Statutes. Section 106.11(4), Florida Statutes, prohibits candidates from authorizing expenditures or signing checks drawn on the campaign account without sufficient funds on deposit in the campaign account.
- 20. A subpoena was issued to Respondent's designated campaign depository to ascertain whether Respondent authorized expenditures or signed checks drawn on the campaign depository without sufficient funds on deposit to pay the full amount of the authorized expenditures.
- 21. The 2020 P1 reporting period ran from June 1, 2020, through June 12, 2020. (ROI Exhibit 6, page 14) Respondent's bank records show that Respondent had sufficient funds on deposit during the relevant reporting period. (ROI Exhibit 7, page 11)
- 22. The 2020 P2 reporting period ran from June 13, 2020, through June 26, 2020. (ROI Exhibit 6, page 20) Respondent's bank records show that Respondent had sufficient funds on deposit during the relevant reporting period. (ROI Exhibit 7, page 11)
- 23. The 2020 TR reporting period ran from August 14, 2020, through November 16, 2020. (ROI Exhibit 6, page 26) Respondent's bank records show that the campaign depository had insufficient funds on deposit during the relevant reporting period. (ROI Exhibit 7, pages 35, 40, & 43) On August 24, 2020, Respondent issued a check to himself in the amount of \$500 and incurred an overdraft item fee in the amount of \$35, which left the account with a balance of -\$489.06. (ROI Exhibit 7, pages 33-35, & 37)
- 24. On September 1, 2020, and October 1, 2020, Respondent's campaign depository was assessed a \$17 monthly service fee by the financial institution which brought the account into a further deficit. (ROI Exhibit 7, pages 39-40, & 42-43) On November 13, 2020, Respondent made a \$600 cash deposit into the account which returned the account to a surplus balance. (ROI Exhibit 7, pages 45-50)
- 25. Respondent stated that his campaign account never had a deficit balance. (ROI Exhibit 10, page 1)

26. Respondent made or authorized an expenditure prohibited by Chapter 106, Florida Statutes, during the 2020 TR reporting period.

#### Alleged Violation: Section 106.07(5), Florida Statutes

- 27. Complainant alleged that Respondent violated Florida's election laws by certifying that the campaign's reports were true, correct, and complete when they were not based upon an apparent deficit after the 2020 P1, 2020 P2, and 2020 TR reports were filed.
- 28. Under Section 106.07, Florida Statutes, a campaign treasurer's report is required to contain all contributions received and all expenditures made during the reporting period. Additionally, Section 106.07(4)(a), Florida Statutes, provides that each report must also contain the full name, address, and occupation or description of business, together with the amount and date of such contributions, and the full name and address to whom expenditures have been made along with the amount, date, and purpose for said expenditures.
- 29. On June 24, 2020, Respondent certified the campaign's 2020 P1 Report was true, correct, and complete. (ROI Exhibit 9, page 1) The campaign's report was incorrect as Respondent failed to disclose a contribution in the amount of \$300 and an expenditure in the amount of \$17. (ROI Exhibit 6, pages 14-18; ROI Exhibit 7, pages 8-31; See ROI, p. 3, \$\quad \text{920}\)
- 30. On July 6, 2020, Respondent certified the campaign's 2020 P2 Report was true, correct, and complete. (ROI Exhibit 9, page 1) The campaign's report was incorrect as Respondent failed to disclose a contribution in the amount of \$1,000 and an expenditure in the amount of \$1,808.30. (ROI Exhibit 6, pages 20-24; ROI Exhibit 7, pages 8-31; See ROI, p. 3, \$\quad \text{920}\)
- 31. On November 17, 2020, Respondent certified the campaign's 2020 TR Report was true, correct, and complete. (ROI Exhibit 9, page 1) The campaign's report was incorrect as Respondent failed to disclose one or more cash contributions totaling \$600 and seven expenditures totaling \$1,069 and disclosed two expenditures totaling \$200 that were not supported by bank records. (ROI Exhibit 6, pages 26-30; ROI Exhibit 7, pages 32-50; See ROI, p. 4, \$\frac{1}{2}\$0)
- 32. Respondent stated that the errors in his reports were related to not reporting the correct finances in the correct month. He stated that he has run for office since 1992. Respondent stated that he has not read the *Candidate and Campaign Treasurer Handbook* or Chapter 106, Florida Statutes, but would review them once he was elected to office. (ROI Exhibit 10, page 1)
- 33. Respondent certified that the campaign's 2020 P1, 2020 P2, and 2020 TR reports were true, correct, and complete when they were not.

#### Alleged Violation: Section 106.19(1)(b), Florida Statutes

34. Complainant alleged that Respondent violated Florida's election laws by failing to report contributions required to be reported by Chapter 106, Florida Statutes, based upon an apparent deficit after the 2020 P1, 2020 P2, and 2020 TR reports were filed.

- 35. A subpoena was issued to Respondent's designated campaign depository to ascertain whether any contributions were received during the relevant reporting periods which were not reported.
- 36. An analysis of Respondent's 2020 P1 Report and relevant bank records shows that Respondent failed to disclose a contribution in the amount of \$300. (ROI Exhibit 6, pages 14-18; ROI Exhibit 7, pages 8-31; See ROI, p. 3, ¶20)
- 37. An analysis of Respondent's 2020 P2 Report and relevant bank records shows that Respondent failed to disclose a contribution in the amount of \$1,000. (ROI Exhibit 6, pages 20-24; ROI Exhibit 7, pages 8-31; See ROI, p. 3, \$\frac{9}{20}\$)
- 38. An analysis of Respondent's 2020 TR Report and relevant bank records shows that Respondent failed to disclose one or more cash contributions totaling \$600. (ROI Exhibit 6, pages 26-30; ROI Exhibit 7, pages 32-50; See ROI, p. 4, \$\quad 20\)
- 39. Respondent stated that the errors in his reports were related to not reporting the correct finances in the correct month. He stated that he has run for office since 1992. Respondent stated that he has not read the *Candidate and Campaign Treasurer Handbook* or Chapter 106, Florida Statutes, but would review them once he was elected to office. (ROI Exhibit 10, page 1)
- 40. Respondent failed to report contributions required to be reported by Chapter 106, Florida Statutes, on the campaign's 2020 P1, 2020 P2, and 2020 TR reports.

#### Alleged Violation: Section 106.19(1)(c), Florida Statutes

- 41. Complainant alleged that Respondent violated Florida's election laws by falsely reporting or deliberately failing to include information required by Chapter 106, Florida Statutes, based upon an apparent deficit after the 2020 P1, 2020 P2, and 2020 TR reports were filed.
- 42. A subpoena was issued to Respondent's designated campaign depository to ascertain whether any contributions were received, or expenditures were made during the relevant reporting periods which were not reported or falsely reported.
- 43. An analysis of Respondent's 2020 P1 Report and relevant bank records shows that Respondent failed to disclose a contribution in the amount of \$300 and an expenditure in the amount of \$17. (ROI Exhibit 6, pages 14-18; ROI Exhibit 7, pages 8-31; See ROI, p. 3, \$\frac{9}{20}\$)
- 44. An analysis of Respondent's 2020 P2 Report and relevant bank records shows that Respondent failed to disclose a contribution in the amount of \$1,000 and an expenditure in the amount of \$1,808.30. (ROI Exhibit 6, pages 20-24; ROI Exhibit 7, pages 8-31; See ROI, p. 3, ¶20)
- 45. An analysis of Respondent's 2020 TR Report and relevant bank records shows that Respondent failed to disclose one or more cash contributions totaling \$600 and seven expenditures totaling \$1,069 and disclosed two expenditures totaling \$200 that were not supported by bank records. (ROI Exhibit 6, pages 26-30; ROI Exhibit 7, pages 32-50; See ROI, p. 4, \$\quad 20\$)

- 46. Respondent stated that the errors in his reports were related to not reporting the correct finances in the correct month. He stated that he has run for office since 1992. Respondent stated that he has not read the *Candidate and Campaign Treasurer Handbook* or Chapter 106, Florida Statutes, but would review them once he was elected to office. (ROI Exhibit 10, page 1)
- 47. Chapter 106, Florida Statutes, requires candidates to report any contributions received and any expenditures made for the purpose of influencing the results of an election.
- 48. Respondent deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2020 P1, 2020 P2, and 2020 TR reports. Respondent falsely reported information required by Chapter 106, Florida Statutes, on the campaign's 2020 TR Report.
- 49. "Probable Cause" is defined as reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. *Schmitt v. State*, 590 So. 2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. *Department of Highway Safety and Motor Vehicles v. Favino*, 667 So. 2d 305, 309 (Fla. 1st DCA 1995).
- 50. The facts set forth above show that Respondent was a 2020 candidate for State Representative, District 108, and was acting as his own treasurer. Respondent failed to timely file the required amendments to the campaign's 2019 M11 and 2020 TR reports within 7 days of receiving notification from the Division that the reports were incomplete and required amendment. Respondent accepted a cash contribution in excess of \$50. The excessive cash contribution was correctly reported on the appropriate report. Respondent made or authorized an expenditure prohibited by Chapter 106, Florida Statutes, during the 2020 TR reporting period. Respondent certified that the campaign's 2020 P1, 2020 P2, and 2020 TR reports were true, correct, and complete when they were not. Respondent failed to report contributions required to be reported by Chapter 106, Florida Statutes, on the campaign's 2020 P1, 2020 P2, and 2020 TR reports. Respondent deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2020 TR Report.

Based upon these facts and circumstances, I recommend that the Commission find **probable cause** to charge Respondent with violating the following:

#### Count 1:

On or about May 7, 2021, Roy Hardemon violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2019 M11 Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

#### Count 2:

On or about May 7, 2021, Roy Hardemon violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2020 TR Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

#### Count 3:

On or about June 2, 2020, Roy Hardemon violated Section 106.09(1)(b), Florida Statutes, when he accepted a cash contribution in excess of \$50.

#### Count 4:

On or about June 24, 2020, Roy Hardemon violated Section 106.07(5), Florida Statutes, when he certified that the campaign's 2020 P1 Report was true, correct, and complete when it was not.

#### Count 5:

On or about July 6, 2020, Roy Hardemon violated Section 106.07(5), Florida Statutes, when he certified that the campaign's 2020 P2 Report was true, correct, and complete when it was not.

#### Count 6:

On or about November 17, 2020, Roy Hardemon violated Section 106.07(5), Florida Statutes, when he certified that the campaign's 2020 TR Report was true, correct, and complete when it was not.

#### Count 7:

On or about June 24, 2020, Roy Hardemon violated Section 106.19(1)(b), Florida Statutes, when he failed to report a contribution required to be reported by Chapter 106, Florida Statutes, on the campaign's 2020 P1 Report.

#### Count 8:

On or about July 6, 2020, Roy Hardemon violated Section 106.19(1)(b), Florida Statutes, when he failed to report a contribution required to be reported by Chapter 106, Florida Statutes, on the campaign's 2020 P2 Report.

#### Count 9:

On or about November 17, 2020, Roy Hardemon violated Section 106.19(1)(b), Florida Statutes, when he failed to report contributions required to be reported by Chapter 106, Florida Statutes, on the campaign's 2020 TR Report.

#### Count 10:

On or about June 24, 2020, Roy Hardemon violated Section 106.19(1)(c), Florida Statutes, when he deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2020 P1 Report.

#### Count 11:

On or about July 6, 2020, Roy Hardemon violated Section 106.19(1)(c), Florida Statutes, when he deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2020 P2 Report.

#### Count 12:

On or about November 17, 2020, Roy Hardemon violated Section 106.19(1)(c), Florida Statutes, when he deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2020 TR Report.

#### Count 13:

On or about November 17, 2020, Roy Hardemon violated Section 106.19(1)(c), Florida Statutes, when he falsely reported information required by Chapter 106, Florida Statutes, on the campaign's 2020 TR Report.

#### Count 14:

On or about August 24, 2020, Roy Hardemon violated Section 106.19(1)(d), Florida Statutes, when he made or authorized an expenditure prohibited by Chapter 106, Florida Statutes, during the 2020 TR reporting period.

#### **I. Preliminary Information:**

- 1. Respondent was a 2020 candidate for State Representative, District 108; he was defeated in the primary election held on August 18, 2020. Respondent was not a first-time candidate.
- 2. An Appointment of Campaign Treasurer and Designation of Campaign Depository (DS-DE 9) was filed on January 7, 2019. Respondent was appointed as campaign treasurer. To review the DS-DE 9, refer to Exhibit 1.1
- 3. Respondent filed a Statement of Candidate with the Division on January 7, 2019, in which Respondent certified he had been provided access to read and understand the requirements of Chapter 106, Florida Statutes. To review the Statement of Candidate, refer to Exhibit 2.
- 4. An acknowledgement letter was mailed to the address provided on the DS-DE 9 on January 8, 2019. The letter advised Respondent that all candidates filing reports with the Division are required to file by means of the Division's electronic filing system (EFS). Respondent was provided with a user identification number and initial password allowing access to the EFS.
- 5. The acknowledgement letter also advised Respondent that all of the Division's publications and reporting forms are available on their website, including Chapter 106, Florida Statutes, the *Candidate and Campaign Treasurer Handbook* and the *Calendar of Reporting Dates*. The letter further advised that it was Respondent's responsibility to read, understand, and follow the requirements of Florida's election laws. To review the acknowledgement letter, refer to Exhibit 3.

#### II. Alleged Violation of Section 106.07(2)(b)1., Florida Statutes:

6. I investigated whether Respondent violated this section of the election laws by failing to file amended report(s) for the following campaign treasurer report(s) after receiving notice from the filing officer: 2019 M11 and the 2020 TR.

- 7. The Division sent correspondence to the address provided on the DS-DE 9 notifying Respondent that one or more campaign treasurer report(s) were incomplete. The correspondence included error report(s) referencing the following report(s): 2019 M11 and 2020 TR. To review the correspondence and error report(s), refer to Exhibit 4.
- 8. On April 27, 2021, the Division sent a letter marked "Final Notice" with delivery confirmation to the address provided on the DS-DE 9 notifying Respondent that one or more campaign treasurer report(s) were incomplete. The letter included an error report referencing the following report(s): 2019 M11 and 2020 TR. It was confirmed delivered on April 30, 2021. To review the "Final Notice," error report and delivery confirmation, refer to Exhibit 5.
- 9. As noted above, the "Final Notice" was confirmed delivered on April 30, 2021. The Division filed the referral on June 24, 2021. By filing the referral, the Division affirmed that as of that date, the report(s) at issue had not been amended to correct all errors identified by the Division. To review the report(s) at issue, refer to Exhibit 6, pages 1-6 and 25-30.
  - 10. Respondent did not respond to the referral.

#### III. Alleged Violation of Sections 106.07(5) and 106.09(1)(b), Florida Statutes:

- 11. I investigated whether Respondent violated these sections of the election laws by certifying that the 2020 P1 report was true, correct, and complete when it was not, or by accepting a cash contribution in excess of the \$50.00 per campaign limit, based upon a contribution reported during the 2020 P1 reporting period.
- 12. Respondent filed the 2020 P1 report on June 24, 2020. By filing the report, Respondent certified it was true, correct, and complete. In the report, Respondent disclosed a cash contribution in the amount of \$500.00 from himself on June 2, 2020. To review the 2020 P1 report, refer to Exhibit 6, pages 13-18.
- 13. I subpoenaed bank records from the designated campaign depository. The June 2020 bank statement reflects that a \$500.00 deposit was made on June 2, 2020. The records included a deposit item showing that \$500.00 cash was deposited on that date, as reported by Respondent. To review the relevant bank records, refer to Exhibit 7, pages 8-9 and 20-23.
  - 14. Respondent did not respond to the referral.

#### IV. Alleged Violation of Section 106.19(1)(d), Florida Statutes:

- 15. I investigated whether Respondent violated this section of the election laws by making or authorizing one or more expenditures prohibited by Chapter 106, Florida Statutes.
- 16. The Division's Sum of Contributions vs. Expenditures report showed an apparent deficit balance in the following reporting periods: 2020 P1, 2020 P2 and 2020 TR. To review the report, refer to Exhibit 8.
- 17. I reviewed bank records from the designated campaign depository covering the following reporting periods: 2020 M5, 2020 P1, 2020 P2 and 2020 TR. There were four instances during that timeframe in which the campaign account balance was negative. To review the relevant bank records, refer to Exhibit 7, pages 1-4, 8-12, and 32-46.
  - On 8/24/20, a check expenditure of \$500.00 took the account to a -\$454.06 balance.
  - On 8/24/20, an overdraft fee of \$35.00 took the account to a -\$489.06 balance.
  - On 9/1/20, a monthly bank fee of \$17.00 took the account to a -\$506.06 balance.
  - On 10/1/20, a monthly bank fee of \$17.00 took the account to a -\$523.06 balance.
  - 18. Respondent did not respond to the referral.

# V. Alleged Violation of Sections 106.07(5), 106.19(1)(b), and 106.19(1)(c), Florida Statutes:

19. I investigated whether Respondent violated these sections of the election laws by certifying that one or more campaign treasurer report(s) were true, correct, and complete when they were not, failing to report one or more contribution(s), and falsely reporting or deliberately failing to include information in one or campaign treasurer report(s) due to an apparent deficit balance in the following reporting period(s): 2020 P1, 2020 P2 and 2020 TR.

20. I reviewed bank records from the designated campaign depository and compared them with campaign treasurer report(s) covering the following reporting period(s): 2020 M5, 2020 P1, 2020 P2 and 2020 TR.<sup>2</sup> The results of my review are reflected in the table below. On June 24, 2021, the Florida Elections Commission received a complaint alleging that you violated Florida's election laws. I have reviewed the complaint and find that it contains one or more legally sufficient allegations. The Commission staff will investigate the following alleged violations:

Section 106.07(2)(b)1., Florida Statutes: Respondent, a 2020 candidate for State Representative, District 108, acting as his own treasurer, failed to timely make necessary amendments to the 2019 M11 and 2020 TR reports, as alleged in the complaint.

**Section 106.07(5), Florida Statutes**: Respondent, a 2020 candidate for State Representative, District 108, may have certified the 2020 P1 campaign treasurer's report was true, correct, and complete when it was not, based on a reported cash contribution in excess of the \$50 per campaign limit, as alleged in the complaint.

Section 106.09(1)(b), Florida Statutes: Respondent, a 2020 candidate for State Representative, District 108, may have accepted a cash contribution in excess of the \$50 per campaign limit, based upon a contribution reported during the 2020 P1 reporting period, as alleged in the complaint.

Section 106.07(5), Florida Statutes: Respondent, a 2020 candidate for State Representative, District 108, may have certified one or more campaign treasurer's reports were true, correct, and complete when they were not, based upon an apparent deficit after the 2020 P1, 2020 P2, and 2020 TR reports were filed, as alleged in the complaint.

Section 106.19(1)(b), Florida Statutes: Respondent, a 2020 candidate for State Representative, District 108, may have failed to report one or more contributions required to be reported by Chapter 106, Florida Statutes, based upon an apparent deficit after the 2020 P1, 2020 P2, and 2020 TR reports were filed, as alleged in the complaint.

Section 106.19(1)(c), Florida Statutes: Respondent, a 2020 candidate for State Representative, District 108, may have falsely reported or deliberately failed to include information in one or more campaign treasurer's reports required by Chapter 106, Florida Statutes, based upon an apparent deficit after the 2020 P1, 2020 P2, and 2020 TR reports were filed, as alleged in the complaint.

Section 106.19(1)(d), Florida Statutes: Respondent, a 2020 candidate for State Representative, District 108, may have made or authorized one or more expenditures prohibited by Chapter 106, Florida Statutes, based upon an apparent deficit after the 2020 P1, 2020 P2, and 2020 TR reports were filed, as alleged in the complaint.

When we conclude the investigation, a copy of the Report of Investigation (ROI) will be mailed to you at the above address. Based on the results of the investigation, a staff attorney will prepare and present a written Staff Recommendation (SR) to the Commission as to whether there is probable cause to charge you, the Respondent, with violating Chapters 104 or 106, Florida Statutes. You will have an opportunity to respond to both the ROI and the SR. The Commission will then hold one or more hearings to determine whether the alleged violations occurred and, if so, the amount of the fine to be imposed upon you. Notice will be mailed to you and the Complainant at least 14 days before any hearing at which your case is to be considered.

Pursuant to Section 106.25(4)(i)3., Florida Statutes, the Commission may enter into a consent agreement with a Respondent to settle a complaint prior to a finding of probable cause. If you are interested in entering negotiations directed towards reaching a consent agreement to resolve this matter, please contact the Commission and request to speak with the attorney assigned to this case.

Please note that all documents related to this matter will be mailed to the above address unless you notify us of a new address.

Pursuant to Section 106.25, Florida Statutes, complaints, investigations, investigative reports, and other documents relating to an alleged violation of Chapters 104 or 106, Florida Statutes, are confidential until the Commission finds probable cause or no probable cause, unless the Respondent files a written waiver of confidentiality with the Commission. The confidentiality provision does not apply to the Complainant or the Respondent.

Should you retain counsel, your attorney must file a notice of appearance with the Commission before any member of the commission staff can discuss this case with him or her.
