**ORDER OF PROBABLE CAUSE**

**THIS MATTER** was heard by the Florida Elections Commission (Commission) at its regularly scheduled meeting on November 15, 2023, in Tallahassee, Florida.

On June 23, 2023, Staff recommended to the Commission that there was probable cause to believe that the Florida Election Code was violated. The facts articulated in Staff's Recommendation are adopted by reference and incorporated herein. Based on the Complaint, Report of Investigation, Staff's Recommendation, and oral statements (if any) made at the probable cause hearing, the Commission finds that there is **probable cause** to charge Respondent with the following violation(s):

**Count 1:**

On or about August 13, 2021, Erica Gayden violated Section 106.07(2)(b)1., Florida Statutes, when she failed to timely file an addendum to the campaign's 2021 TR Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

**NOTICE OF RIGHT TO A HEARING**

As the Respondent, you may elect to resolve this case in several ways. First, you may elect to resolve this case by consent order where you and Commission staff agree to resolve the violation(s) and agree to the amount of the fine. The consent order is then presented to the Commission for its approval. To discuss a consent order, contact the FEC attorney identified in the Order of Probable Cause.

Second, you may request an informal hearing held before the Commission, if you do not dispute any material fact in the Staff Recommendation. You have 30 days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to make written or oral arguments to the Commission concerning the legal issues related to the violation(s) and the potential fine. At the request of Respondent, the Commission will consider and determine willfulness at an informal hearing. Otherwise, live witness testimony is unnecessary.

Third, you may request a formal hearing held before an administrative law judge in the Division of Administrative Hearings (DOAH), if you dispute any material fact in the Staff Recommendation. You have 30 days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-

hand corner of the first page of the order. At the hearing, you will have the right to present evidence relevant to the violation(s) listed in this order, to cross-examine opposing witnesses, to impeach any witness, and to rebut the evidence presented against you.

If you do not elect to resolve the case by consent order or request a formal hearing at the DOAH or an informal hearing before the Commission within 30 days of the date this Order of Probable Cause is filed with the Commission, the case will be sent to the Commission for a formal or informal hearing, depending on whether the facts are in dispute. **STAFF RECOMMENDATION FOLLOWING INVESTIGATION**

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the referral in this case recommending that there is **probable cause** to charge Respondent with violating **Section 106.07(2)(b)1., Florida Statutes**. Based upon a thorough review of the Report of Investigation submitted on December 8, 2022, the following facts and law support this staff recommendation:

1. On August 20, 2021, the Florida Elections Commission (“Commission”) received a referral from the Department of State, Division of Elections (“Division” or “Complainant”), alleging that Erica Gayden (“Respondent”) violated Chapter 106, Florida Statutes.

2. Respondent was the treasurer for Tammyette Thomas, a 2020 candidate for State Representative, District 15. (ROI Exhibit 1)<sup>1</sup>

3. By letter dated September 14, 2022, the Executive Director notified Respondent that Commission staff would investigate the following statutory provision:

**Section 106.07(2)(b)1., Florida Statutes:** Respondent, treasurer for Tammyette Thomas, a 2020 candidate for State Representative, District 15, failed to timely make necessary amendments to the 2021 TR, as alleged in the complaint.

4. On October 30, 2019, Tammyette Thomas filed her Appointment of Campaign Treasurer and Designation of Campaign Depository for Candidates form (“DS-DE 9”) appointing Respondent as treasurer for her campaign. (ROI Exhibit 1)

5. By letter dated October 31, 2019, Krisi Reid Willis, Chief, Bureau of Election Records, sent Respondent a letter acknowledging that the Division had received Ms. Thomas’ DS-DE 9. (ROI Exhibit 2)

6. The acknowledgment letter advised Respondent that all candidates filing reports with the Division are required to use the electronic filing system (“EFS”) and provided Respondent with a user identification number and initial password to grant access to the EFS. The letter further advised Respondent that all of the Division’s publications and reporting forms were available on its website and directed Respondent to print out Chapter 106, Florida Statutes, and the *Calendar of Reporting Dates*, as well as other relevant documents. (ROI Exhibit 2)

7. Complainant alleged that the campaign's 2021 TR Report was incomplete when filed. *See Compl.*

8. The Division sent two letters notifying Respondent that the campaign's report was incomplete, and that Respondent was required to amend the report within 7 days of receipt of the notification. An Error Report showing why the report was incomplete was attached to each notification. (ROI Exhibits 3 & 4) It does not appear that the letter sent by U.S. First Class Mail nor the letter sent by Certified Mail was delivered to Respondent. (ROI Exhibit 3, page 1; ROI Exhibit 4, page 8)

9. The Division's records show that it contacted Respondent regarding the certified letter that was likely not delivered. A Division representative stated that they called Respondent and while on the telephone, emailed a copy of the letter to Respondent who responded to the email that she received it. (ROI Exhibit 6, page 2) The Division's records show an email from Daryl L. Howard regarding the certified letter to an email address associated with Ms. Thomas' campaign. The email was responded to as being received within three minutes of being sent. (ROI Exhibit 5, pages 1-2)

10. Respondent stated that this was her first time acting as a campaign treasurer. She stated that the report has been properly amended but that she could not recall when it was amended. (ROI Exhibit 8, page 1) The Division's records show that the last amendment to the report was made on July 16, 2021, prior to the referral filed in this matter. (ROI Exhibit 7, page 18) By filing the referral, the Division affirmed that as of August 20, 2021, the errors had not been amended. (ROI, p. 2, ¶8)

11. "Probable Cause" is defined as reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. *Schmitt v. State*, 590 So. 2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. *Department of Highway Safety and Motor Vehicles v. Favino*, 667 So. 2d 305, 309 (Fla. 1st DCA 1995).

12. The facts set forth above show that Respondent was the treasurer for Tammyette Thomas, a 2020 candidate for State Representative, District 15. Respondent failed to timely file the required amendment to the campaign's 2021 TR Report within 7 days of receiving notification from the Division that the report was incomplete and required amendment.

Based upon these facts and circumstances, I recommend that the Commission find **probable cause** to charge Respondent with violating the following:

**Count 1:**

On or about August 13, 2021, Erica Gayden violated Section 106.07(2)(b)1., Florida Statutes, when she failed to timely file an addendum to the campaign's 2021 TR Report within seven days

after receiving notice from the Department of State, Division of Elections, that the report required amendment.

Section 106.07(2)(b)1., Florida Statutes, failure of the treasurer for a candidate or political committee to file an addendum to an incomplete report after receiving notice from the filing officer.

**I. Preliminary Information:**

1. I investigated whether Respondent violated this section of the election laws by failing to file amended report(s) for the following campaign treasurer report(s) after receiving notice from the filing officer: 2021 TR.

2. An Appointment of Campaign Treasurer and Designation of Campaign Depository (DS-DE 9) was filed on October 30, 2019. Respondent was appointed as campaign treasurer for Tammyette Thomas, a 2020 candidate for State Representative, District 15. To review the DS-DE 9, refer to Exhibit 1.

3. On October 31, 2019, the Division sent Respondent a letter acknowledging Respondent's appointment as the campaign treasurer for Tammyette Thomas's campaign. The letter advised Respondent that all of the Division's publications and reporting forms are available on their website, including Chapter 106, Florida Statutes, the *Candidate and Campaign Treasurer Handbook*, and the *Calendar of Reporting Dates*. The letter further advised that it was Respondent's responsibility to read, understand, and follow the requirements of Florida's election laws. To review the acknowledgement letter, refer to Exhibit 2.

**II. Alleged Violation of Section 106.07(2)(b)(1), Florida Statutes:**

4. The Division sent correspondence to the address provided on the DS-DE 9 notifying Respondent that one or more campaign treasurer report(s) were incomplete. The correspondence included error report(s) referencing the following report(s): 2021 TR.<sup>1</sup> To review the correspondence and error report(s), refer to Exhibit 3.

5. On July 6, 2021, the Division sent a letter marked "Final Notice" with delivery confirmation to the address provided on the DS-DE 9 notifying Respondent that one or more campaign treasurer report(s) were incomplete. The letter included an error report referencing the following report(s): 2021 TR. No confirmation of delivery to Respondent through USPS was provided with the referral. Commission staff checked the certified number on the USPS tracking website, which did not provide confirmation of delivery to Respondent. To review the "Final Notice," error report and USPS delivery status information, refer to Exhibit 4.

<sup>1</sup> Although the letter is marked "Second Notice," it was the first notice sent to Respondent advising her that the 2021 TR was incomplete; the letter referenced a notice sent on March 25, 2021, but that notice did not address the 2021 TR. Regardless, the "Second Notice" was returned to the Division undelivered.

6. The referral included an email from Division staff dated August 6, 2021, attaching a copy of the “Final Audit Notice.” In the email, Division staff stated that the “Final Audit Notice” was being sent by email since the Division had not yet received USPS confirmation of delivery. However, although the email was addressed to Respondent, it was sent to an email address specified for Ms. Thomas on a DS-DE 9 she had filed appointing herself a deputy treasurer. The DS-DE 9 appointing Respondent as treasurer specified a different email address for Respondent. While someone replied and confirmed receipt of the Division email, the reply was not signed, and it does not appear that Respondent was copied on the reply. To review the email to Ms. Thomas and the DS-DE 9 appointing her deputy treasurer, refer to Exhibit 5.

7. Division records note that on August 4, 2021, Respondent called the Division and was told about an issue with the 2021 TR. Division records further note that on August 6, 2021, Division staff made phone contact with Respondent, emailed the “Final Audit Notice” during their conversation, and that Respondent replied acknowledging that she had received it. Division history notes show that Division staff had previously emailed Respondent at the address specified for her on the DS-DE 9 appointing her as treasurer, not the address specified for Ms. Thomas on the DS-DE 9 appointing Ms. Thomas as deputy treasurer. To review the Division records, refer to Exhibit 6.

8. As noted above, the “Final Notice” was emailed to Ms. Thomas’ email address on August 6, 2021. The Division filed the referral on August 20, 2021. By filing the referral, the Division affirmed that as of that date, the report(s) at issue had not been amended to correct all errors identified by the Division. To review the report(s) at issue, refer to Exhibit 7.

9. Respondent did not respond to the referral.

10. On September 15, 2022, I called Respondent for the purpose of providing an opportunity to discuss the allegations made in the referral. Respondent advised that this was the first time she has worked in an election campaign. She acknowledged that she had read Chapter 106, Florida Statutes, and the *Candidate and Campaign Treasurer Handbook*. Respondent stated she contacted the Division for assistance, and she asserted that the report had been properly amended, though she could not recall the exact date. To review the phone log, refer to Exhibit 8.

On August 20, 2021, the Florida Elections Commission received a complaint alleging that you violated Florida's election laws. I have reviewed the complaint and find that it contains one or more **legally sufficient allegations**. The Commission staff will investigate the following alleged violation:

**Section 106.07(2)(b)1., Florida Statutes:** Respondent, treasurer for Tammyette Thomas, a 2020 candidate for State Representative, District 15, failed to timely make necessary amendments to the 2021 TR, as alleged in the complaint.

When we conclude the investigation, a copy of the Report of Investigation (ROI) will be mailed to you at the above address. Based on the results of the investigation, a staff attorney will prepare and present a written Staff Recommendation (SR) to the Commission as to whether there is probable cause to charge you, the Respondent, with violating Chapters 104 or 106, Florida Statutes. You will have an opportunity to respond to both the ROI and the SR. The Commission will then hold one or more hearings to determine whether the alleged violation occurred and, if so, the amount of the fine to be imposed upon you. Notice will be mailed to you and the Complainant at least 14 days before any hearing at which your case is to be considered.

Pursuant to Section 106.25(4)(i)3., Florida Statutes, the Commission may enter into a consent agreement with a Respondent to settle a complaint prior to a finding of probable cause.
