NOTICE OF HEARING (AUTOMATIC FINE (AF))

A hearing will be held in this case before the Florida Elections Commission on, **April 22, 2026 at 10:00 a.m.**, or as soon thereafter as the parties can be heard, at the following location: via Webinar at: **Registration URL** <https://attendee.gotowebinar.com/register/17181422935246175>, **Webinar ID 325-697-827**.

Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

If you are the Respondent, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

If you are the Complainant, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

If you are an Appellant, and you have requested a hearing, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

Please refer to the information below for further instructions related to your particular hearing:

If this is a hearing to consider an **appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

SUMMARY: The Honorable Christine (Chris) Hoffman was a candidate for the City of Jacksonville Beach Mayor in the 2024 elections. Mayor Hoffman was her own treasurer.

Mayor Hoffman is appealing the fine, claiming that she was unable to submit the report via the e-filing system after multiple attempts. According to Mayor Hoffman, she informed the City Clerk's office about the issue and received suggestions that did not resolve the problem. She mentions that she discovered the error the following day and subsequently submitted the report. Ms. Hoffman emphasizes that this is her first and only issue regarding campaign reporting. She is requesting a waiver or reduction of the fine based on the circumstances surrounding the situation.

- The 2024 G6 Original Report covers the period from 10/19/24-10/31/24; it was due on 11/01/24.
- The 2024 G6 Original Report shows that it was filed on 11/02/24.
- Mayor Hoffman reported receiving 8 contributions, while making 13 expenditures.
- The Jacksonville Beach City Clerk's office provided emails that pertain to Mayor Hoffman's 2024 G6 report. On 11/01/24, Ms. Hoffman sent an email to the Clerk titled "Trying to file report". She also included a screenshot of the error message in the email.

Please accept this letter as an appeal request for the fine I received pursuant to a late filing of my campaign treasurer's report during the 2024 election cycle.


The report was due on November 1 and I filed it less than 24 hours late. This is my fourth campaign and my first violation so I would request leniency on the \$500 fine.

I was unable to submit via the e-filing system that the City of Jacksonville Beach uses and tried multiple browsers to no avail. I alerted the Clerk's Office to the issue. They suggested I submit the "preview" report screen as a PDF but I was not even able to get to that point in the system. All information had been input, I could just not complete the filing.

I was able to try the next day, found my error, and submitted my report.

I take responsibility for the fact that my missing the "end date" on the report period was what caused the delay in my being able to submit. But given this is a first and only issue with campaign reporting, I humbly request this fine to be dismissed or reduced.

Penalty for late filing

Any candidate or committee failing to file a report on the designated due date shall be subject to a fine of \$50 per day for the first 3 days late and, thereafter, \$500 per day for each late day, not to exceed 25% of the total contributions or expenditures, whichever is greater, for the period covered by the late report. However, for reports immediately preceding an election, the fine shall be \$500 per day for each late day not to exceed 25% of the total contributions or expenditures, whichever is greater, for the period covered by the late report.

For Termination Reports the fine is \$50 per day for each late day, not to exceed 25% of the total contributions or expenditures, whichever is greater, for the period covered by the late report.

Candidates must dispose of all funds in the campaign account and file a Termination Report within 90 days after having withdrawn, becoming unopposed, eliminated, or elected to office.
