ORDER OF PROBABLE CAUSE

On or about February 10, 2022, Peace River Valley Citrus Growers Association PAC violated Section 106.07(7), Florida Statutes, when it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2022 M1 Report.

Count 2:

On or about April 11, 2022, Peace River Valley Citrus Growers Association PAC violated Section 106.07(7), Florida Statutes, when it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2022 M3 Report.

Count 3:

On or about May 10, 2022, Peace River Valley Citrus Growers Association PAC violated Section 106.07(7), Florida Statutes, when it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2022 M4 Report.

Count 4:

On or about June 10, 2022, Peace River Valley Citrus Growers Association PAC violated Section 106.07(7), Florida Statutes, when it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2022 M5 Report.

Count 5:

On or about June 24, 2022, Peace River Valley Citrus Growers Association PAC violated Section 106.07(7), Florida Statutes, when it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2022 P1 Report.

Count 6:

On or about July 1, 2022, Peace River Valley Citrus Growers Association PAC violated Section 106.07(7), Florida Statutes, when it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2022 P1A Report.

Count 7:

On or about July 8, 2022, Peace River Valley Citrus Growers Association PAC violated Section 106.07(7), Florida Statutes, when it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2022 P2 Report.

Count 8:

On or about July 15, 2022, Peace River Valley Citrus Growers Association PAC violated Section 106.07(7), Florida Statutes, when it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2022 P2A Report.

Count 9:

On or about July 29, 2022, Peace River Valley Citrus Growers Association PAC violated Section 106.07(7), Florida Statutes, when

it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2022 P4 Report.

Count 10:

On or about August 5, 2022, Peace River Valley Citrus Growers Association PAC violated Section 106.07(7), Florida Statutes, when it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2022 P5 Report.

NOTICE OF RIGHT TO A HEARING

As the Respondent, you may elect to resolve this case in several ways. First, you may elect to resolve this case by <u>consent order</u> where you and Commission staff agree to resolve the violation(s) and agree to the amount of the fine. The consent order is then presented to the Commission for its approval. To discuss a consent order, contact the FEC attorney identified in the Order of Probable Cause.

Second, you may request an <u>informal hearing</u> held before the Commission, if you <u>do not</u> dispute any material fact in the Staff Recommendation. You have 30 days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to make written or oral arguments to the Commission concerning the legal issues related to the violation(s) and the potential fine. At the request of Respondent, the Commission will consider and determine willfulness at an informal hearing. Otherwise, live witness testimony is unnecessary.

Third, you may request a <u>formal hearing</u> held before an administrative law judge in the Division of Administrative Hearings (DOAH), if you dispute any material fact in the Staff

Recommendation. You have 30 days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to present evidence relevant to the violation(s) listed in this order, to cross-examine opposing witnesses, to impeach any witness, and to rebut the evidence presented against you.

STAFF RECOMMENDATION FOLLOWING INVESTIGATION

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the referral in this case recommending that there is **probable cause** to charge Respondent with violating **Section 106.07(7)**, **Florida Statutes**. Based upon a thorough review of the Report of Investigation submitted on February 28, 2023, the following facts and law support this staff recommendation:

- 1. On September 14, 2022, the Florida Elections Commission ("Commission") received a referral from the Department of State, Division of Elections ("Division" or "Complainant"), alleging that Peace River Valley Citrus Growers Association PAC ("Respondent") violated Chapter 106, Florida Statutes.
 - 2. Respondent is a political committee registered with the Division. (ROI Exhibit 1)¹
- 3. By letter dated January 6, 2023, the Executive Director notified Respondent that Commission staff would investigate the following statutory provision:

Section 106.07(7), Florida Statutes: As alleged in the complaint, Respondent, a political committee registered with the Division of Elections, failed to notify the filing officer on the prescribed reporting date that no report would be filed on that date because it had not received funds, made contributions, or expended reportable funds during the following reporting periods:

- 2022 M1
- 2022 M3
- 2022 M4
- 2022 M5
- 2022 P1
- 2022 P1A
- 2022 P2
- 2022 P2A
- 2022 P4
- 2022 P5

¹ The Report of Investigation is referred to herein as "ROI."

- 4. By letter dated April 19, 2018, Kristi Reid Willis, Chief, Bureau of Election Records, sent Respondent's chairperson and treasurer a letter acknowledging that the Division had received its Appointment of Campaign Treasurer and Designation of Campaign Depository for Political Committees form. (ROI Exhibit 2)
- 5. The acknowledgment letter advised Respondent that all of the Division's publications and reporting forms were available on its website and directed Respondent to print out the *Calendar of Reporting Dates* as well as other relevant documents. (ROI Exhibit 2)
- 6. Pursuant to Section 106.07(7), Florida Statutes, in any reporting period during which a political committee has not received funds, made any contributions, or expended any reportable funds, the filing of the required report for that period is waived. However, the political committee is required to notify the filing officer in writing on the prescribed reporting date that no report is being filed on that date.
- 7. The *Political Committee Handbook* references the statutory requirement regarding written notification and directs political committees to notify the Division by way of the Division's electronic filing system. (ROI Exhibit 3, page 2) The *Political Committee EFS User's Guide* shows the process through which to notify the Division. The user's guide instructs political committees to select the relevant reporting period and place a checkmark in a box titled "Waiver" to indicate the lack of reportable financial activity. (ROI Exhibit 4, page 2)
- 8. Respondent failed to notify the filing officer on the prescribed reporting dates that no reports would be filed for the following reporting periods, as set forth in the table below. (ROI Exhibit 5, page 1)

- 9. Emma Keller, Acting Executive Director for Respondent, stated that the previous executive director, Kate Shaw, did not provide any information to the Division to update their records, nor did she provide passwords necessary to log into various websites. As to why the relevant notices were not timely filed, Ms. Keller stated that it was thought that the previous executive director had reporting under control. (ROI Exhibit 6, pages 1 & 2)
- 10. Roy Petteway, Former President for Respondent, confirmed that the former executive director did not update records nor maintain reporting requirements with the Division. (ROI Exhibit 6, pages 1 & 2)
- 11. "Probable Cause" is defined as reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. *Schmitt v. State*, 590 So. 2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. *Department of Highway Safety and Motor Vehicles v. Favino*, 667 So. 2d 305, 309 (Fla. 1st DCA 1995).
- 12. The facts set forth above show that Respondent is a political committee registered with the Division. Respondent failed to notify the filing officer on the prescribed reporting dates that no reports would be filed for the following reporting periods: 2022 M1, 2022 M3, 2022 M4, 2022 M5, 2022 P1, 2022 P1A, 2022 P2, 2022 P2A, 2022 P4, and 2022 P5.

Based upon these facts and circumstances, I recommend that the Commission find probable cause to charge Respondent with violating the following:

Count 1:

On or about February 10, 2022, Peace River Valley Citrus Growers Association PAC violated Section 106.07(7), Florida Statutes, when it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2022 M1 Report.

Count 2:

On or about April 11, 2022, Peace River Valley Citrus Growers Association PAC violated Section 106.07(7), Florida Statutes, when it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2022 M3 Report.

Count 3:

On or about May 10, 2022, Peace River Valley Citrus Growers Association PAC violated Section 106.07(7), Florida Statutes, when it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2022 M4 Report.

Count 4:

On or about June 10, 2022, Peace River Valley Citrus Growers Association PAC violated Section 106.07(7), Florida Statutes, when it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2022 M5 Report.

Count 5:

On or about June 24, 2022, Peace River Valley Citrus Growers Association PAC violated Section 106.07(7), Florida Statutes, when it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2022 P1 Report.

Count 6:

On or about July 1, 2022, Peace River Valley Citrus Growers Association PAC violated Section 106.07(7), Florida Statutes, when it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2022 P1A Report.

Count 7:

On or about July 8, 2022, Peace River Valley Citrus Growers Association PAC violated Section 106.07(7), Florida Statutes, when it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2022 P2 Report.

Count 8:

On or about July 15, 2022, Peace River Valley Citrus Growers Association PAC violated Section 106.07(7), Florida Statutes, when it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2022 P2A Report.

Count 9:

On or about July 29, 2022, Peace River Valley Citrus Growers Association PAC violated Section 106.07(7), Florida Statutes, when it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2022 P4 Report.

Count 10:

On or about August 5, 2022, Peace River Valley Citrus Growers Association PAC violated Section 106.07(7), Florida Statutes, when

it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2022 P5 Report.

I. Preliminary Information:

1. Respondent is a political committee registered with the Division.

- 2. An Appointment of Campaign Treasurer and Designation of Campaign Depository (DS-DE 6) was filed on September 4, 1998.¹ On April 17, 2018, a DS-DE 6 was filed appointing Lynn Shelfer as campaign treasurer. To review the DS-DE 6, refer to Exhibit 1.
- 3. An acknowledgement letter was mailed to the address provided on the DS-DE 6 on April 19, 2018, advising Respondent that all political committees filing reports with the Division are required to file by means of the Division's electronic filing system (EFS). Respondent was provided with a new user identification number and password allowing access to the EFS.
- 4. The acknowledgement letter also advised Respondent that all the Division's publications and reporting forms are available on their website, including Chapter 106, Florida Statutes, the *Political Committee Handbook*, and the *Calendar of Reporting Dates*. The letter further advised that it was Respondent's responsibility to read, understand, and follow the requirements of Florida's election laws. To review the acknowledgement letter, refer to Exhibit 2.
- 5. The *Political Committee Handbook* discusses filing a waiver when there is no activity to disclose. To review the relevant page of the *Handbook*, refer to Exhibit 3.
- 6. The *Political Committee EFS User's Guide* discusses how to notify the Division on the prescribed reporting date that no report will be filed using the EFS. Specifically, the *EFS User's Guide* instructs the user to click the box next to "waiver" if there is no activity to disclose. To review the relevant page(s) from the *EFS User's Guide*, refer to Exhibit 4.

II. Alleged Violation of Section 106.07(7), Florida Statutes:

7. I investigated whether Respondent violated this section of the election laws by not timely notifying the filing officer, in writing, that no report(s) would be filed due to not receiving any contributions or making expenditures during the following reporting period(s). To review Respondent's filing history reflecting the untimely filed notifications summarized below, refer to Exhibit 5.

Ms. Keller also stated that she was not provided login credentials, passwords, or access to the Division's website when she became Executive Director in August 2022, and she did not know how to file or update records with the Division of Elections. She provided Commission staff with the number for Roy Petteway, the previous President of the Peace River Valley Citrus Growers Association. Commission staff called the number, and Mr. Petteway stated that Kate Shaw, who was Executive Director from approximately 2018 until early-to-mid 2022, was believed to have been reporting and updating records with the Division of Elections, but it was discovered that she had not. Unless the electronic filing requirements of Section 106.0705, Florida Statutes, apply, reports shall be filed no later than 5 p.m. of the day designated. A report postmarked by the U.S. Postal Service no later than midnight of the day designated is deemed timely filed. A report received by the filing officer within 5 days after the designated due date that was delivered by the U.S. Postal Service is deemed timely filed unless it has a postmark indicating the report was mailed after the designated due date. A certificate of mailing obtained from and dated by the U.S. Postal Service at the time of mailing or a receipt from an established courier company, which bears a date on or before the date on which the report is due, is proof of mailing in a timely manner.

Reports filed with the Division through the <u>Electronic Filing System (EFS)</u> are due no later than midnight, Eastern Time, of the due date. (See <u>Chapter 11</u>, <u>Electronic Filing of Campaign Reports</u>.)

(Sections 106.07, 106.0705, and 106.141, F.S.)

Penalty for Late Filing

Any political committee failing to file a report on the designated due date shall be subject to a fine of \$50 per day for the first three days late and, thereafter, \$500 per day for each late day, not to exceed 25 percent of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for the reports due immediately prior to the primary and general elections, the fine shall be \$500 per day for each late day, not to exceed 25 percent of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

(Section 106.07(8), F.S.)

Notice of No Activity

When there has been no reportable activity in the campaign account during a reporting period (no funds expended or received) the filing of the report is waived. The political committee shall notify the filing officer in writing on or before the prescribed reporting date that no report is being filed on that date. The next report filed must specify that the report covers the entire period between the last submitted report and the report being filed.

(Section <u>106.07</u>, F.S.)

A notice of no activity filed with the Division must be filed electronically using the Division's electronic filing system.

(Section <u>106.0705</u>, F.S.)

Special Election Reports


When a special election is called to fill a vacancy in office, all political committees making contributions or expenditures to influence the results of the special election shall file campaign treasurers' reports with the filing officer on the dates set by the Department of State pursuant to Section 100.111, F.S.

When an election is called for an issue to appear on the ballot at a time when no candidates are scheduled to appear on the ballot, all political committees making contributions or expenditures in support of or in opposition to such issue shall file reports on the 18th and 4th days prior to such election.
