If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing*. The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

SUMMARY: Robert "Bob" Larrivee is a candidate for State Representative, District 57 in the 2024 elections. Mr. Larrivee was his own treasurer. Linda C. Larrivee is the current treasurer.

Robert "Bob" Larrivee is appealing the fine, claiming he encountered technical difficulties filing the report. According to Mr. Larrivee, he contacted the support line for EFS and received help submitting the report. He notes that he was a first-time candidate and had "navigation issues" with the system. He requests a waiver of the fine due to the circumstances.

- The 2024 Q2 Original Report covers the period from 04/01/24-05/31/24; it was due on 06/10/24.
- The 2024 Q2 Queued Transaction Report shows that it was created on 05/03/24 and filed on 06/17/24. The report was amended on 06/21/24. After amending Total contributions: two totaling \$2,100; total expenditures: four totaling \$121.90.
- Robert "Bob" Larrivee reported receiving 2 contributions, while making 4 expenditures.
- The Division of Elections does not have any notes that pertain to Robert "Bob" Larrivee's 2024 Q2 report.

PRIOR CASES: None.

To Donna S. Brown, Chief, Bureau of Election Records:

I am writing to formally appeal the recent \$500.00 fine assessment for late filing of my report for June 10, 2024. I am just now aware of this and the notifications that this had occurred. I received a letter via U.S. mail informing me of this on Saturday July 6, 2024, and it was the first I had seen this notification. I was not previously made aware but now know to look in the Candidate section for the Elections Commission, where I found electronic copies of the notification letters.

As an NPA Candidate, and first-time entrant into politics, I do not enjoy the luxury of a team working with me on my campaign efforts. I therefore serve as both candidate and Treasurer. When attempting to file the report prior to the deadline, I encountered technical and navigation issues and could not work my way past them. I subsequently contacted the support line for EFS, and the helpdesk personnel walked me through the process to make appropriate corrections finally bringing me to the point of submission on June 17, 2024. When we completed this call, I was assured everything was now proper.

I have since filed my P2 report, contacted the EFS support line again to ensure I had done it correctly, and then contacted the Division of Elections support line where confirmation was validated. I now have located and downloaded a calendar of future due dates to remind me of the deadlines and keep me on track.

I understand the need for these reports and am doing all I can to comply. I feel more confident in relation to the EFS, have the printed and digital calendars for reminders of the deadlines, and will make every effort to meet those deadlines by the due dates.

I know it is my responsibility and admit that I had problems in the beginning. I am trying to learn and complete the required actions to be a successful candidate. I respectfully request removal of the fine in this instance. If there is anything additional you need from me, I will work to provide it in a timely manner.

Dear Mr. Larrivee:

Our records indicate that you have not filed either your campaign treasurer's report or notification that no reportable activity occurred, whichever is applicable. The filing date was June 10, 2024.

The law (s. 106.07(8)(b), Fla. Stat.) requires the filing officer to immediately notify you about the missed filing date and the automatic fines that will be assessed for late filing of a report, if a report was due.

- If reportable activity occurred and you have not filed a report, statutory fines are automatically assessed as follows until you file your report:
 - \$50 per day for the first 3 days late
 - \$500 per day for each day after the 3rd day late
 - * If the required report immediately precedes a primary and general election, the automatic fine is \$500 for each late day.

The total fine for the untimely report cannot exceed 25% of the total receipts or expenditures, whichever is greater, for the cover period. Even if you end up filing your report late, we cannot waive the statutory fines. We will notify you of the specific amount of fines owed once you file your report. You have 20 days from the day you receive the notice to pay the fine or to appeal the fine to the Florida Elections Commission.

• If no reportable activity occurred for the report date(s), you are still required to notify us in writing, via the Division's Electronic Filing System, that no reportable activity occurred. No automatic fines are statutorily assessed.

However, in all cases, failure to file and/or untimely filing of a report of reportable activity, or if applicable, a notice that no reportable activity occurred, may constitute an apparent violation of chapter 106, Fla. Stat. If we refer such matter to the Florida Elections Commission, the Commission may subsequently impose a civil penalty for each violation under chapter 106.265(1), Fla. Stat.
