**ORDER OF PROBABLE CAUSE**

THIS MATTER was heard by the Florida Elections Commission (Commission) at its regularly scheduled meeting on May 17, 2022, in Tallahassee, Florida.

On March 28, 2022, Staff recommended to the Commission that there was probable cause to believe that the Florida Election Code was violated. The facts articulated in Staff's Recommendation are adopted by reference and incorporated herein. Based on the Complaint, Report of Investigation, Staff's Recommendation, and oral statements (if any) made at the probable cause hearing, the Commission finds that there is **probable cause** to charge Respondent with the following violation(s):

**Count 1:**

On or around November 26, 2018, Jeffrey Duane Porter violated Section 106.19(1)(c), Florida Statutes, when he deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2018 Termination Report.

The Commission finds that there is **no probable cause** to charge Respondent with violating Sections 106.07(5), and 106.141(1), Florida Statutes.

#### **NOTICE OF RIGHT TO A HEARING**

As the Respondent, you may elect to resolve this case in several ways. First, you may elect to resolve this case by consent order where you and Commission staff agree to resolve the violation(s) and agree to the amount of the fine. The consent order is then presented to the Commission for its approval. To discuss a consent order, contact the FEC attorney identified in the Order of Probable Cause.

Second, you may request an informal hearing held before the Commission, if you do not dispute any material fact in the Staff Recommendation. You have 30 days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to make written or oral arguments to the Commission concerning the legal issues related to the violation(s) and the potential fine. At the request of Respondent, the Commission will consider and determine willfulness at an informal hearing. Otherwise, live witness testimony is unnecessary.

Third, you may request a formal hearing held before an administrative law judge in the Division of Administrative Hearings (DOAH), if you dispute any material fact in the Staff Recommendation. You have 30 days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to present evidence relevant to the violation(s) listed in this order, to cross-examine opposing witnesses, to impeach any witness, and to rebut the evidence presented against you.

If you do not elect to resolve the case by consent order or request a formal hearing at the DOAH

or an informal hearing before the Commission within 30 days of the date this Order of Probable Cause is filed with the Commission, the case will be sent to the Commission for a formal or informal hearing, depending on whether the facts are in dispute. The date this order was filed appears in the upper right-hand corner of the first page of the order.

**STAFF RECOMMENDATION FOLLOWING INVESTIGATION**

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the referral in this case recommending that there is **probable cause** to charge Respondent with violating **Section 106.19(1)(c), Florida Statutes**, and **no probable cause** to charge Respondent with violating **Sections 106.07(5), and 106.141(1), Florida Statutes**. Based upon a thorough review of the Report of Investigation submitted on March 4, 2022, the following facts and law support this staff recommendation:

1. On March 26, 2019, the Florida Elections Commission (“Commission”) received a referral from the Department of State, Division of Elections (“Division”), alleging that Jeffrey Duane Porter (“Respondent”) violated Chapter 106, Florida Statutes.
2. Respondent was a 2018 candidate for Commissioner of Agriculture. Respondent’s Statement of Candidate form (“DS-DE 84”) was filed on January 30, 2018. (ROI Exhibit 2)<sup>1</sup>
3. By letter dated May 17, 2019, the Executive Director notified Respondent that Commission staff would investigate the following statutory provisions:

**Section 106.07(5), Florida Statutes:** Respondent, a 2018 candidate for Commissioner of Agriculture, may have certified one or more campaign treasurer reports were true, correct, and complete when they were not, as alleged in the complaint.

**Section 106.141(1), Florida Statutes:** Respondent, a 2018 candidate for Commissioner of Agriculture, filed a 2018 Termination Report that may have failed to accurately reflect the disposition of all remaining campaign funds.

**Section 106.19(1)(c), Florida Statutes:** Respondent, a 2018 candidate for Commissioner of Agriculture, may have falsely reported or deliberately failed to include information in one or more campaign treasurer reports, as required by Chapter 106, as alleged in the complaint.

4. On January 30, 2018, Respondent filed his Appointment of Campaign Treasurer and Designation of Campaign Depository for Candidates form (“DS-DE 9”) appointing Olga Yount as treasurer for his campaign. (ROI Exhibit 1)

5. By letter dated January 31, 2018, Kristi Reid Willis, Chief, Bureau of Election Records, sent Respondent a letter acknowledging that the Division had received his DS-DE 9 and that his name was placed on the 2018 active candidate list. (ROI Exhibit 3, page 1)

6. The acknowledgment letter advised Respondent that all candidates filing reports with the Division are required to use the electronic filing system (“EFS”), and provided Respondent with a user identification number and initial password to grant access to the EFS. (ROI Exhibit 3, page 1) The letter further advised Respondent that all of the Division’s publications and reporting forms were available on its website and directed Respondent to print out Chapter 106, Florida Statutes, and the *Calendar of Reporting Dates*, as well as other relevant documents. (ROI Exhibit 3, page 2)

#### **Alleged Violation: Section 106.141(1), Florida Statutes**

7. Complainant alleged that Respondent violated Florida’s election laws by failing to dispose of the funds on deposit in his campaign account. *See Compl.*, pp. 10-11.

8. On August 28, 2018, Respondent was defeated in the 2018 primary election. (ROI, p. 1, ¶ 1) Respondent was required to dispose of the funds on deposit in his campaign account within 90 days after being eliminated as a candidate.

9. A subpoena was issued to Respondent’s designated campaign depository. The campaign’s bank records show that Respondent had a zero balance as of the last day of the 2018 termination reporting period, i.e., November 26, 2018. (ROI Exhibit 5, page 10)

10. It does not appear that Respondent failed to dispose of the funds on deposit in his campaign account within 90 days after being eliminated as a candidate.

#### **Alleged Violation: Section 106.07(5), Florida Statutes**

11. Complainant alleged that Respondent violated Florida’s election laws by certifying that the campaign’s 2018 Termination Report was true, correct, and complete when it was not.

12. The campaign notified the filing officer in writing that it would not be filing its 2018 Termination Report. (ROI Exhibit 6, page 1) The requirement under Section 106.07(5), Florida Statutes, to certify as to the correctness of a report does not apply to notifications of no activity submitted to the filing officer pursuant to Section 106.07(7), Florida Statutes.

13. It does not appear that Respondent certified that the campaign’s 2018 Termination Report was true, correct, and complete when it was not as Respondent did not file a report but rather submitted a notice of no activity pursuant to section 106.07(7), Florida Statutes.

### **Alleged Violation: Section 106.19(1)(c), Florida Statutes**

14. Complainant alleged that Respondent violated Florida's election laws by falsely reporting or deliberately failing to include information required by Chapter 106, Florida Statutes, on the campaign's 2018 Termination Report. The reporting period at issue ran from September 1, 2018, through November 26, 2018.

15. A subpoena was issued to Respondent's designated campaign depository to ascertain whether any contributions were received or expenditures were made during the relevant reporting period which were not reported or falsely reported.

16. The campaign's bank records show that Respondent failed to disclose \$4,235.01 in financial activity consisting of nine expenditures totaling \$2,513.54, and four charge-off credits from the financial institution totaling \$1,721.47. (ROI Exhibit 5) With regard to Respondent's deliberate failure to include information on the campaign's report, he may have failed to disclose the campaign's financial activity as the funds were not disposed of properly pursuant to sections 106.141(4)(a), and 106.11(5), Florida Statutes, but were spent at a car rental company, and as the campaign account was overdrawn in violation of section 106.11(4), Florida Statutes. Respondent did not file the campaign's 2018 Termination Report but rather notified his filing officer that he had no financial activity during the relevant reporting period. Respondent was not a first-time candidate. (ROI, p. 1, ¶ 1)

17. Respondent was given multiple opportunities to respond to Commission staff's investigation, but failed to do so. (ROI, page 3, ¶¶11-12; ROI Exhibit 7)

18. Chapter 106, Florida Statutes, requires candidates to report any contributions received and any expenditures made for the purpose of influencing the results of an election. Respondent deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2018 Termination Report.

19. "Probable Cause" is defined as reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. *Schmitt v. State*, 590 So. 2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. *Department of Highway Safety and Motor Vehicles v. Favino*, 667 So. 2d 305, 309 (Fla. 1st DCA 1995).

20. The facts set forth above show that Respondent was a 2018 candidate for Commissioner of Agriculture. It does not appear that Respondent failed to dispose of the funds on deposit in his campaign account within 90 days after being eliminated as a candidate. It does not appear that Respondent certified that the campaign's 2018 Termination Report was true, correct, and complete when it was not. Respondent deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2018 Termination Report.


Based upon these facts and circumstances, I recommend that the Commission find **no**

**probable cause** to charge Respondent with violating **Sections 106.07(5), and 106.141(1), Florida Statutes**, and find **probable cause** to charge Respondent with violating the following:

**Count 1:**

On or around November 26, 2018, Jeffrey Duane Porter violated Section 106.19(1)(c), Florida Statutes, when he deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2018 Termination Report.

## Report of Investigation for Apparent Surplus in Campaign Account

### Case Number: FEC 19-196

Section 106.141(1), Florida Statutes, failure of a candidate to dispose of funds remaining in the campaign account within 90 days after the candidate withdrew, became unopposed, was eliminated, or elected and to file a termination report (TR) reflecting the disposition of all remaining funds.

Sections 106.07(5) and 106.19(1)(c), Florida Statutes, a candidate certified campaign treasurer report(s) as true, correct, and complete when they were not and falsely reported or deliberately failed to include all information required by Chapter 106, F.S., in campaign treasurer report(s).

### I. Preliminary Information:

1. Respondent was a 2018 candidate for Commissioner of Agriculture; he was eliminated in the primary election held on August 28, 2018. Respondent was not a first-time candidate.
2. An Appointment of Campaign Treasurer and Designation of Campaign Depository (DS-DE 9) was filed on January 30, 2018. Olga Yount was appointed as campaign treasurer. To review the DS-DE 9, refer to Exhibit 1.
3. Respondent filed a Statement of Candidate with the Division on January 30, 2018, in which Respondent certified he had been provided access to read and understand Chapter 106, F.S. To review the Statement of Candidate, refer to Exhibit 2.
4. An acknowledgement letter was mailed to the address provided on the DS-DE 9 on January 31, 2018. The letter advised Respondent that all candidates filing reports with the Division are required to file by means of the Division's electronic filing system (EFS). Respondent was provided with a user identification number and initial password allowing access to the EFS.
5. The acknowledgement letter also advised Respondent that all of the Division's publications and reporting forms are available on their website, including Chapter 106, Florida Statutes, the *Candidate and Campaign Treasurer Handbook* and the *Calendar of Reporting Dates*. The letter further advised that it was Respondent's responsibility to read, understand, and follow the requirements of Florida's election laws. To review the acknowledgement letter, refer to Exhibit 3.

### II. Alleged Violation of Section 106.141(1), Florida Statutes:

6. I investigated whether Respondent violated this section of the election laws by not disposing of all remaining campaign funds within 90 days of being eliminated. To review Respondent's filing history, refer to Exhibit 4.

7. On the date the 2018 TR was due, campaign account records reflect that the balance was \$0.00.<sup>1</sup> To review the relevant bank statement, refer to Exhibit 5, page 10.

8. Respondent did not respond to the referral.

### **III. Alleged Violation of Sections 106.07(5), 106.141(1), and 106.19(1)(c), Florida Statutes:**

9. I investigated whether Respondent violated these sections of the election laws by certifying that one or more campaign treasurer report(s) were true, correct, and complete when they were not, falsely reporting or deliberately failing to include information in one or campaign treasurer report(s), and by failing to accurately reflect disposition of all remaining campaign funds in a termination report due to an apparent surplus balance after the TR was filed.

10. I reviewed bank records from the designated campaign depository and compared them with campaign treasurer report(s) covering the following reporting period(s): 2018 TR.<sup>2</sup> The results of my review are reflected in the table below. 




On March 26, 2019, the Florida Elections Commission received a complaint alleging that you violated Florida's election laws. I have reviewed the complaint and find that it contains one or more **legally sufficient allegations**. The Commission staff will investigate the following alleged violations:

**Section 106.07(5), Florida Statutes:** Respondent, a 2018 candidate for Commissioner of Agriculture, may have certified one or more campaign treasurer reports were true, correct, and complete when they were not, as alleged in the complaint.

**Section 106.141(1), Florida Statutes:** Respondent, a 2018 candidate for Commissioner of Agriculture, filed a 2018 Termination Report that may have failed to accurately reflect the disposition of all remaining campaign funds.

**Section 106.19(1)(c), Florida Statutes:** Respondent, a 2018 candidate for Commissioner of Agriculture, may have falsely reported or deliberately failed to include information in one or more campaign treasurer reports, as required by Chapter 106, as alleged in the complaint.

When we conclude the investigation, a copy of the Report of Investigation (ROI) will be mailed to you at the above address. Based on the results of the investigation, a staff attorney will make a written recommendation (Staff Recommendation or SR) to the Commission as to whether there is probable cause to charge respondent with violating Chapters 104 or 106, Florida Statutes. You will have an opportunity to respond to both the ROI and the SR. The Commission will then hold one or more hearings to determine whether the alleged violations occurred and, if so, the amount of the fine to be imposed. You and the complainant will receive notice at least 14 days before any hearing at which your case is to be considered.



Pursuant to Section 106.07(2), Florida Statutes, you have 7 days from receipt of this letter to correct errors or provide missing information. If the information has been reported accurately, you must provide a written explanation to the Division addressing the issue noted in the error report. Please be advised that if you fail to comply with this request, the Division will forward this matter to the Florida Elections Commission for further action. Section 106.265(1), Florida Statutes, authorizes the Florida Elections Commission to impose civil penalties of up to \$1,000 per violation.
