ORDER OF PROBABLE CAUSE

THIS MATTER was heard by the Florida Elections Commission ("Commission") at its regularly scheduled meeting held on August 20, 2025, at 1:00 p.m. via Zoom teleconferencing.

On January 10, 2025, Staff recommended to the Commission that there was probable cause to believe that the Florida Election Code was violated. The facts articulated in Staff's Recommendation are adopted by reference and incorporated herein. Based on the Complaint, Report of Investigation, Staff's Recommendation, and oral statements (if any) made at the probable cause hearing, the Commission finds that there is **probable cause** to charge Respondent with the following violation:

Count 1:

On June 4, 2024, Leslie James Gibbs violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2023 Q4 Report within seven days after receiving notice from the Division that the report required amendment.

NOTICE OF RIGHT TO A HEARING

As the Respondent, you may elect to resolve this case in several ways. STAFF RECOMMENDATION FOLLOWING INVESTIGATION

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the referral in this case recommending that there is **probable cause** to charge Respondent with violating **Section 106.07(2)(b)1.**, **Florida Statutes**. Based upon a thorough review of the Report of Investigation submitted on November 7, 2024, the following facts and law support this staff recommendation:

- 1. On June 21, 2024, the Florida Elections Commission ("Commission") received a referral from the Florida Division of Elections ("Complainant" or "Division") alleging that Leslie James Gibbs ("Respondent") violated Chapter 106, Florida Statutes.
- 2. Respondent was the treasurer for Katherine Waldron, a 2024 candidate for State Representative, District 93. (ROI Exhibit 1, page 1)¹
- 3. The Appointment of Campaign Treasurer and Designation of Campaign Depository form ("DS-DE 9") was filed on February 15, 2023, appointing Respondent to serve as the campaign's treasurer. (ROI Exhibit 1, page 1)
- 4. By letter dated September 11, 2024, the Executive Director notified Respondent that Commission staff would investigate the following statutory provision:

Section 106.07(2)(b)1., Florida Statutes: Respondent, treasurer for Katherine M. Waldron, a 2024 candidate for State Representative, District 93, failed to timely make necessary amendments to the 2023 Q4 campaign treasurer's report, as alleged in the complaint.

- 5. By letter dated February 17, 2023, Donna S. Brown, Chief, Bureau of Election Records, sent Respondent a letter acknowledging that the Division had received Respondent's DS-DE 9. (ROI Exhibit 2, page 1)
- 6. The acknowledgment letter provided Respondent with a user identification number and initial password to grant access to the electronic filing system ("EFS"). The letter further advised Respondent that all the Division's publications and reporting forms were available on its website and directed Respondent to print out Chapter 106, Florida Statutes, and the *Calendar of Reporting Dates*, as well as other relevant documents. (ROI Exhibit 2, page 1)

Alleged Violation: Section 106.07(2)(b)1., Florida Statutes

- 7. The campaign's 2023 Q4 Report was filed on January 8, 2024. (ROI Exhibit 5, page 10) The report was incomplete when filed as it reflected one excessive contribution, two reimbursements without corresponding distributions, and one improper itemization. (ROI Exhibit 3, page 2)
- 8. The Division sent Respondent a letter on January 23, 2024, notifying him that the campaign's report was incomplete and that Respondent was required to amend the report within seven days of receipt of the notification. (ROI Exhibit 3, page 1) A Compliance Report showing why the report was incomplete was attached to the notification. (ROI Exhibit 3, page 2)
- 9. Respondent amended the report three times during the interim, resolved the identified errors, but created additional errors in the process. Specifically, Respondent uploaded seven distributions with incorrect dates. (ROI Exhibit 4, page 2; ROI Exhibit 5, page 11; ROI Exhibit 7, page 2)
- 10. The Division sent another letter on May 8, 2024, notifying Respondent that the campaign's report was incomplete and that Respondent was required to amend the report within seven days of receipt of the notification. (ROI Exhibit 4, page 1) An updated Error Report showing why the report was incomplete was attached to the notification. (ROI Exhibit 4, page 2)
- 11. The final notification was confirmed delivered on May 28, 2024. (ROI Exhibit 4, page 3)
- 12. Respondent amended the report on June 24, 2024; however, Respondent did not correct the identified errors. (ROI Exhibit 5, pages 5, 8, 9 & 11)
- 13. Respondent stated that the Division closed the complaint and directed him to inform the Commission of this action. (ROI Exhibit 6, page 2) Respondent stated that the Division informed him that all errors were corrected. (ROI Exhibit 6, page 1)
- 14. In response to the investigation, Respondent stated that he did not receive any assistance, advice, or materials from the Division. Respondent stated that he called the Division, but staff could not explain what corrections were needed. Respondent stated that he was a first-time treasurer. (ROI Exhibit 9, page 1)
- 15. The Division's records reflect that staff made multiple calls to Respondent and sent an email to Respondent's confirmed email address with instructions on how to correct the report. Respondent answered one of the calls, updated his contact information, and stated that he would call back to discuss the errors. The Division's records do not reflect that Respondent returned any of the Division's calls or initiated any calls to the Division. (ROI Exhibit 7, page 2)
- 16. As of January 9, 2025, Respondent has not filed the required amendments to the campaign's report. (Attachment A, pages 1-3)

- 17. Commission staff expresses concern over several aspects of this case. First, the erroneous information raises questions about the true nature of the transactions involved. Despite the Division's request, Respondent did not change the expenses to monetary transactions and itemize the general expenditures. In keeping the transactions as reimbursements, Respondent also failed to itemize and link the expenditures to ensure transparency. The only modifications appear to be Respondent's attempts to fit the transactions into the reporting period at issue.
- 18. Section 106.07(4), Florida Statutes, prohibits a candidate or treasurer from concealing the entities with whom they conduct business with and the activities that benefit or advance the campaign. Because of the manner in which Respondent reported the transactions, i.e., stating that expenses to himself went to gas, meals, tolls, and parking in general, the public was blocked from seeing the actual businesses involved, the dates of the transactions, and other specifying information designed to assure the public that Respondent's compensation was a legitimate campaign expense as opposed to a personal expense.
- 19. Second, due to Respondent's contradictory statements, Commission staff is unable to give weight to Respondent's alleged mitigating and aggravating circumstances. Respondent alleged that he was a first-time treasurer, but it is unusual that Respondent willfully avoided learning the nature of the errors involved and, more importantly, willfully avoided Division staff who tried to help him.
- 20. The Division had the authority, but declined, to report Respondent and the candidate to the Commission for violations of sections 106.07(5), Florida Statutes, as to multiple campaign reports and section 106.19(1)(a), Florida Statutes, as to the excessive contribution. Respondent's conduct also provides grounds for possible violations under section 106.19(1)(c), Florida Statutes. However, it is plausible that the Division or a citizen could file a new complaint with the Commission under section 106.25(2), Florida Statutes, for subsequent reporting periods based on the errors that are visible on the Division's website.
- 21. Nonetheless, this matter is before the Commission as a violation of section 106.07(2)(b)1., Florida Statutes, which not only appears to fulfill the probable cause threshold but also appears to fulfill the willfulness threshold.
- 22. Respondent failed to amend the campaign's 2023 Q4 Report within seven days of receiving notification from the Division that the report was in error and required correction.
- 23. "Probable Cause" is defined as reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. *Schmitt v. State*, 590 So. 2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. *Department of Highway Safety and Motor Vehicles v. Favino*, 667 So. 2d 305, 309 (Fla. 1st DCA 1995).
- 24. The facts set forth above show that Respondent was the treasurer for Katherine Waldron, a 2024 candidate for State Representative, District 93. Respondent failed to timely file

the required amendments to the campaign's 2023 Q4 Report within seven days of receiving notification from the Division that the report was incomplete and required amendment.

Based upon these facts and circumstances, I recommend that the Commission find probable cause to charge Respondent with violating the following:

Count 1:

On June 4, 2024, Leslie James Gibbs violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2023 Q4 Report within seven days after receiving notice from the Division that the report required amendment.

I. Preliminary Information:

- 1. I investigated whether Respondent violated this section of the election laws by failing to file amended report(s) for the following campaign treasurer report(s) after receiving notice from the filing officer: 2023 Q4.
- 2. An Appointment of Campaign Treasurer and Designation of Campaign Depository (DS-DE 9) was filed on February 15, 2023. Respondent was appointed as campaign treasurer for Katherine Waldron, a 2024 candidate for State Representative, District 93. To review the DS-DE 9, refer to Exhibit 1.
- 3. On February 17, 2023, the Division sent Respondent a letter acknowledging Respondent's appointment as the campaign treasurer for Katherine Waldron's campaign. The letter advised Respondent that all of the Division's publications and reporting forms are available on their website, including Chapter 106, Florida Statutes, the *Candidate and Campaign Treasurer Handbook*, and the *Calendar of Reporting Dates*. The letter further advised that it was Respondent's responsibility to read, understand, and follow the requirements of Florida's election laws. To review the acknowledgement letter, refer to Exhibit 2.

II. Alleged Violation of Section 106.07(2)(b)(1)., Florida Statutes:

- 4. The Division sent correspondence to the address provided on the DS-DE 9 notifying Respondent that one or more campaign treasurer report(s) were incomplete. The correspondence included error report(s) referencing the following report(s): 2023 Q4. To review the correspondence and error report(s), refer to Exhibit 3.
- 5. On May 8, 2024, the Division sent a letter marked "Final Notice" with delivery confirmation to an updated address notifying Respondent that one or more campaign treasurer report(s) were incomplete. The letter included an error report referencing the following report(s): 2023 Q4. It was confirmed delivered on May 28, 2024. To review the "Final Notice," error report and delivery confirmation, refer to Exhibit 4.
- 6. As noted above, the "Final Notice" was confirmed delivered on May 28, 2024. The Division filed the referral on June 21, 2024. By filing the referral, the Division affirmed that as of that date, the report(s) at issue had not been amended to correct all errors identified by the Division. To review the report(s) at issue, refer to Exhibit 5.
- 7. Respondent did respond to the referral by email on September 10, 2024. Respondent stated, "I was informed by two clerks that I had corrected all requested, though originally the corrections were made after a deadline due to correspondence going to wrong addresses." To review Respondent's response, refer to Exhibit 6.

- 8. Division history notes as of September 13, 2024, do not show record of contact with Respondent informing him that the 2023 Q4 report had been correctly amended. The "Final Notice" sent on May 8, 2024, was sent to 225 S. Ocean Breeze, Suite 6, Lake Worth Beach, FL 33460, but the address on the DS-DE 9 is 1215 Gator Trail, West Palm Beach, FL 33409. Division records show that on March 11, 2024, Division staff called Respondent, who "says the address on file with the division (1215 Gator Trail, West Palm Beach FL 33409) is his old address. He said he will update EFS with his current address today and call us back to go over the issues with this audit." Division records note that on March 12, 2024, Respondent "updateded (sic) his address in EFS. I am remailing the final notice." The records note that as of June 17, 2024, the "errors haven't been fixed. Referring to FEC." On May 28, 2024, another DS-DE 9 was filed again listing 1215 Gator Trail as Respondent's Treasurer address of record. To review the DS-DE 9, refer to Exhibit 1. To review the "Final Notice," refer to Exhibit 4. To review Division records of contact with Respondent, refer to Exhibit 7. To review the updated DS-DE 9, refer to Exhibit 8.
- 9. I called Respondent for the purpose of providing an opportunity to discuss the allegations made in the referral. Respondent stated that he was a first-time treasurer. He stated that he did not receive any election materials, advice, or assistance from the Division. Respondent stated, "I called them (Division), but they couldn't explain to me what corrections were required, so I ended up not correcting anything." Respondent verified his contact address is 225 S. Ocean Breeze, Suite 6, Lake Worth Beach, FL 33460, which is the same address to which the "Final Notice" was sent on May 8, 2024, and delivered on May 28, 2024. To review the "Final Notice," refer to Exhibit 4. To review the phone log, refer to Exhibit 9.

On June 21, 2024, the Florida Elections Commission received a complaint alleging that you violated Florida's election laws. I have reviewed the complaint and find that it contains one or more **legally sufficient allegations**. The Commission staff will investigate the following alleged violation:

Section 106.07(2)(b)1., Florida Statutes: Respondent, treasurer for Katherine M. Waldron, a 2024 candidate for State Representative, District 93, failed to timely make necessary amendments to the 2023 Q4 campaign treasurer's report, as alleged in the complaint.

When we conclude the investigation, a copy of the Report of Investigation (ROI) will be mailed to you at the above address. Based on the results of the investigation, a staff attorney will prepare and present a written Staff Recommendation (SR) to the Commission as to whether there is probable cause to charge you, the Respondent, with violating Chapters 104 or 106, Florida Statutes. You will have an opportunity to respond to both the ROI and the SR. The Commission will then hold one or more hearings to determine whether the alleged violation occurred and, if so, the amount of the fine to be imposed upon you. Notice will be mailed to you and the Complainant at least 14 days before any hearing at which your case is to be considered.

Pursuant to Section 106.25(4)(i)3., Florida Statutes, the Commission may enter into a consent agreement with a Respondent to settle a complaint prior to a finding of probable cause. If you are interested in entering negotiations directed towards reaching a consent agreement to resolve this matter, please contact the Commission and request to speak with the attorney assigned to this case.
