If you are the Respondent, you may attend the hearing, and you or your attorney will have 5 minutes to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

If you are the Complainant, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

If you are an Appellant, and you have requested a hearing, you may attend the hearing, and you or your attorney will have 5 *minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider **an appeal of an intent to revoke a registration**, of a Political Committee, Electioneering Communications Organization, or a Political Party, the Division of Elections has issued you a notice of intent, citing the reasons for which it intends to cancel your registration. By filing the appeal, you have asked the Commission to recommend that the Division's Notice of Intent be set aside. You are required to explain why you believe your registration should not be cancelled. Based upon the information you present, the Commission will issue a recommended order to the Division, in which it will either recommend that the Notice of Intent be set aside, or that the cancellation be upheld.

SUMMARY: Citizens for Cleaner Government is a political committee (PC) registered with the State of Florida. The PC's chair is Elizabeth Benac and its treasurer is Patsy Ugarte.

The PC is appealing the fine, claiming that they received incorrect information from the Division of Elections. According to Ms. Benac, she received credentials for an unfamiliar committee by mail and reached out to the Division to report the error. She notes that she was not provided with the correct PIN for her committee until after the report was due. Ms. Benac has provided documents to support the appeal.

- The 2024 P3 Original Report covers the period from 07/06/24-07/12/24; it was due on 07/19/24.
- The 2024 P3 Queued Transaction Report shows that it was created on 07/08/24 and filed on 07/22/24.
- · Citizens for Cleaner Government reported receiving 14 contributions, while making 11 expenditures.
- The Division of Elections provided one note that pertains to Citizens for Cleaner Government's 2024 P3 report. On 07/19/24, DOE staff called Ms. Benac regarding credentials.

Today I received a letter from the Division of Elections stating that our PAC, Citizens for Cleaner Government has been assessed a late fine of \$ 150.00. I just received the letter which is dated August 2, 2024, as it was forwarded to my out of state address. Therefore, please accept this email as my appeal of this fine, and I will follow with a written letter in the mail.

The reasons for our late filing was that the letter with the information for Citizens for Cleaner Government was mailed to me on July 18, 2024, and not received until well after the filing date of July 19, 2024. Prior to receipt of this correct, I received a letter from the Florida Division of Elections dated July 10 addressed to myself as chairperson for the Committee of the Islands (see attached). This was terribly confusing, as I have nothing to do with this PAC-and I called the Division of Elections to report their error.

Dear Ms. Benac:

Our records indicate that you have not filed either your campaign treasurer's report or notification that no reportable activity occurred, whichever is applicable. The filing date was July 19, 2024.

The law (s. 106.07(8)(b), Fla. Stat.) requires the filing officer to immediately notify you about the missed filing date and the automatic fines that will be assessed for late filing of a report, if a report was due.

- If reportable activity occurred and you have not filed a report, statutory fines are automatically assessed as follows until you file your report:
 - \$50 per day for the first 3 days late
 - § \$500 per day for each day after the 3rd day late
 - If the required report immediately precedes a primary and general election, the automatic fine is \$500 for each late day.

The total fine for the untimely report cannot exceed 25% of the total receipts or expenditures, whichever is greater, for the cover period. Even if you end up filing your report late, we cannot waive the statutory fines. We will notify you of the specific amount of fines owed once you file your report. You have 20 days from the day you receive the notice to pay the fine or to appeal the fine to the Florida Elections Commission.

• If no reportable activity occurred for the report date(s), you are still required to notify us in writing, via the Division's Electronic Filing System, that no reportable activity occurred. No automatic fines are statutorily assessed.

However, in all cases, failure to file and/or untimely filing of a report of reportable activity, or if applicable, a notice that no reportable activity occurred, may constitute an apparent violation of chapter 106, Fla. Stat. If we refer such matter to the Florida Elections Commission, the Commission may subsequently impose a civil penalty for each violation under chapter 106.265(1), Fla. Stat.

due date, the report will be accepted as timely filed if filed no later than midnight, Eastern Standard Time, of the first business day the EFS becomes operable. No fine will be levied during the period the EFS was inoperable.




