**NOTICE OF HEARING (AUTOMATIC FINE (AF))**

A hearing will be held in this case before the Florida Elections Commission on **February 7, 2024 at 9:00 a.m., or as soon thereafter as the parties can be heard**, at the following location: **402 South Monroe Street, 12 HOB, Tallahassee, Florida 32399**. Due to heightened security access requirements, please bring only essential items into the building and plan to arrive early to allow for delays coming through security.

Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

**If you are the Respondent**, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

**If you are the Complainant**, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

**If you are an Appellant**, and you have requested a hearing, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

Please refer to the information below for further instructions related to your particular hearing:

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant to Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

- The 2023 M2 Queued Transaction Report shows that it was created on 02/10/23 and filed on 03/14/23.
- Democratic Women's Club of Florida Political Committee reported receiving 36 contributions while making 4 expenditures.
- The Division of Elections provided notes that pertain to Democratic Women's Club of Florida Political Committee's 2023 M2 Report. The notes from 01/10/23 to 3/13/23 show a series of pin requests by the treasurer, Ms. Ryan, and notes from DOE staff regarding the information.

Gentlemen/Ladies:

My name is Deborah Ryan and I am the Treasurer of the Democratic Women's Club of Florida Political Committee. I was asked to undertake this position in December, 2022. The former chair of the Committee Ms. Nancy Hurlbert (of Leesburg) and the former treasurer Ms. Francine Garcia (of Clermont) as well as the incoming Chair, Ms. JoAnne Devries (of Sarasota), our State President Monica Readus (of Cocoa Beach), and I had a zoom call just before the first of the year regarding what the Committee needed to do to transfer all our records, accounts, etc. We first had to make a request to have Ms. DeVries and I appointed to our positions and letters went to the Division of Election Records to that effect. Ms. Garcia stated that she had already filed the January Electronic Filing.

While we were waiting for the numeric codes to be issued from Tallahassee, I went over to Clermont and spent the afternoon reviewing all the EFS paperwork with Ms. Garcia. She showed me how to go into the system using her passwords and PIN.

As soon as I received the PIN numeric code from Tallahassee – 3026--, I put together a permanent password and in fact used THAT password when I completed the February EFS filing which went through on February 10<sup>th</sup>. Ms. Garcia was able to view the report electronically and made a few changes before I filed it since this was the first one I did.

On Friday, March 10<sup>th</sup>, I gathered all the information together that I needed for that month's filing and attempted to do the report using the password I had set up in February, but I could not get it to work. I started around 11:00 AM just like I did in February. My PIN was accepted but not the password I had set up and used in February. I tried several times. I called the Division of Election Records and spoke to "Chris." He was very professional and explained that I had to fill out an "Electronic Filing System (EFS) Credentials Request Form". He further explained

how to download the form and asked me to fill it out and fax it back to their office. I downloaded the form successfully, filled it out, and drove to the closest Office Depot near me (about six miles away) and faxed the form. I then returned home.

A little while later I received a text message from their office with a phone number. I spoke with Mr. Ford, and he gave me a temporary password of **5jrkF5h7**. I read it back to him and that was the correct number. We both hung up on the call.

I then tried to start on the report again using the above number so I could set up the permanent password. After I put in the above number the screen went to the security question about my mother's family name which is "Hassall" and I attempted to create a permanent password. The system did not let me do this even after several attempts. I called the office back, but Mr. Ford's was in a meeting. I left a message on his voicemail. I know they are a very busy state office.

I tried several times over the weekend to set up a permanent password, but nothing was working. I wrote a letter (please see attached and excuse typos), did another EFS Credentials Form and faxed everything to Mr. Ford on Sunday, March 12<sup>th</sup>. I remember it was the night of the Academy Awards. I was very upset because I knew that the report was past due, and I always try to be punctual with everything. To make matters worse I had a minor traffic accident in the parking lot. It was not my fault, but it was also upsetting.

On Monday, I called the office and Mr. Ford was in a meeting. The staffer I talked to said that the fax had been received and I would get a call back. Mr. Ford called back around 3:00 PM and he could not have been nicer. He gave me the following temporary password – **2j8JSH06** – and said he would not hang up until he knew I had created a new permanent password. I had him on speaker phone. He also said he had heard about the traffic accident, and he hoped I was okay. I was finally able to create a new permanent password and I started to do the report.

I am not a computer or IT expert and I do not know why the password worked in February and not in March. I do not know if it was a computer anomaly or some kind of software malfunction. I worked for the State of Florida (first at Seminole

State College (at the time Seminole Community College) and the University of Central Florida) so I am familiar with computer mishaps and anomalies.

I take my position as Treasurer very seriously. This is a position with a lot of responsibility. Our members donate their personal funds to help us achieve our mission. I would like to point out that the April report was submitted early. What happened in March involved problems that were beyond my control.

Thank you for your attention and we look forward to a positive response to this appeal. I am also sending a copy to the Division of Elections as directed.

Dear Ms. DeVries:

Our records indicate that you have not filed either your campaign treasurer's report or notification that no reportable activity occurred, whichever is applicable. The filing date was March 10, 2023.

The law (s. 106.07(8)(b), Fla. Stat.) requires the filing officer to immediately notify you about the missed filing date and the automatic fines that will be assessed for late filing of a report, if a report was due.

- If reportable activity occurred and you have not filed a report, statutory fines are automatically assessed as follows until you file your report:
  - \$50 per day for the first 3 days late
  - \$500 per day for each day after the 3rd day late
  - If the required report immediately precedes a primary and general election, the automatic fine is \$500 for each late day.

The total fine for the untimely report cannot exceed 25% of the total receipts or expenditures, whichever is greater, for the cover period. Even if you end up filing your report late, we cannot waive the statutory fines. We will notify you of the specific amount of fines owed once you file your report. You have 20 days from the day you receive the notice to pay the fine or to appeal the fine to the Florida Elections Commission.

- If no reportable activity occurred for the report date(s), you are still required to notify us in writing, via the Division's Electronic Filing System, that no reportable activity occurred. No automatic fines are statutorily assessed.

However, in all cases, failure to file and/or untimely filing of a report of reportable activity, or if applicable, a notice that no reportable activity occurred, may constitute an apparent violation of chapter 106, Fla. Stat. If we refer such matter to the Florida Elections Commission, the Commission may subsequently impose a civil penalty for each violation under chapter 106.265(1), Fla. Stat.
