ORDER OF PROBABLE CAUSE

THIS MATTER was heard by the Florida Elections Commission ("Commission") at its meeting held on August 20, 2025, at 1:00 p.m. via Zoom teleconferencing.

On September 16, 2024, Staff recommended to the Commission that there was probable cause to believe that the Florida Election Code was violated. The facts articulated in Staff's Recommendation are adopted by reference and incorporated herein. Based on the Complaint, Report of Investigation, Staff's Recommendation, and oral statements (if any) made at the probable cause hearing, the Commission finds that there is **probable cause** to charge Respondent with the following violation(s):

Count 1:

On or about December 15, 2022, George Navarini violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2022 G4 Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

NOTICE OF RIGHT TO A HEARING

As the Respondent, you may elect to resolve this case in several ways. First, you may elect to resolve this case by <u>consent order</u> where you and Commission staff agree to resolve the violation(s) and agree to the amount of the fine. The consent order is then presented to the Commission for its approval. To discuss a consent order, contact the FEC attorney identified in the Order of Probable Cause.

Second, you may request an <u>informal hearing</u> held before the Commission, if you <u>do not</u> dispute any material fact in the Staff Recommendation. You have 30 days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to make written or oral arguments to the Commission concerning the legal issues related to the violation(s) and the potential fine. STAFF RECOMMENDATION FOLLOWING INVESTIGATION

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the referral in this case recommending that there is **probable cause** to charge Respondent with violating **Section 106.07(2)(b)1.**, **Florida Statutes**. Based upon a thorough review of the Report of Investigation submitted on January 12, 2024, the following facts and law support this staff recommendation:

- 1. On January 6, 2023, the Florida Elections Commission ("Commission") received a referral from the Department of State, Division of Elections ("Division"), alleging that George Navarini ("Respondent") violated Chapter 106, Florida Statutes.
- 2. Respondent was a 2022 candidate for State Representative, District 103. (ROI Exhibit 1, page 2)¹ On March 24, 2022, Respondent changed his designation from State Representative, District 104, to State Representative, District 103, due to redistricting. (ROI Exhibit 1, page 1)
- 3. By letter dated May 24, 2023, the Executive Director notified Respondent that Commission staff would investigate the following statutory provision:

Section 106.07(2)(b)1., Florida Statutes: As alleged in the complaint, Respondent, a 2022 candidate for State Representative, District 103, acting as his own treasurer, failed to timely make necessary amendments to the following campaign treasurer's reports:

- 2022 P6
- 2022 G3
- 2022 G4
- 4. On November 30, 2020, Respondent filed his Appointment of Campaign Treasurer and Designation of Campaign Depository for Candidates form ("DS-DE 9") appointing himself as treasurer for his campaign. (ROI Exhibit 2)
- 5. By letter dated November 30, 2020, Kristi Reid Willis, Chief, Bureau of Election Records, sent Respondent a letter acknowledging that his name was placed on the 2022 active candidate list. (ROI Exhibit 3, page 1)

¹ The Report of Investigation is referred to herein as "ROI."

- 6. The acknowledgment letter advised Respondent that all candidates filing reports with the Division are required to use the electronic filing system ("EFS") and provided Respondent with a user identification number and initial password to grant access to the EFS. (ROI Exhibit 3, page 1) The letter further advised Respondent that all of the Division's publications and reporting forms were available on its website and directed Respondent to print out Chapter 106, Florida Statutes, and the *Calendar of Reporting Dates*, as well as other relevant documents. (ROI Exhibit 3, page 2)
- 7. The campaign's 2022 P6, 2022 G3, and 2022 G4 reports were incomplete when filed. See Compl.
- 8. The Division sent five letters notifying Respondent that the campaign's reports were incomplete and that Respondent was required to amend the reports within 7 days of receipt of the notification. An Error Report showing why the reports were incomplete was attached to each notification. (ROI Exhibits 4 & 5) The final notification was confirmed delivered. (ROI Exhibit 5, page 5)
- 9. Respondent stated that the Division sent the letters to his post office box which he does not check often. He stated that he is running his campaign by himself. (ROI Exhibit 7, page 2)
- 10. The Division's records show that the 2022 P6 Report was incomplete as the report contained a \$0 contribution that did not have any supporting information (ROI Exhibit 5, page 2) The Division's records show that the 2022 G3 Report was incomplete as the report contained a \$0 contribution with an occupation of "Retired" that did not have any supporting information. (ROI Exhibit 5, page 3) The Division's records show that the 2022 G4 Report was incomplete as the report disclosed a contribution that contained a transaction date that occurred prior to the relevant reporting period and a contribution that contained an address but lacked a state. (ROI Exhibit 5, page 4)
- 11. The Division's records show that Respondent attempted to amend the 2022 G3 and 2022 G4 reports. (ROI Exhibit 6, pages 7 & 13) The errors in the 2022 P6 and 2022 G3 reports appear to be inadvertent. (ROI Exhibit 6, pages 3 & 9)
- 12. "Probable Cause" is defined as reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. *Schmitt v. State*, 590 So. 2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. *Department of Highway Safety and Motor Vehicles v. Favino*, 667 So. 2d 305, 309 (Fla. 1st DCA 1995).
- 13. The facts set forth above show that Respondent was a 2022 candidate for State Representative, District 103, and was acting as his own treasurer. Respondent failed to timely file the required amendments to the campaign's 2022 G4 Report within 7 days of receiving notification from the Division that the report was incomplete and required amendment. Additionally, Respondent failed to timely amend the campaign's 2022 P6 and 2022 G3 reports; however, due to

the nature of the incomplete information, it does not appear that the public interest would be served by proceeding further.

Based upon these facts and circumstances, I recommend that the Commission find **probable cause** to charge Respondent with violating the following:

Count 1:

On or about December 15, 2022, George Navarini violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2022 G4 Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

I. Preliminary Information:

- 1. I investigated whether Respondent violated this section of the election laws by failing to file amended report(s) for the following campaign treasurer report(s) after receiving notice from the filing officer: 2022 P6, 2022 G3 and 2022 G4.
- 2. An Appointment of Campaign Treasurer and Designation of Campaign Depository (DS-DE 9) was filed on November 30, 2020. Respondent was appointed as campaign treasurer for George Navarini, a 2022 candidate for State Representative, District 103.¹ To review the DS-DE 9, refer to Exhibit 2.
- 3. On November 30, 2020, the Division sent Respondent a letter acknowledging Respondent's appointment as the campaign treasurer for George Navarini's campaign. The letter advised Respondent that all of the Division's publications and reporting forms are available on their website, including Chapter 106, Florida Statutes, the *Candidate and Campaign Treasurer Handbook*, and the *Calendar of Reporting Dates*. The letter further advised that it was Respondent's responsibility to read, understand, and follow the requirements of Florida's election laws. To review the acknowledgement letter, refer to Exhibit 3.

II. Alleged Violation of Section 106.07(2)(b)(1)., Florida Statutes:

- 4. The Division sent correspondence to the address provided on the DS-DE 9 notifying Respondent that one or more campaign treasurer report(s) were incomplete. The correspondence included error report(s) referencing the following report(s): 2022 P6, 2022 G3 and 2022 G4. To review the correspondence and error report(s), refer to Exhibit 4.
- 5. On December 1, 2022, the Division sent a letter marked "Final Notice" with delivery confirmation to the address provided on the DS-DE 9 notifying Respondent that one or more campaign treasurer report(s) were incomplete. The letter included an error report referencing the following report(s): 2022 P6, 2022 G3 and 2022 G4. It was confirmed delivered on December 8, 2022. To review the "Final Notice," error report and delivery confirmation, refer to Exhibit 5.
- 6. As noted above, the "Final Notice" was confirmed delivered on December 8, 2022. The Division filed the referral on January 6, 2023. By filing the referral, the Division affirmed that as of that date, the report(s) at issue had not been amended to correct all errors identified by the Division. To review the report(s) at issue, refer to Exhibit 6.

¹ Respondent initially filed to run for District 104, but he later filed for redesignation to District 103 due to redistricting. To review the redesignation documentation, refer to Exhibit 1.

- 7. Respondent did not respond to the referral.
- 8. I called Respondent for the purpose of providing an opportunity to discuss the allegations made in the referral. When asked about the failure to timely file amend the reports at issue, Respondent stated that the Division sent the notices by mail to his post office box. He stated that he did not go to the post office that often, especially at the start of early voting. Respondent asserted that he was doing everything himself. Respondent acknowledged that he possessed and had read Chapter 106, Florida Statutes, and the *Candidate and Campaign Treasurer Handbook*. Respondent acknowledged responsibility for the issue but stated that there was no malicious intent. To review the phone log, refer to Exhibit 7.

Any candidate failing to file a report on the designated due date shall be subject to a fine of \$50 per day for the first three days late and, thereafter, \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for reports immediately preceding each primary and general election, the fine shall be \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

Electronic Receipts

The person submitting the report on the EFS will be issued an electronic receipt indicating and verifying the report was filed. Each campaign treasurer's report filed by means of the EFS is considered to be under oath by the candidate and campaign treasurer, and such persons are subject to the provisions of Section 106.07(5), Florida Statutes.



On January 6, 2023, the Florida Elections Commission received a complaint alleging that you violated Florida's election laws. I have reviewed the complaint and find that it contains one or more **legally sufficient allegations**. The Commission staff will investigate the following alleged violation:

Section 106.07(2)(b)1., Florida Statutes: As alleged in the complaint, Respondent, a 2022 candidate for State Representative, District 103, acting as his own treasurer, failed to timely make necessary amendments to the following campaign treasurer's reports:

- 2022 P6
- 2022 G3
- 2022 G4

When we conclude the investigation, a copy of the Report of Investigation (ROI) will be mailed to you at the above address. Based on the results of the investigation, a staff attorney will prepare and present a written Staff Recommendation (SR) to the Commission as to whether there is probable cause to charge you, the Respondent, with violating Chapters 104 or 106, Florida Statutes. You will have an opportunity to respond to both the ROI and the SR. The Commission will then hold one or more hearings to determine whether the alleged violation occurred and, if so, the amount of the fine to be imposed upon you. Notice will be mailed to you and the Complainant at least 14 days before any hearing at which your case is to be considered.
