**SUMMARY:** Libertarian Party of Florida is a political party executive committee (PTY) registered with the State of Florida. The PTY's chair is Joshua Hlavka and its treasurer is Joe Sokol. Brianna Pacheco-Jones is the former treasurer.

The PTY is appealing the fine claiming that late submission was due to several factors. According to Mr. Hlavka, the new treasurer received a letter from the "Florida Election Commission (FEC) indicating an expected date change during an election year. This, coupled with technical difficulties experienced while attempting to upload the records a few days earlier, led to the delay."

- The 2024 Q1 Original Report covers the period from 01/01/24-03/31/24; it was due on 04/10/24.
- The 2024 Q1 Queued Transaction Report shows that it was created on 04/12/24 and filed on 04/15/24.
- · Libertarian Party of Florida reported receiving 202 contributions, while making 46 expenditures.
- The Division of Elections provided 1 note that pertains to Libertarian Party of Florida's 2024 Q1 report. On April 18, 2024, Ms. Pacheco-Jones called regarding the failure to file letter and indicated she was given the incorrect deadline. She was directed to the calendar of reporting dates as well as the campaign documents database. DOE staff also discussed the fine letter and appeal process.

I hope this letter finds you well. I am writing to address a recent correspondence from your office, dated May 14, 2024, which I received on May 22, 2024. The letter, which was sent to my PO Box instead of my home address, informed me that the Libertarian Party of Florida has been assessed a late fine of \$5,000. This fine pertains to our campaign treasurer's report, which was due on April 10, 2024, but was filed on April 15, 2024.

The late submission was due to several factors. Our new treasurer, who recently assumed her position, received a letter from the Florida Election Commission (FEC) indicating an expected date change during an election year. This, coupled with technical difficulties experienced while attempting to upload the records a few days earlier, led to the delay. Given that it was tax season and her first filing, the treasurer assumed the date change was standard.

I acknowledge the importance of adhering to deadlines and regulations governing campaign finance. To ensure such issues do not reoccur, we have implemented several measures, including enhanced training for our treasurer and a review of our internal processes. We are also establishing a more robust communication protocol with the FEC to avoid any future misunderstandings.

We sincerely apologize for any inconvenience this may have caused. As the fine notice was not received until May 22 and not seen online before our last meeting three weeks ago, I am sending this appeal via email in addition to mailing it to ensure timely receipt.

Given these circumstances and the steps we have taken to improve our compliance procedures, we kindly request that the imposed fine be reconsidered and removed. Additionally, I would like to request an appeal appointment in Tallahassee to discuss this matter further.

Thank you for your attention to this matter. I look forward to your response and the opportunity to resolve this issue promptly.

Dear Mr. Hlavka:

Your campaign treasurer's report, which was due April 10, 2024, has not been received.

Section 106.29(3)(b), Florida Statutes, requires that the filing officer immediately notify you of the failure to file this report and that a fine will be assessed of \$1,000 per day for each late day, although a fine cannot exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for the report immediately preceding the general election, the fine shall be \$10,000 per day for each late day.

Once your report is filed, this office will notify you of the specific amount of your fine. Fines must be paid to the filing officer within 20 days of receipt of the payment due notice.

Please be advised, however, that failure to file a campaign treasurer's report may constitute a violation of Chapter 106, Florida Statutes, independent of the automatic fine violation referenced above. Therefore, if you fail to file a report, the division will turn the matter over to the Florida Elections Commission.

Section 106.265(1), Florida Statutes, authorizes the Florida Elections Commission to impose a civil penalty up to \$1,000 per count for each willful violation of Chapter 106.
