ORDER OF PROBABLE CAUSE

THIS MATTER was heard by the Florida Elections Commission ("Commission") at its meeting held on August 20, 2025, at 9:00 a.m. via Zoom teleconferencing.

On July 9, 2025, Staff recommended to the Commission that there was probable cause to believe that the Florida Election Code was violated. The facts articulated in Staff's Recommendation are adopted by reference and incorporated herein. Based on the Complaint, Report of Investigation, Staff's Recommendation, and oral statements (if any) made at the probable cause hearing, the Commission finds that there is **probable cause** to charge Respondent with the following violation(s):

Count 1:

On or about September 2, 2022, Michael Harvey Sr. violated Section 106.19(1)(c), Florida Statutes, when he deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2022 G1 Report.

Count 2:

On or about September 16, 2022, Michael Harvey Sr. violated Section 106.19(1)(c), Florida Statutes, when he deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2022 G2 Report.

The Commission finds that there is **no probable cause** to charge Respondent with violating Section 106.07(7), Florida Statutes.

NOTICE OF RIGHT TO A HEARING

As the Respondent, you may elect to resolve this case in several ways. First, you may elect to resolve this case by <u>consent order</u> where you and Commission staff agree to resolve the violation(s) and agree to the amount of the fine. The consent order is then presented to the Commission for its approval. To discuss a consent order, contact the FEC attorney identified in the Order of Probable Cause.

Second, you may request an <u>informal hearing</u> held before the Commission, if you <u>do not</u> dispute any material fact in the Staff Recommendation. You have 30 days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to make written or oral arguments to the Commission concerning the legal issues related to the violation(s) and the potential fine. At the request of Respondent, the Commission will consider and determine willfulness at an informal hearing. Otherwise, live witness testimony is unnecessary.

Third, you may request a <u>formal hearing</u> held before an administrative law judge in the Division of Administrative Hearings (DOAH), if you dispute any material fact in the Staff Recommendation. You have 30 days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to present evidence relevant to the violation(s) listed in this order, to cross-examine opposing witnesses, to impeach any witness, and to rebut the evidence presented against you.

If you do not elect to resolve the case by consent order or request a formal hearing at the DOAH

or an informal hearing before the Commission within 30 days of the date this Order of Probable Cause is filed with the Commission, the case will be sent to the Commission for a formal or informal hearing, depending on whether the facts are in dispute. STAFF RECOMMENDATION FOLLOWING INVESTIGATION

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the referral in this case recommending that there is probable cause to charge Respondent with violating Section 106.19(1)(c), Florida Statutes, and no probable cause to charge Respondent with violating Section 106.07(7), Florida Statutes. Based upon a thorough review of the Report of Investigation submitted on May 19, 2025, the following facts and law support this staff recommendation:

- 1. On February 2, 2023, the Florida Elections Commission ("Commission") received a referral from the Department of State, Division of Elections ("Division"), alleging that Michael Harvey Sr. ("Respondent") violated Chapter 106, Florida Statutes.
- 2. Respondent was a 2022 candidate for State Senator, District 23. Respondent's Statement of Candidate form ("DS-DE 84") was filed on December 21, 2020, initially for State Senator, District 20. (ROI Exhibit 2, page 1)¹ However, on June 17, 2022, Respondent filed a request to change his candidacy from District 20 to District 23 due to redistricting. (Attachment A)
- 3. By letter dated March 28, 2025, the Executive Director notified Respondent that Commission staff would investigate the following statutory provisions:

Section 106.07(7), Florida Statutes: Respondent, a 2022 candidate for State Senator, District 23, failed to notify the filing officer on the prescribed reporting date that no report would be filed on that date because he had not received funds, made contributions, or expended reportable funds during the 2022 G1 and 2022 G2 reporting periods, as alleged in the complaint.

Section 106.19(1)(c), Florida Statutes: Respondent, a 2022 candidate for State Senator, District 23, may have falsely reported or deliberately failed to include information required by Chapter 106, Florida Statutes, during the 2022 G1 and 2022 G2 reporting periods, as alleged in the complaint.

4. On December 21, 2020, Respondent filed his Appointment of Campaign Treasurer and Designation of Campaign Depository for Candidates form ("DS-DE 9") appointing Brandy

Harvey as treasurer for his campaign. (ROI Exhibit 1, page 1) Respondent later filed an updated DS-DE 9 form on June 17, 2022, to change his candidacy to State Senator, District 23 and appoint Alia Scott as his new campaign treasurer. (ROI Exhibit 1, page 2)

- 5. By letter dated December 22, 2020, Kristi Reid Willis, Chief, Bureau of Election Records, sent Respondent a letter acknowledging that the Division had received his DS-DE 9 and that his name was placed on the 2022 active candidate list. (ROI Exhibit 3, page 1)
- 6. The acknowledgment letter advised Respondent that all candidates filing reports with the Division are required to use the electronic filing system ("EFS") and provided Respondent with a user identification number and initial password to grant access to the EFS. (ROI Exhibit 3, page 1) The letter further advised Respondent that all of the Division's publications and reporting forms were available on its website and directed Respondent to print out Chapter 106, Florida Statutes, and the *Calendar of Reporting Dates*, as well as other relevant documents. (ROI Exhibit 3, page 2)
- 7. Complainant alleged that Respondent violated Florida's election laws by failing to notify the filing officer on the prescribed reporting dates that no reports would be filed or by falsely reporting or deliberately failing to include information required by Chapter 106, Florida Statutes, during the following reporting periods: 2022 G1 and 2022 G2.
- 8. Respondent's 2022 G1 report was due to be filed by September 2, 2022. (ROI Exhibit 4, page 1) Respondent's 2022 G2 report was due to be filed by September 16, 2022. (ROI Exhibit 4, page 2) However, Respondent failed to timely file the reports or notify the filing officer that no reports would be filed. (ROI Exhibit 4)
- 9. The Division sent multiple letters informing Respondent that his 2022 G1 and 2022 G2 reports were late, with the Final Notice being confirmed delivered on October 28, 2022. (ROI Exhibits 4-6)
- 10. A subpoena was issued to Respondent's designated campaign depository to ascertain whether any financial activity occurred during the 2022 G1 and 2022 G2 reporting periods, which revealed that Respondent had reportable financial activity during said periods. (ROI Exhibit 8)
 - 11. Respondent's bank records show the following reportable financial activity:
 - Contributions totaling \$165.22 during the 2022 G1 reporting period (August 19, 2022 – August 26, 2022). (ROI Exhibit 8)
 - Contributions totaling \$351.00 and expenditures totaling \$645.10 during the 2022 G2 reporting period (August 27, 2022 – September 9, 2022). (ROI Exhibit 8)
- 12. Commission staff attempted to contact Respondent multiple times regarding the investigation but were never able to reach him. (ROI Exhibit 9, page 1) Respondent also failed to

respond to any written electronic communications sent by the Commission during the investigation. (Exhibit 9, page 2) Respondent was not a first-time candidate. (ROI, page 1)

- 13. On the amended DS-DE 9 form Respondent attached a letter informing the Division that their prior treasurer had separated from the campaign and as a result they were unable to file their reports. (ROI, page 2) They also stated that they had appointed a new treasurer and would be able to catch up on late filings. (ROI, page 2) As of the filing of the Report of Investigation, Respondent did not file the reports at issue. (ROI, page 2)
- 14. As it appears that Respondent had financial activity during the 2022 G1 and 2022 G2 reporting periods, Respondent was required to report this activity but failed to do so. Since Respondent had reportable financial activity during these reporting periods, Respondent was not required to notify the filing officer in writing that he would not be filing his 2022 G1 and 2022 G2 reports.
- 15. "Probable Cause" is defined as reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. Schmitt v. State, 590 So. 2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. Department of Highway Safety and Motor Vehicles v. Favino, 667 So. 2d 305, 309 (Fla. 1st DCA 1995).
- 16. The facts set forth above show that Respondent was a 2022 candidate for State Senator, District 23. Respondent failed to timely file his 2022 G1 and 2022 G2 reports or notify the filing officer in writing on the prescribed reporting date that no reports would be filed. The evidence shows that Respondent had reportable financial activity during the reporting periods. Therefore, Respondent deliberately failed to include information required by Chapter 106, Florida Statutes, in his reports in violation of Section 106.19(1)(c), Florida Statutes. Since Respondent did have reportable financial activity during the 2022 G1 and 2022 G2 reporting periods, it does not appear that Respondent failed to notify the filing officer that no reports would be filed.

Based upon these facts and circumstances, I recommend that the Commission find no probable cause to charge Respondent with violating Section 106.07(7), Florida Statutes, and find probable cause to charge Respondent with violating the following:

Count 1:

On or about September 2, 2022, Michael Harvey Sr. violated Section 106.19(1)(c), Florida Statutes, when he deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2022 G1 Report.

Count 2:

On or about September 16, 2022, Michael Harvey Sr. violated Section 106.19(1)(c), Florida Statutes, when he deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2022 G2 Report.

I. Preliminary Information:

1. Respondent was a 2022 candidate for State Senator, District 23¹; he was defeated in the general election held on November 8, 2022. Respondent was not a first-time candidate.

- 2. An Appointment of Campaign Treasurer and Designation of Campaign Depository (DS-DE 9) was filed on December 21, 2020. Brandy Harvey was appointed as campaign treasurer. To review the DS-DE 9, refer to Exhibit 1.²
- 3. Respondent filed a Statement of Candidate with the Division on December 21, 2020, in which Respondent certified he had been provided access to read and understand Chapter 106, F.S. To review the Statement of Candidate, refer to Exhibit 2.
- 4. An acknowledgement letter was mailed to the address provided on the DS-DE 9 on December 22, 2020, advising Respondent that all candidates filing reports with the Division are required to file by means of the Division's electronic filing system (EFS). Respondent was provided with a user identification number and initial password allowing access to the EFS.
- 5. The acknowledgement letter also advised Respondent that all of the Division's publications and reporting forms are available on their website, including Chapter 106, Florida Statutes, the *Candidate and Campaign Treasurer Handbook* and the *Calendar of Reporting Dates*. The letter further advised that it was Respondent's responsibility to read, understand, and follow the requirements of Florida's election laws. To review the acknowledgement letter, refer to Exhibit 3.
- 6. The Division sent correspondence to the address provided on the DS-DE 9 notifying Respondent that the following campaign report(s), or the required notification that no reportable activity occurred, had not been filed: 2022 G1 and 2022 G2. The letter(s) included reference to the filing date(s) for the report(s). To review the failure to file correspondence, refer to Exhibit 4.
- 7. On October 24, 2022, the Division sent a letter marked "Final Notice" with delivery confirmation to the address provided on the DS-DE 9 notifying Respondent that the following campaign report(s), or the required notification that no reportable activity occurred, had not been filed: 2022 G1. The letter was confirmed delivered on October 28, 2022. To review the letter marked "Final Notice" and delivery confirmation, refer to Exhibit 5.

¹ Respondent originally filed to run for District 20, but he redesignated to District 23.

² Another form was subsequently filed appointing a new treasurer.

8. On October 24, 2022, the Division sent a letter marked "Final Notice" with delivery confirmation to the address provided on the DS-DE 9 notifying Respondent that the following campaign report(s), or the required notification that no reportable activity occurred, had not been filed: 2022 G2. Dear Mr. Harvey:

On March 9, 2022, the Florida Elections Commission received a complaint alleging that you violated Florida's election laws. I have reviewed the complaint and find that it contains one or more **legally sufficient allegations**. The Commission staff will investigate the following alleged violations:

Section 106.07(7), Florida Statutes: Respondent, a 2022 candidate for State Senator, District 23, failed to notify the filing officer on the prescribed reporting date that no report would be filed on that date because he had not received funds, made contributions, or expended reportable funds during the 2022 G1 and 2022 G2 reporting periods, as alleged in the complaint.

Section 106.19(1)(c), Florida Statutes: Respondent, a 2022 candidate for State Senator, District 23, may have falsely reported or deliberately failed to include information required by Chapter 106, Florida Statutes, during the 2022 G1 and 2022 G2 reporting periods, as alleged in the complaint.

When we conclude the investigation, a copy of the Report of Investigation (ROI) will be mailed to you at the above address. Based on the results of the investigation, a staff attorney will prepare and present a written Staff Recommendation (SR) to the Commission as to whether there is probable cause to charge you, the Respondent, with violating Chapters 104 or 106, Florida Statutes. You will have an opportunity to respond to both the ROI and the SR. The Commission will then hold one or more hearings to determine whether the alleged violations occurred and, if so, the amount of the fine to be imposed upon you. Notice will be mailed to you and the Complainant at least 14 days before any hearing at which your case is to be considered.

Pursuant to Section 106.25(4)(i)3., Florida Statutes, the Commission may enter into a consent agreement with a Respondent to settle a complaint prior to a finding of probable cause. If you are interested in entering negotiations directed towards reaching a consent agreement to resolve this matter, please contact the Commission and request to speak with the attorney assigned to this case.

Pursuant to Section 106.25, Florida Statutes, complaints, investigations, investigative reports, and other documents relating to an alleged violation of Chapters 104 or 106, Florida Statutes, are confidential until the Commission finds probable cause or no probable cause, unless the Respondent files a written waiver of confidentiality with the Commission. The confidentiality provision does not apply to the Complainant or the Respondent.

Should you retain counsel, your attorney must file a notice of appearance with the Commission before any member of the commission staff can discuss this case with him or her.
