Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

**If you are the Respondent**, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

**If you are the Complainant**, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

**If you are an Appellant**, and you have requested a hearing, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

Please refer to the information below for further instructions related to your particular hearing:

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

**SUMMARY:** HCA West Florida Division Good Government PAC is a political committee (PC) registered with the State of Florida. The PC's chair is Juric Sims and its treasurer is Phil Baker.

The PC is appealing the fine. According to the registered agent, Allison Kinney, their PAC compliance vendor uploaded information on September 19, 2024, but "inadvertently logged out of the system." They mistakenly believed the report was submitted. Ms. Kinney notes that once the oversight was discovered, the report was filed immediately. She notes that this is the first occurrence and requests a waiver of the fine.

- The 2024 G2A Original Report covers the period from 09/07/24-09/13/24; it was due on 09/20/24.
- The 2024 G2A Queued Transaction Report shows that it was created on 09/19/24 and filed on 09/23/24.
- HCA West Florida Division Good Government PAC reported receiving zero contributions, while making 72 expenditures.
- The Division of Elections does not have any notes that pertain to HCA West Florida Division Good Government PAC's 2024 G2A report.

To Whom It May Concern:

This letter is a response to the Florida Division of Elections fail to file letter dated October 1, 2024. I am writing to formally request a waiver of the \$150 late filing fine for the HCA West Florida Division Good Government PAC ("the PAC") G2A report, due on September 20, 2024.

On September 19, 2024, our PAC Compliance vendor uploaded all necessary activity into the Florida online reporting system in preparation for filing the PACs G2A report. However, our vendor inadvertently logged out of the system, mistakenly believing the G2A report had been submitted. They realized this oversight on September 23, 2024, while filing waivers the PACs G3 report. Upon discovering the error, our vendor filed the PACs G2A report immediately.

This is the first time such a situation has occurred, and I respectfully request that the fine be waived due to the unintentional nature of the delay and our vendor's prompt correction as soon as the mistake was identified.

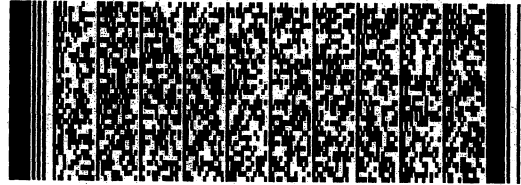
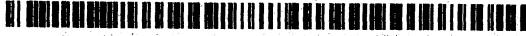

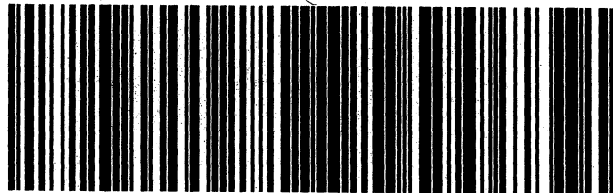

Dear Mr. Sims:

The Florida Elections Commission received a letter from *Allsion Kinney* appealing the fine assessed against your committee for failing to timely file a required report. However, Section 106.07(8)(c), Florida Statutes, provide that only the ***candidate or chair*** of a political committee, may appeal a fine assessed by a filing officer for the late filing of a campaign treasurer's report.

Therefore, to preserve your right to appeal the automatic fine, the Commission must receive your written statement confirming that the person who submitted the initial intent to appeal the fine, was representing you in that request. For your convenience, your signed statement can be submitted via email attachment to, [FEC@myfloridalegal.com](mailto:FEC@myfloridalegal.com).

If we do not hear from you within 14 days from the date of this letter, we will assume that the person signing the letter is neither your attorney nor your personal representative and that you have waived your right to appeal. The Commission will then enter a Default Final Order, ordering you to pay the fine assessed by your filing officer for failing to timely file your campaign treasurer's report.




