**NOTICE OF HEARING (AUTOMATIC FINES (AF))**

A hearing will be held in this case before the Florida Elections Commission on, **August 19, 2025 at 9:00 a.m., or as soon thereafter as the parties can be heard**, at the following location: **Virtual Meeting via Webinar link: <https://register.gotowebinar.com/register/3863768971242962781> and Webinar ID 748-293-987.**

Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

**If you are the Respondent**, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

**If you are the Complainant**, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

**If you are an Appellant**, and you have requested a hearing, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

Please refer to the information below for further instructions related to your particular hearing:

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

**SUMMARY:** Shlomo Danzinger was a candidate for the office of Miami-Dade County Mayor in the 2024 elections. Mr. Danzinger was his own treasurer.

Shlomo Danzinger is appealing the fine claiming that the online submission portal was not available until one to two days before the deadline. According to Mr. Danzinger, he was unable to conduct his financial audit and prepare the report as he typically would. He points out that the late availability of the online submission portal conflicted with his religious practices, which include restrictions on the use of electricity during the Sabbath. He requests a waiver of the fine due to these circumstances.

- The 24P7 Original Report covers the period from 08/03/24-08/15/24; it was due on 08/16/24.
- The 24P7 Report shows that it was filed on 08/17/24.
- Shlomo Danzinger reported receiving zero contributions while making 6 expenditures.
- The Miami-Dade County Supervisor of Elections sent Respondent an email on 08/13/24 reminding him that the report was due on 08/16/24.
- On 10/08/24, Respondent sent an email to the filing officer appealing the fine and stating that he spoke with staff on 06/14/24 about the accessibility of reports before their due dates. The filing officer replied, “[A]ll reports due before the Primary Election were available by June 20, 2024[.]”
- Respondent provided a call log, which reflected one outgoing call to the filing officer on 06/14/24, which lasted 2 minutes.

**RE: Appeal for Fine Dismissal Due to Unusual Circumstances in 24P7 Report Filing**

To Whom It May Concern,

I am writing to formally appeal the fine imposed by the Miami-Dade Department of Elections on September 24, 2024, for the alleged violation of Florida Statute 106.07(8)(b). I respectfully request the dismissal of this fine due to the unusual circumstances surrounding the late filing of the 24P7 Campaign Treasurer's Report submitted on August 17, 2024 (#1327079).

To clarify these circumstances, I would like to highlight a few key points:

1. **Online Submission Portal:** Financial filings for Miami-Dade County elections must be submitted exclusively through an online portal ([https://www.voterfocus.com/CampaignFinance/candidate\\_login.php?county=miamidade](https://www.voterfocus.com/CampaignFinance/candidate_login.php?county=miamidade)).
2. **Report Availability:** All prior reports—24Q2, 24P1, 24P2, 24P3, 24P4, 24P5, and 24P6—were accessible throughout their respective reporting periods. However, the 24P7 report was only made available on the portal a day or two before the submission deadline (August 16, 2024).
3. **Timing of the Deadline:** The 24P7 report was due on a Friday, which as an orthodox Jew, is a day reserved for preparing for the Sabbath. This preparation is essential because the Sabbath involves religious restrictions, including the prohibition of the use of any electricity.

Due to the late availability of the report and the timing of the deadline, I was unable to conduct my financial audit and prepare the report in the usual manner. Unlike previous reports, for which I could enter transactions daily, the late availability of this report required me to complete the entire financial report within a significantly constrained timeframe.

Given these unique and unavoidable circumstances, along with my history of timely reporting, I kindly ask for your understanding and request the dismissal of the fine.

Thank you for your prompt response to my appeal request. I appreciate your time and attention to this matter. In accordance with the letter from your office dated October 15, 2024, I am attaching the document that was missing from my original submission:

- **A copy of the notice of imposition of fine issued by the filing officer. (Fine Ltr)**

As I mentioned in my previous correspondence, I am respectfully appealing to the Commission for the dismissal of this fine. The circumstances surrounding the late submission of report 24P7 clearly align with the State's definition of "Unusual Circumstances" under Florida Administrative Code 2B-1.0055, specifically section (1)(e), which states: *"Computer or equipment failure caused by events that could not have been anticipated and that made timely filing of the report impossible."*

In support of this, my recent email communication with the Miami-Dade County Elections Department (attached) outlines the difficulties I encountered with the County's online portal when attempting to access upcoming financial reports. Unfortunately, I was informed that this behavior was expected at the time, so I did not take screenshots of the issue. As a result, an audit of the system by Miami-Dade County would be necessary to confirm these technical difficulties (please see attached email correspondence with MDCED).

Due to personal circumstances, attending an appeal hearing in person in Tallahassee would be challenging for me. Therefore, I respectfully request that the Commission take into account both the unusual circumstances as defined in Rule 2B-1.0055(1)(e) and my consistent history of timely reporting when considering the dismissal of this fine.

Good morning, Sandy,

Thank you for the confirmation or receipt and your prompt response.

I appreciate your insights, but I would like to clarify my experience with the reporting system, which differs from the information in your email. When my account was assigned, I had access to only three initial reports. Subsequent reports only became available only shortly before their respective reporting periods. Notably, the 24P7 report was only accessible a day or two before its due date.

Consequently, I actually reached out to the Miami-Dade Department of Elections on June 14, 2024 at 2:25 PM EST, shortly after receiving access to the portal, and spoke with Vanessa Innocent regarding this issue. I inquired about my limited access to reports, which was in contradiction to the on-boarding materials I had received when qualifying. I was informed that the additional reports would be available as we approached their deadlines.

As a systems and application architect, I consider myself quite tech-savvy, and I assure you this was not a case of user error. I recommend conducting an audit of the system to ensure it functions as intended, based on my experience.

Dear Mr. Danzinger,

The 24P7 Campaign Treasurer's Report filed with our office was submitted on 8/17/2024 (#1327079). Since this report was not filed by the appropriate filing date, a fine is being assessed for each late day pursuant to Florida Statute 106.07(8)(b).

As such, for reports immediately preceding each primary and general election, the fine shall be \$500.00 per day for each late day. These fines are not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. Therefore, since the report was 1 day late, the fine is \$86.53, which is 25% of your Total Expenditures of \$346.12. Said fine must be received by our office at 2700 NW 87th Avenue, Miami, FL 33172 within twenty (20) days of your receipt of this notice. The check should be made payable to Miami-Dade County paid only from candidate's personal funds.

Florida Statute 106.07(8)(b) goes on to say that the fine may be appealed or disputed based upon unusual circumstances surrounding the failure to file by the designated due date. A hearing before the Florida Elections Commission may be requested, which shall have the authority to waive the fine in part or whole. Any such request must be submitted in writing and must be received by the Florida Elections Commission within 20 days of your receipt of this notice. To request an appeal, please write to the Florida Elections Commission, 107 West Gaines Street, Collins Building, Suite 224, Tallahassee, FL 32399-1050. Our office must also be notified of the intent to bring this matter before the Commission.

I urge you to promptly resolve this matter. If not, in accordance with Florida Statute 106.07(8)(d), we will be required to notify the Florida Elections Commission of this late filing and failure to pay the imposed fine.

**Contributions**

1. Contributions entered must fall within the time period covered by the report.
