NOTICE OF HEARING (AUTOMATIC FINE (AF))

A hearing will be held in this case before the Florida Elections Commission on, **November 14, 2023 at 8:30 a.m., or as soon thereafter as the parties can be heard**, at the following location: **402 South Monroe Street, 12 HOB, Tallahassee, Florida 32399**. Due to heightened security access requirements, please bring only essential items into the building and plan to arrive early to allow for delays coming through security.

Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

If you are the Respondent, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

If you are the Complainant, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

If you are an Appellant, and you have requested a hearing, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

Please refer to the information below for further instructions related to your particular hearing:

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant to Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

SUMMARY: People For A United Florida is a political committee (PC) registered with the State of Florida. The PC's chair is Jason H. Haber and its treasurer is Jason Blank. Attorney Jennifer S. Blohm, Esquire is representing the PC in this matter.

The PC is appealing the fine and requests an opportunity to present argument at a hearing before the Commission as authorized by Rules 2B-1.005 and 2B-1.055, Florida Administrative Code.

According to Jennifer S. Blohm, Esq., the Committee contends that their 2022 G6 report was timely filed, and therefore, no fine should be imposed. She states Mr. Blank, as the treasurer for the Committee, hired Yolanda Brown of Brown Financial and Consulting Services Group LLC to assist him with filing the campaign reports.

Ms. Brown timely filed a waiver for the 2022 G6 reporting period. However, she second-guessed her decision and filed a 2022 G6 Report disclosing financial activity that was previously disclosed on a prior "daily report." This was in error and led to a duplicate reporting of contributions and expenditures. She later deleted the report to reinstate the initial timely filed waiver but was assessed an automatic fine based on the report.

- The 2022G6 Original Report covers the period from 10/22/22-11/03/22; it was due on 11/04/22.
- The 2022G6 Queued Transaction Report shows that it was created and filed on 11/04/22.¹
- People For A United Florida reported receiving zero contributions, while making 1 expenditure.
- FEC staff was advised, "The committee filed a notice of no activity (waiver) on 11/04/22. A waiver is not a report. On 01/11/23, the committee filed a report showing \$4,854.00 of activity. The fine is based on 25% of the activity.
- The Division of Elections does not have any notes that pertain to People For A United Florida's 2022 G6 report.

PRIOR CASES: None.

¹ The filing discussed in this bullet refers to the waiver that reflected zero activity.

Please take notice that our office represents the below listed political committees which by letters dated March 8, 2023, and March 10, 2023, (attached as Exhibit A) have been assessed automatic fines for the 2022 G6 campaign treasurer's report that was due on November 4, 2022.

The Committees appeal the fines which have been imposed and request an opportunity to present argument at a hearing before the Commission as authorized by Rules 2B-1.005 and 2B-1.055, Florida Administrative Code.

The Committees have the same treasurer, Jason Blank, and the reason for the automatic fines and the appeals is the same for all the Committees. The Committees are:

- Latino Rising
- Representative Democracy¹
- Voters for Truth PC
- Building Stronger Communities
- Activate Florida PC

¹ The reason for the automatic fine is the same for the committee, Representative Democracy, as the other committees. However, the daily report that was timely filed also has been amended to correct a bank credit that was incorrectly reported as an expenditure (\$21.07).

The basis for the appeals is that the Committees contend that their 2022 G6 reports were timely filed, and therefore, no fines should be imposed. Mr. Blank, as the treasurer for the Committees, hired Yolanda Brown of Brown Financial and Consulting Services Group LLC to assist him with filing the campaign reports for the Committees. Ms. Brown timely filed the daily reports due for the Committees during the 2022 election cycle. She, then, timely filed a waiver for each of the Committees for the 2022 G6 report on November 4, 2022. However, Ms. Brown second guessed her decision to file the waivers instead of re-reporting the contributions and expenditures she had reported on the daily reports. Therefore, she filed amendments to the 2022 G6 reports and re-reported the contributions and expenditures that she had already timely reported on the daily reports. The amendments to the waiver reports generated the automatic fines at issue in this appeal.


The filing of the amendments was in error. She should not have re-reported the contributions and expenditures (results in incorrect duplicate reporting). The initial, timely filed waivers were correct. The amendments have now been deleted, and the reporting is now correct. Based on these facts which are verified in the attached Declaration by Ms. Brown (attached as Exhibit B), the Committees respectfully request that the automatic fines be removed from all the Committees since the 2022 G6 reports were timely filed (the initial waivers).

4. Later, I second guessed my decision to file the waiver reports and determined that I needed to file amendments to the 2022 G6 reports listing the contributions and expenditures for each committee that I had already reported on the daily reports. I filed the amendments for each of the committees.

5. When Mr. Blank began receiving the automatic fine letters and spoke to me about what happened, I realized that the amendments were filed in error and the initial, timely filed waiver reports were correct.

6. I have removed the incorrectly filed amendments so that the committees' reporting is correct and reflects a waiver for the 2022 G6 reports.

Under penalties of perjury, I declare that I have read the foregoing and the facts stated in it are true.

due date, the report will be accepted as timely filed if filed no later than midnight, Eastern Standard Time, of the first business day the EFS becomes operable. No fine will be levied during the period the EFS was inoperable.

Any political committee failing to file a report on the designated due date is subject to a fine of \$50 per day for the first three days late and, thereafter, \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for the reports immediately preceding each primary and general election, the fine shall be \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

Electronic Receipts

The person submitting the report on the EFS will be issued an electronic receipt indicating and verifying the report was filed. Each campaign treasurer's report filed by means of the EFS is considered to be under oath by the chairperson and campaign treasurer, and such persons are subject to the provisions of Section 106.07(5), Florida Statutes.





