**SUMMARY:** Rodney Jacobs was a candidate for State Senator, District 35 in the 2024 elections. Mark Herron, Esquire was his treasurer. Mr. Herron is representing the candidate in this matter.

Rodney Jacobs is appealing the fine and requests a hearing before the Commission. According to Mr. Herron, the report was submitted beyond the deadline because the Division did not provide the newly appointed treasurer's credentials. He claims that once the initial campaign treasurer resigned, he started filing as the campaign's deputy treasurer. His credentials as Deputy Treasurer were revoked by the Division on June 11, 2024, following the filing of the DS-DE 9, which named him as the campaign treasurer. He claims that despite his repeated attempts to contact the Division of Elections support desk, the problem was not rectified until June 26, 2024.

- The 2024 P1 Original Report covers the period from 06/01/24-06/14/24; it was due on 06/21/24.
- The 2024 P1 Queued Transaction Report shows that it was created on 06/03/24 and filed on 06/26/4.
- Rodney Jacobs reported receiving 13 contributions, while making 23 expenditures.
- The Division of Elections provided one note that pertains to Rodney Jacobs' 2024 P1 report. On 06/26/24, DOE staff provided Mr. Herron with his credentials. The note also mentions Mr. Herron's issue with the transition from deputy treasurer to campaign treasurer.

PRIOR CASES: None.

Appeal of Fine Imposed for Late-Filed Campaign Treasurer's Report

Rodney Jacobs, through undersigned counsel, appeals the fine imposed by the Division of Elections in connection with a late filed campaign treasurer's report, pursuant to Section 106.07(8)(c), Florida Statutes. With respect to this appeal, Mr. Jacobs requests a hearing before the Florida Elections Commission ("FEC"). Mr. Jacobs disputes the assessed fine, based upon, but not limited to unusual circumstances, surrounding the failure to file the P1 report on the designated due date.

On or about June 28, 2024, Donna Brown, Chief, Bureau of Elections Records, sent a letter to Mr. Jacobs indicating that the 2024 P1 campaign treasurer's report that was due on June 21, 2024, was filed on June 26, 2024, and that a late fine of \$870.55 had been assessed. A copy of that letter accompanies this appeal.

The report was late due to the failure of the Division to provide credentials to the newly appointed treasurer, when a DE-DE 9 was filed on June 11, 2024,

naming Mark Herron the campaign treasurer.<sup>1</sup> Prior to June 11, Mr. Herron served as the deputy campaign treasurer.<sup>2</sup> Upon being named as the campaign treasurer, the Division cancelled Mr. Herron's credentials to file the campaign treasurer's report as the deputy treasurer but did not provide him with new credentials to file as treasurer. This issue was not resolved until June 26, 2024.

On over sixty occasions, Mr. Herron and his administrative assistant attempted to file the 2024 P1 campaign treasurer's report on June 21, 2024. Mr. Herron's assistant spoke with Help Line personnel on June 21, 2024, regarding the problem and was informed it was a "traffic issue." At that time, she was advised that the report would be deemed timely filed. Mr. Herron continued to attempt to file the report on numerous occasions until 11:59 p.m. on June 21, 2024, and after midnight on June 22, 2024. Mr. Herron again attempted to file the report on Saturday June 22 and on Sunday June 23, 2014.

On Monday June 24, Mr. Herron again attempted to file the report without success. He subsequently called the Division's Help Desk to report his continued inability to file the report, at which time he described the message

he received each time he attempted to file the report. He was asked to send a screenshot to the Help Desk, which he did via <a href="mailto:electrecords@dos.myflorida.com">electrecords@dos.myflorida.com</a> He was advised that the Help Desk personnel would get back with him about the issue.

Hearing nothing on June 24 or June 25, Mr. Herron went to the Division on the morning of June 26, 2024. After explaining the issue again to the Help Desk personnel, he was again advised that there had been a "traffic issue." Disagreeing with that explanation, Mr. Herron showed the screenshot that he had previously forwarded to the Help Line personnel who were assisting him. Shortly after that, it was determined that when the Division cancelled Mr. Herron's deputy treasurer credentials, it did not provide him with new credentials to file as treasurer. Once he received new credentials, Mr. Herron promptly filed the 2024 P1 campaign treasurer's report that was due on June 21, 2024, on June 26, 2024.

### Conclusion

Based on the foregoing, Mr. Jacobs respectfully requests that the FEC take up this appeal, grant him a hearing as requested, and waive the assessed fine, in whole or in part, based on the standards set out in Section 106.07(8)(c), Florida Statutes.

Dear Mr. Jacobs:

Our records indicate that you have not filed either your campaign treasurer's report or notification that no reportable activity occurred, whichever is applicable. The filing date was June 21, 2024.

The law (s. 106.07(8)(b), Fla. Stat.) requires the filing officer to immediately notify you about the missed filing date and the automatic fines that will be assessed for late filing of a report, if a report was due.

- If reportable activity occurred and you have not filed a report, statutory fines are automatically assessed as follows until you file your report:
  - \$50 per day for the first 3 days late
  - 9 \$500 per day for each day after the 3rd day late
  - If the required report immediately precedes a primary and general election, the automatic fine is \$500 for each late day.

The total fine for the untimely report cannot exceed 25% of the total receipts or expenditures, whichever is greater, for the cover period. Even if you end up filing your report late, we cannot waive the statutory fines. We will notify you of the specific amount of fines owed once you file your report. You have 20 days from the day you receive the notice to pay the fine or to appeal the fine to the Florida Elections Commission.

• If no reportable activity occurred for the report date(s), you are still required to notify us in writing, via the Division's Electronic Filing System, that no reportable activity occurred. No automatic fines are statutorily assessed.

However, in all cases, failure to file and/or untimely filing of a report of reportable activity, or if applicable, a notice that no reportable activity occurred, may constitute an apparent violation of chapter 106, Fla. Stat. If we refer such matter to the Florida Elections Commission, the Commission may subsequently impose a civil penalty for each violation under chapter 106.265(1), Fla. Stat.

All reports filed must be completed and filed through the EFS no later than midnight, Eastern Standard Time, of the due date. Reports not filed by midnight of the due date are late filed and subject to the penalties in Section 106.07(8), Florida Statutes. In the event that the EFS is inoperable on the due date, the report will be accepted as timely filed if filed no later than midnight of the first business day the EFS becomes operable. No fine will be levied during the period the EFS was inoperable.

Any candidate failing to file a report on the designated due date shall be subject to a fine of \$50 per day for the first three days late and, thereafter, \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for reports immediately preceding each primary and general election, the fine shall be \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

### **Electronic Receipts**

The person submitting the report on the EFS will be issued an electronic receipt indicating and verifying the report was filed. Each campaign treasurer's report filed by means of the EFS is considered to be under oath by the candidate and campaign treasurer, and such persons are subject to the provisions of Section 106.07(5), Florida Statutes.
