You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

- The 2024 P1 Report shows that it was filed on 06/22/24.
- Christopher Gleason reported receiving 66 contributions, while making 1 expenditure.
- The Pinellas County SOE’s office provided notes that pertain to Christopher Gleason’s 2024 P1 report.

Your P2 Campaign Finance Report was received on July 6, 2024 at 12:02:41 a.m., which was after the reporting deadline of Midnight (Eastern Time), July 5, 2024.

**Pursuant to F.S. §106.07, any candidate who fails to file a report by the designated due date is subject to a fine, paid only by personal funds.** The fine shall be \$50.00 per day for the first 3 days late and, thereafter, \$500.00 per day for each late day, not to exceed 25% of the total receipts (contributions) or expenditures, whichever is greater, for the period covered by the late report. Therefore, you are required to pay a fine of \$50.00.

**The \$50.00 fee or appeal is due by Sunday, July 28, 2024. Pursuant to Florida Statute §106.07(8)(b), the fine shall be paid to the Supervisor of Elections within twenty days after receipt of notice of payment due, unless an appeal is made to the Florida Elections Commission.**

This statement is part of the above-referenced case regarding Christopher Gleason, Candidate for Pinellas County Supervisor of Elections for the August 20, 2024 Primary Election. Mr. Gleason filed a late P1 Campaign Finance Report and did not pay the \$50.00 fine. Mr. Gleason appealed to your office via email on July 16 at 5:06 p.m. but failed to notify our office pursuant to Section 106.07(8)(c), Florida Statutes.

On June 10, 2024, Mr. Gleason appeared in person at our office to announce his candidacy. At that time, staff provided Mr. Gleason with the 2024 County and Special District Candidate Reporting Dates and an explanation of the dates each campaign finance report was due. Additionally, Mr. Gleason was provided a printed copy of the 2024 Candidate Handbook and the "How To File Campaign Finance Reports Online" manual, which provides easy-to-follow, step-by-step instructions with pictures and illustrations as to how to navigate the campaign finance portal and to file campaign reports. Mr. Gleason also signed his Statement of Candidate, acknowledging access to read and understand the requirements of Chapter 106, Florida Statutes. Finally, Mr. Gleason signed and hand-delivered on June 14 his Acknowledgement of Electronic Filing Information form, which stresses that "Campaign Treasurer Reports must be electronically filed **no later than Midnight (Eastern Time)** of the reporting due date [...] or they are deemed filed late and are subject to the applicable penalties..."

Mr. Gleason was reminded via email of the midnight June 21 (Eastern time) deadline for his P1 report. The email reminders were sent to Mr. Gleason on June 14 at 4:24 p.m. and June 20 at 1:53 p.m.

Mr. Gleason did not start his P1 report until 7:44 p.m. June 21, the evening the report was due. Between 7:53 and 11:29 p.m., he input 36 contributions, and then took no further action. Per our practice, the next morning staff called Mr. Gleason to make him aware that our office had not received his P1 report. Mr. Gleason accused staff of "deleting his report" and told staff that they were "committing treason."

Following our phone call, Mr. Gleason logged in at 10:38 a.m. on June 22, and between 8:41 and 10:46 p.m. he input 38 contributions and expenditures. Finally, at 10:48 p.m. Mr. Gleason

generated and submitted his report, approximately 23 hours after the reporting deadline of Midnight (Eastern Time), June 21, 2024. The logs do not indicate any attempt to generate or submit the report prior to the deadline.


Because Mr. Gleason was less than 3 days late, he was required to pay a fine of \$50.00 from personal funds or appeal the fine within 20 days of receipt, pursuant to Florida Statute Section 106.07(8)(b). He was notified of this disposition via email June 27.

At no time was the Supervisor of Elections informed or notified by our C-Finance vendor (VR Systems) of a system error or malfunction. Nor did Mr. Gleason ever notify our office of any issues or reach out for assistance. Every other candidate for this election was able to timely file all their reports, including the P1.

Mr. Gleason has publicly acknowledged the late reports, stating, *"The Florida Elections Complaint that [the Pinellas County SOE] filed against me...not once but twice...but what they filed this complaint against me over was the fact that I filed my campaign finance report late. [P1] was a submission error [...] and [P2], was, I was three minutes late, and it was a navigation issue with their software."*<sup>1</sup> Yet in his appeal to the Commission for the late P1 report, the only reason Mr. Gleason gave for the appeal was "I had tried to submit the report and there appeared to be an issue when I received a notification the next day." A basis for an appeal of a late report is, generally, "unusual circumstances surrounding the failure to file on the designated due date." Section 106.07(8)(c), Florida Statutes. There is no log that indicates Mr. Gleason attempted to submit his P1 on June 21.

Per your letter dated August 13, 2024, we have enclosed the report that was filed late (Ex. A), the emails reminding the candidate that the P1 was due (Ex. B), the filing officer's failure to file email and letter (Ex. C), the filing officer's fine email and letter (Ex. D), the certified mail receipt that the fine letter was received (Ex. E), the Appointment of Campaign Treasurer and Designation of Campaign Depository form (Ex. F), the filing history (Ex. G), the Statement of Candidate Oath (Ex. 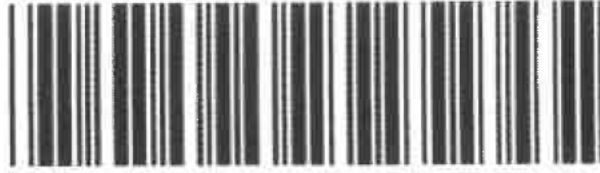

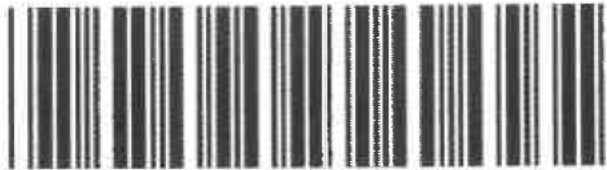



4. **Alternative Procedure for Inoperable Electronic Filing System**
