#### ORDER OF PROBABLE CAUSE

#### Count 3:

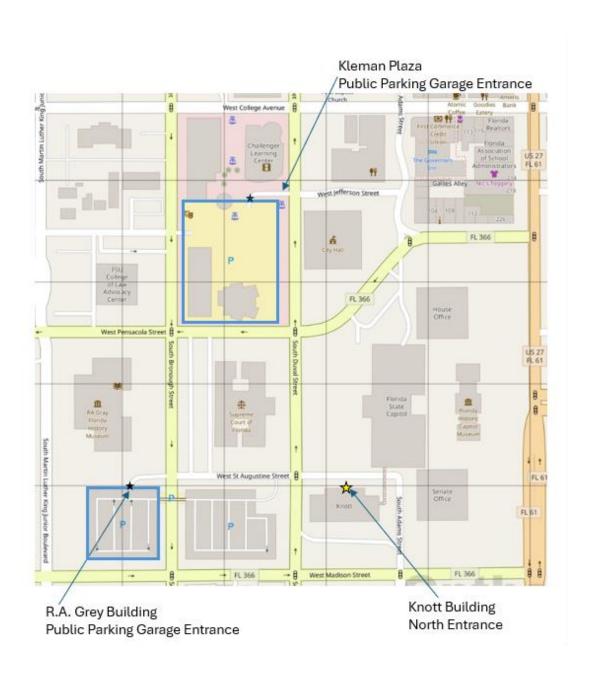

Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, he must provide the Commission with written proof of his financial resources at the hearing. A financial affidavit form is available from the Commission Clerk.

#### STAFF RECOMMENDATION FOLLOWING INVESTIGATION

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the sworn complaint in this case recommending that there is **probable cause** to charge Respondent with violating **Sections 106.143(1)(c)**, and **106.03(4)**, **Florida Statutes**. Based upon a thorough review of the Report of Investigation submitted on June 11, 2024, the following facts and law support this staff recommendation:

- 1. On May 4, 2022, the Florida Elections Commission ("Commission") received a sworn complaint from Joel Keller ("Complainant"), alleging that Citizens for the Advancement of Ocoee ("Respondent") violated Chapter 106, Florida Statutes.
- 2. Respondent is a political committee registered with the Orange County Supervisor of Elections. On November 25, 2020, Respondent filed its Statement of Organization of Political Committee ("DS-DE 5") with the Orange County Supervisor of Elections. (ROI Exhibit 1)<sup>1</sup>
- 3. By letter dated April 9, 2024, the Executive Director notified Respondent that Commission staff would investigate the following statutory provisions:

Section 106.143(1)(c), Florida Statutes: Respondent, a political committee registered with the Orange County Supervisor of Elections, may have paid for and distributed political advertisements in the form of signs that contained express advocacy but did not include a proper disclaimer, as alleged in the complaint.

**Section 106.03(4), Florida Statutes**: Respondent, a political committee registered with the Orange County Supervisor of Elections, may have failed to timely file an amended DS-DE 5 form reflecting the candidate it supported, as alleged in the complaint.

#### Alleged Violation: Section 106.143(1)(c) Florida Statutes

4. Complainant alleged that Respondent violated Florida's election laws by failing to include a proper disclaimer on two political advertisements.

- 5. Under Section 106.143(1)(c), Florida Statutes, political advertisements are required to be marked with the proper statutory disclaimer ("paid political advertisement" or "pd. pol. adv."), the name and address of the persons paying for the advertisement, and state whether the advertisement was paid for or provided in kind.
- 6. The advertisements at issue are two signs which encourage the reader to vote for George Oliver. (ROI Exhibits 5 & 6) The signs meet the definition of a "political advertisement" as they expressly advocate for the election of a candidate. §106.011(15), Fla. Stat. The ads contain the following disclaimers: "POLITICAL ADVERTISEMENT PAID FOR AND APPROVED BY CITIZENS FOR THE ADVANCEMENT OF OCOEE" and "POLITICAL ADVERTISEMENT PAID FOR BY CITIZENS FOR THE ADVANCEMENT OF OCOEE." (ROI Exhibit 5, page 1; Exhibit 6, page 1) The ads do not contain the specific language required by the statute, i.e., "paid political advertisement" or "pd. pol. adv." followed by the name and address of the persons paying for the advertisement.
  - 7. Respondent did not file a response to the investigation. (ROI Exhibit 7)
- 8. Respondent paid for and published two political advertisements that did not include a proper disclaimer.

#### Alleged Violation: Section 106.03(4), Florida Statutes

- 9. Complainant alleged that Respondent violated Florida's election laws by failing to timely file an amended DS-DE 5 disclosing its support of candidate George Oliver.
- 10. Under Section 106.03(4), Florida Statutes, "[a]ny change in information previously submitted in a statement of organization shall be reported to the agency or officer with whom such committee or electioneering communications organization is required to register within 10 days following the change."
- 11. On November 25, 2020, Respondent filed its DS-DE 5 with the Orange County Supervisor of Elections. Respondent's DS-DE 5 indicated that it was not supporting any candidates. (ROI Exhibit 1) On September 21, 2021, Respondent filed an amended DS-DE 5; however, the DS-DE 5 was filed after George Oliver's election. (ROI Exhibit 9) A Commission staff investigator requested copies of the DS-DE 5s on file with the Orange County Supervisor of Elections and the above-referenced forms were the only ones provided. (ROI, p. 3, ¶ 18)
- 12. Complainant provided photos of two political advertisements which expressly advocated for George Oliver and were attributable to Respondent. The photos show the political advertisements being displayed at an event and in front of a residence. (ROI Exhibit 5, pages 2 & 3; ROI Exhibit 6, page 2)
- 13. On February 27, 2021, George Oliver made a social media post stating that one of the signs (as shown in ROI Exhibit 6) was replaced. (ROI Exhibit 8) Therefore, Respondent was supporting candidate George Oliver on or before February 27, 2021, but failed to timely file an amended DS-DE 5 disclosing its support of the candidate.

- 14. "Probable Cause" is defined as reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. *Schmitt v. State*, 590 So. 2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. *Department of Highway Safety and Motor Vehicles v. Favino*, 667 So. 2d 305, 309 (Fla. 1st DCA 1995).
- 15. The facts set forth above show that Respondent is a political committee registered with the Orange County Supervisor of Elections. Respondent paid for and published two political advertisements that did not include a proper disclaimer. Respondent failed to timely file an amended DS-DE 5 disclosing its support of candidate, George Oliver.

Based upon these facts and circumstances, I recommend that the Commission find **probable cause** to charge Respondent with violating the following:

#### Count 1:

On or around February 27, 2021, Citizens for the Advancement of Ocoee violated Section 106.143(1)(c), Florida Statutes, when it paid for and published a political advertisement that contained express advocacy but did not include a proper disclaimer.

#### Count 2:

On or around February 27, 2021, Citizens for the Advancement of Ocoee violated Section 106.143(1)(c), Florida Statutes, when it paid for and published a political advertisement that contained express advocacy but did not include a proper disclaimer.

#### Count 3:

On or around March 9, 2021, Citizens for the Advancement of Ocoee violated Section 106.03(4), Florida Statutes, when it failed to report a change of information in its Statement of Organization to its filing officer within 10 days following the change.

On May 4, 2022, the Florida Elections Commission (Commission) received a sworn complaint alleging that Respondent violated Chapters 104 or 106, Florida Statutes. Commission staff investigated whether Respondent violated the following statute(s):

Section 106.143(1)(c), Florida Statutes, may have paid for and distributed political advertisements in the form of signs that contained express advocacy but did not include a proper disclaimer; and

Section 106.03(4), Florida Statutes, may have failed to timely file an amended DS-DE 5 form reflecting the candidate it supported.

#### I. Preliminary Information:

- 1. Respondent is a political committee registered with the Orange County Supervisor of Elections (SOE).
- 2. On November 25, 2020, Respondent filed a Statement of Organization form (DS-DE 5) with the SOE. Rhiannon Arnold was noted to be Respondent's Chairperson. To review the DS-DE 5, refer to Exhibit 1.
- 3. On November 25, 2020, Respondent also filed an Appointment of Campaign Treasurer and Designation of Campaign Depository form (DS-DE 6) with the SOE. Alfred Carson, Jr., was appointed campaign treasurer. To review the DS-DE 6, refer to Exhibit 2.
- 4. In an affidavit, SOE staff attested that on November 25, 2020, Respondent was provided a committee packet, or similar material, that included links to the websites of the Division of Elections and/or the SOE, where documents such as Chapter 106, F.S., and the *Political Committee Handbook* were available for review. SOE staff further attested that Rhiannon Arnold ran for 9<sup>th</sup> Circuit Court Judge, Group 1, in 2020 but was not elected. To review the SOE staff affidavit, refer to Exhibit 3.
- 5. On November 25, 2020, the SOE sent Respondent's Treasurer a letter acknowledging receipt of the DS-DE 6 and advising him to "Please visit the Division of Elections website at dos.myflorida.com/elections/ for copies of Florida Statutes and the Political Committee

Handbook." A copy of this letter was sent to Chairperson Arnold. To review the acknowledgment letter, refer to Exhibit 4.

#### II. Alleged Violation of Section 106.143(1)(c), Florida Statutes:

- 6. I investigated whether Respondent violated this section of the election laws by failing to include a proper disclaimer on political advertisement signs.
- 7. Specifically, Complainant alleged that Respondent paid for and distributed signs advocating for the re-election of George Oliver III, the 2021 incumbent candidate for City of Ocoee Commissioner, District 4. Mr. Oliver was re-elected in the municipal election held on March 9, 2021.
- 8. Complainant provided photos of the two different signs at issue. The first sign states, "RE-ELECT GEORGE OLIVER FOR CITY OF OCOEE COMMISSIONER DISTRICT 4...VOTE MARCH 9<sup>TH</sup>." A disclaimer at the bottom states, "POLITICAL ADVERTISEMENT PAID FOR AND APPROVED BY CITIZENS FOR THE ADVANCEMENT OF OCOEE." One photo shows a close-up of the sign, and two other photos show the sign being displayed at an event. To review the photos of the first sign, refer to Exhibit 5.
- 9. The second sign also states, "RE-ELECT GEORGE OLIVER FOR CITY OF OCOEE COMMISSIONER DISTRICT 4" and "VOTE MARCH 9<sup>TH</sup>." The arrangement of the phrase "VOTE MARCH 9<sup>TH</sup>" is different from the other sign, and this sign includes a photograph of Mr. Oliver. The disclaimer on the second sign states, "POLITICAL ADVERTISEMENT PAID FOR BY CITIZENS FOR THE ADVANCEMENT OF OCOEE." One photo shows a close-up of the sign, and another photo shows three of the signs being displayed on a front lawn. To review the photos of the second sign, refer to Exhibit 6.
- 10. Section 106.143(1)(c), F.S., sets forth the requirements for disclaimers on any other political advertisement paid for and distributed by someone other than a candidate. Specifically, it states, "Any other political advertisement published, displayed, or circulated before, or on the day of, any election must prominently: 1. Be marked 'paid political advertisement' or with the abbreviation 'pd. pol. adv.' 2. State the name and address of the persons paying for the advertisement. 3. State whether the advertisement and the cost of production is paid for or provided in kind by or at the expense of the entity publishing, displaying, broadcasting, or circulating the political advertisement."
  - 11. Respondent did not respond to the complaint.
- 12. I sent Respondent's attorney an affidavit posing pertinent questions about the complaint in order to provide Respondent the opportunity to respond to the allegations in the complaint. However, as of the date of this report a completed affidavit has not been returned. Therefore, I am unable to determine whether Respondent's Chairperson and/or Treasurer possess and have read Chapter 106, F.S., and the *Political Committee Handbook*. To review the emails and affidavit, refer to Exhibit 7.

### III. Alleged Violation of Section 106.03(4), Florida Statutes:

- 13. I investigated whether Respondent violated this section of the election laws by failing to file an amended DS-DE 5 form with the SOE reflecting the candidate it supported within 10 days following the change.
- 14. Specifically, Complainant alleged that Respondent was supporting the re-election of George Oliver III, the 2021 incumbent candidate for City of Ocoee Commissioner, District 4, but failed to file an amended DS-DE 5 disclosing that information. Mr. Oliver was re-elected in the municipal election held on March 9, 2021.
- 15. As noted above, Respondent initially filed its DS-DE 5 with the SOE on November 25, 2020. At section 3 of the DS-DE 5, Respondent's area, scope, and jurisdiction was stated as follows: "The Citizens for the Advancement of Ocoee is a Political Action Committee that was formed by a group of Ocoee and Orange County residents to support initiatives and political candidates that are interested in Ocoee's and West Orange County's infrastructure (roads, highways, traffic control devices, storm water, and 5G connectivity) and Social Initiatives." At section 7 of the DS-DE 5, which asked for the name, address, office sought, and party affiliation of "Each Candidate or Other Individual that this Committee is Supporting," Respondent stated, "None." To review the initial DS-DE 5, refer to Exhibit 1.
- 16. Complainant provided photos of political advertisement signs that expressly advocated for the re-election of Mr. Oliver. The photos pictured the signs being publicly displayed at an event and on a front lawn. The disclaimers on the signs stated, "POLITICAL ADVERTISEMENT PAID FOR AND APPROVED BY CITIZENS FOR THE ADVANCEMENT OF OCOEE" and "POLITICAL ADVERTISEMENT PAID FOR BY CITIZENS FOR THE ADVANCEMENT OF OCOEE," respectively. To review the photos of the signs, refer to Exhibits 5-6.
- 17. Complainant also provided a screenshot of a social media post made by Mr. Oliver on February 27, 2021. The post stated, "Three signs were stolen and three signs have been replaced." Included within the post was a photo showing three of the signs referenced above in paragraphs 9 and 16, which contained disclaimers specifying that Respondent had paid for the signs. That post is evidence that Respondent took overt actions to support Mr. Oliver's re-election campaign in the form of the signs. These actions were taken on or before February 27, 2021, which was the date of the post in which the signs were shown publicly displayed. Therefore, an updated DS-DE 5 form should have been filed within 10 days of that post, at the latest. To review the post, refer to Exhibit 8.
- 18. The SOE provided copies of Respondent's DS-DE 5s on file with their office, which included the initial DS-DE 5 and another DS-DE 5 filed on September 21, 2021. The second DS-DE 5 was not filed until several months after the election in which Mr. Oliver had been reelected. The second DS-DE 5 was not filed until approximately seven months after the social media post evidencing that signs supporting Mr. Oliver's re-election campaign and paid for by Respondent were publicly displayed. The second DS-DE 5 specified the same area, scope, and jurisdiction at section 3 and still did not specify a candidate Respondent was supporting at section 7, which still stated, "None." To review the second DS-DE 5, refer to Exhibit 9.

- 19. Respondent did not respond to the complaint.
- 20. I sent Respondent's attorney an affidavit posing pertinent questions about the complaint in order to provide Respondent the opportunity to respond to the allegations in the complaint. However, as of the date of this report a completed affidavit has not been returned. Therefore, I am unable to determine whether Respondent's Chairperson and/or Treasurer possess and have read Chapter 106, F.S., and the *Political Committee Handbook*. To review the emails and affidavit, refer to Exhibit 7.

On May 4, 2022, the Florida Elections Commission received a complaint alleging that your client violated Florida's election laws. I have reviewed the complaint and find that it contains one or more **legally sufficient allegations**. The Commission staff will investigate the following alleged violations:

Section 106.143(1)(c), Florida Statutes: Respondent, a political committee registered with the Orange County Supervisor of Elections, may have paid for and distributed political advertisements in the form of signs that contained express advocacy but did not include a proper disclaimer, as alleged in the complaint.

Section 106.03(4), Florida Statutes: Respondent, a political committee registered with the Orange County Supervisor of Elections, may have failed to timely file an amended DS-DE 5 form reflecting the cardiclate it supported, as alleged in the complaint.

When we conclude the investigation, a copy of the Report of Investigation (ROI) will be mailed to you at the above address. Based on the results of the investigation, a staff attorney will prepare and present a written Staff Recommendation (SR) to the Commission as to whether there is probable cause to charge your client with violating Chapters 104 or 106, Florida Statutes. You will have an opportunity to respond to both the ROI and the SR. The Commission will then hold one or more hearings to determine whether the alleged violations occurred and, if so, the amount of the fine to be imposed upon your client. Notice will be mailed to you and the Complainant at least 14 days before any hearing at which your case is to be considered.

Pursuant to Section 106.25(4)(i)3., Florida Statutes, the Commission may enter into a consent agreement with a Respondent to settle a complaint prior to a finding of probable cause. If you are interested in entering negotiations directed towards reaching a consent agreement to resolve this matter, please contact the Commission and request to speak with the attorney assigned to this case.

# Complaint Against Chairman Rhiannon Arnold Citizens for Advancement of Ocoee PC Statement of Facts

George Oliver, III ("Oliver") was a successful candidate for election in the 2021 City of Ocoee Municipal Election, District 4. Before and during the 2021 election, Oliver and the political committee, Citizens for the Advancement of Ocoee ("PC") violated Florida's campaign finance laws related to independent expenditures, coordination, contribution limits, campaign reporting and political disclaimers.

Several political advertisements were produced for Oliver saying "re-elect" Oliver, but there are no expenses for these advertisements appearing on Oliver's campaign reports. It is abundantly clear that Oliver's entire campaign circumvented election law when the affiliated PC's 3-4 large donors paid for Oliver's entire campaign. I have personally reviewed the PC's contribution and expenditure reports, Oliver's contribution and expenditure reports, and political advertisements, collateral material and pictures/videos posted by the Oliver Campaign, and it appears that all Oliver campaign advertising and collateral material was paid for by the PC.

To my knowledge, none of Oliver's campaign collateral was compliant with laws relating to political advertising or electioneering communications. *See ss. 106.143, 106.1439, F.S.* The ads, referenced in more detail below, instructed voters to "re-elect" or "vote for" George Oliver. There is also plenty of evidence of coordination, inkind contributions from the PC to the Oliver Campaign, and excess contribution violations between the PC and Oliver Campaign, set forth in more detail below.

#### A. Evidence of Coordination Violations

I am of the belief that Ms. Myers does not have the financial wherewithal to make such a large contribution to the PC thus, I have concerns that this contribution actually came from someone else and was simply funneled through Ms. Myers' business. #### **B. Evidence of Contribution Violations**

1. Yard Signs & Large Signs – All signs say "re-elect" Oliver, but the disclaimer indicates that the signs are paid for by the PC (total cost, \$2,306.53).

9. Every publication I have reviewed appears to violate election laws with "Re-elect George (Oliver." The listed purposes on the PC's expenditure reports also reiterates that it was spending a lot on behalf of the Oliver Campaign, and likely with the input of Oliver or his campaign staff. Therefore, these additional expenses should also be investigated because a strong pattern of coordination has been established. The PC should be required to produce any collateral material and support for the following expenses (total costs, \$1,659.34):

"Megaphone speaker for campaign" - \$50

"Social media advertising" - \$75

"Catering services" - \$160

"Campaign mailers" - \$470

"Deposit for food for campaign staff" - \$500

"Event planning for campaign event" - \$180

"Flyers for the campaign" - \$124.34

"Social media marketing" - \$100

#### C. Miscellaneous Violation

Finally, the PC filed its Statement of Organization, Form DS-DE 5, on November 25, 2020. In Box 7 of page two, the PC represented that it was <u>not</u> supporting any candidates (Listing "NONE.") and made no mention of the Oliver Campaign. In fact, the PC represented that it was only supporting the "ONE OCOEE initiative" (Box 8). It is clear that the PC was in fact supporting the Oliver Campaign, but failed to disclose this fact in its Statement of Organization (or any updates thereto). See s. 106.03(2)(f), F.S.

#### CONCLUSION

It is abundantly clear that the PC, with the cooperation and coordination of the Oliver Campaign, circumvented campaign election laws by running Oliver's campaign for Ocoee City Commission through the PC. There is ample evidence that the PC expenditures referenced above were coordinated with the Oliver Campaign, and therefore, should be treated as "in-kind contributions" to the Oliver Campaign. "In-kind" contributions, like monetary contributions are subject to the contribution limits references in section 106.08, Florida Statutes. This was likely done to enable large contributors to fund 95% of Oliver's campaign because he was unable to raise it from individual supporters. As a candidate who ran against Mr. Oliver in the 2021 election, I have personal knowledge of these allegations and ask that the Florida Elections Commission investigate such allegations.
