If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

Assessment of Late Fine

Your campaign treasurer's report due June 21, 2024, was received in my office on July 5, 2024. Therefore, pursuant to Chapter 106.07(8)(b), F.S., your report was 14 days late and subject to a fine.

Florida Statute 106.07 states any candidate failing to file a report on the designated due date shall be subject to a fine of \$50 per day for the first three days late and, thereafter, \$500 per day for each late day, not to exceed 25 percent of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for the reports immediately preceding the primary and general election, the fine shall be \$500 per day for each late day, not to exceed 25 percent of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

The Division of Elections, Department of State, has confirmed that Saturdays, Sundays and Holidays must be included when assessing this fine. Thus, your fine is \$2,788.75 (25% of your Total Contributions of \$11,155.00).

This fine is not an allowable campaign expenditure and your personal funds must be used to pay this fine. (An officer or member of a political committee shall not be personally liable for such fine.) This fine must be paid within 20 days of receipt of this notice, unless appeal or request for a hearing is made to the Florida Elections Commission. 
