**NOTICE OF HEARING (AUTOMATIC FINE (AF))**

A hearing will be held in this case before the Florida Elections Commission on, **April 22, 2026 at 10:00 a.m.**, or as soon thereafter as the parties can be heard, at the following location: via Webinar at: **Registration URL** <https://attendee.gotowebinar.com/register/17181422935246175>, **Webinar ID 325-697-827.**

Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

**If you are the Respondent**, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

**If you are the Complainant**, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

**If you are an Appellant**, and you have requested a hearing, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

Please refer to the information below for further instructions related to your particular hearing:

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

**SUMMARY:** The Honorable Elizabeth Gibson was a candidate for Circuit Judge, Circuit 9, Group 11 in the 2024 elections. Jessica Ortiz was her treasurer.

Judge Elizabeth Gibson is appealing the fine. According to the treasurer, Jessica Ortiz, she received a phone call from the Division of Elections on August 12, 2024, stating that the report was not filed. She said that the report was submitted on May 14, 2024, and that staff confirmed that the last activity did happen on that date. A staff member advised her to resubmit the report and remained on the line to verify its submission. Ms. Ortiz also notes that communication from DOE was sent to a closed post office box, and they were unaware of online notices until receiving advice from other campaign representatives. She requests a waiver of the fine based on a change in communication from the Division of Elections.

- The 2024 TR Original Report covers the period from 04/01/24-07/25/24; it was due on 07/25/24.
- The 2024 TR Queued Transaction Report shows that it was created on 05/14/24 and filed on 08/12/24. It was subsequently amended on 11/11/24.
- Elizabeth Gibson reported receiving zero contributions, while making 111 expenditures.
- The Division of Elections does not have any notes that pertain to Elizabeth Gibson's 2024 TR report.

Dear Judge Gibson:

The Florida Elections Commission received a letter from Jessica Ortiz appealing the fine assessed against you for failing to timely file a required report. However, Section 106.07(8)(c), Florida Statutes, provide that only the *candidate or chair* of a political committee, may appeal a fine assessed by a filing officer for the late filing of a campaign treasurer's report.

Therefore, to preserve your right to appeal the automatic fine, the Commission must receive your written statement confirming that the person who submitted the initial intent to appeal the fine, was representing you in that request. For your convenience, your signed statement can be submitted via email attachment to, [FEC@myfloridalegal.com](mailto:FEC@myfloridalegal.com).

If we do not hear from you within 14 days from the date of this letter, we will assume that the person signing the letter is neither your attorney nor your personal representative and that you have waived your right to appeal. The Commission will then enter a Default Final Order, ordering you to pay the fine assessed by your filing officer for failing to timely file your campaign treasurer's report.

I am writing in response to a letter received on March 21, 2025, to appeal the fine assessed for a late filing of the 2024 Termination Report. This report was filed on May 14, 2024. I received a call on August 12, 2024, from the Division of Elections stating that the report had not been filed. I told the representative that I did in fact file the report on May 14, 2024. He looked at the activity on the site and stated that the last date he showed activity was that date, May 14, 2024. He told me to then file the report online again so that he could verify that it was processed, which I did. Based on our conversation, and no further calls from the Division of Elections, I was under the impression that the report was accepted and filed timely. There was no communication to me directly regarding a late filing notice. I assumed all required filings were accepted. We hence discovered notices of the late filing penalty were being mailed by The Florida Division of Elections to a closed Post Office box. Through comments with other campaign representatives, it came to our attention that there were on-line notices we were unaware of and acted immediately to address the late filing notice. We respectfully request the abatement of the late filing fine in the amount of \$900.00 based on a change in communication channels by the department for which we were unaware of and sincerely apologize for any inconvenience caused to The Florida Department of Elections. For certain, this oversight will not happen again as now we are aware the online database is the only notification we will be receiving for future notices. For the entire period up to the termination report we received written notification regarding any issues.

Our records indicate that you have not filed either your termination report or notification that no reportable activity occurred, whichever is applicable. The filing date was July 25, 2024.

The law (s. 106.07(8)(b), Fla. Stat.) requires the filing officer to immediately notify you about the missed filing date and the automatic fines that will be assessed for late filing of a report, if a report was due.

- If reportable activity occurred and you have not filed a report, statutory fines are automatically assessed as \$50 per day until you file your report. The total fine for the untimely report cannot exceed 25% of the total receipts or expenditures, whichever is greater, for the cover period. Even if you end up filing your report late, we cannot waive the statutory fines. We will notify you of the specific amount of fines owed once you file your report. You have 20 days from the day you receive the notice to pay the fine or to appeal the fine to the Florida Elections Commission.
- If no reportable activity occurred for the report date(s), you are still required to notify us in writing, via the Division's Electronic Filing System, that no reportable activity occurred. No automatic fines are statutorily assessed.

However, in all cases, failure to file and/or untimely filing of a report of reportable activity, or if applicable, a notice that no reportable activity occurred, may constitute an apparent violation of chapter 106, Fla. Stat. If we refer such matter to the Florida Elections Commission, the Commission may subsequently impose a civil penalty for each violation under chapter 106.265(1), Fla. Stat.

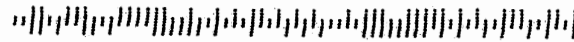

However, in all cases, failure to file and/or untimely filing of a report of reportable activity, or if applicable, a notice that no reportable activity occurred, may constitute an apparent violation of chapter 106, Fla. Stat. If we refer such matter to the Florida Elections Commission, the Commission may subsequently impose a civil penalty for each violation under chapter 106.265(1), Fla. Stat.
